#### COMMISSION ANNOUNCEMENTS

FEE RATE CHANGE EFFECTIVE 9:00 A.M. OCTOBER 28, 1993

Registrants should be aware that the SEC's fiscal 1994 appropriation was signed into law on October 28, 1993, changing the fee rate pursuant to Section 6(b) of the Securities Act of 1933 to 1/29th of one percent from the previous fee rate of 1/32nd of one percent. This change was effective as of 9:00 a.m. on October 28, 1993. Registrants are advised that the agency's formula used to calculate the new fee rate is based on a factor of 0.00034483, effective as of 9:00 a.m. on October 28, 1993. Any filings made at the old fee rate will not be accepted. (Press Rel. 93-48)

## ADMINISTRATIVE PROCEEDINGS

### NASD DIRECTED TO BAR WILLIAM SPILLMAN

The Commission issued an order directing the National Association of Securities Dealers, Inc. (NASD) to bar William Spillman, a person subject to a statutory disqualification, from becoming associated with a member firm that had proposed to employ him. Mr. Spillman is subject to a statutory disqualification as a result of his felony conviction for making false statements to financial institutions under 18 U.S.C. § 1014. The NASD had given the Commission notice that it proposed to permit Mr. Spillman to become associated with a member firm unless directed otherwise by the Commission. (Rel. 34-33092)

#### CIVIL PROCEEDINGS

# DON KENNETH HANKS, JR., ENJOINED

On October 22, the U.S. District Court for the District of Colorado entered an order enjoining Don Kenneth Hanks, Jr., a registered investment adviser, from future violations of the antifraud and registration provisions of the Investment Advisers Act, the Exchange Act and the Investment Company Act. Hanks consented to the injunction without admitting or denying the complaint's allegations.

The complaint, filed September 13, alleged that Hanks organized an unregistered investment fund, hired a firm to solicit investors for the fund, used the money to trade in options, and ultimately lost most of the investments. He never registered as a broker-dealer and registered as an investment adviser only long after he began operating the fund.

In order to induce investors to invest in, and to leave their money in, the fund, Hanks allegedly made false statements concerning his past and current performance in trading in options, his compensation, and the safety of the invested money.

According to the complaint, 169 persons invested \$1.966 million with Hanks; about \$1.62 million was ultimately lost through trading losses. The remaining money was retained by Hanks or paid to the solicitor firm he hired. The issue of disgorgement, prayed for in the complaint, remains pending. [SEC v. #### INVESTMENT COMPANY ACT RELEASES

# NATIONWIDE LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Nationwide Life Insurance Company, Nationwide Variable Account II (Account) and Nationwide Financial Services, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction from the assets of the Account of mortality and expense risk charges imposed under certain individual modified single premium deferred variable annuity contracts. #### THE GUARDIAN PARK AVE. FUND

An order has been issued pursuant to Section 8(f) of the Investment Company Act declaring that The Guardian Park Ave. Fund has ceased to be an investment company. (Rel. IC-19818 - October 27)
