AMENDMENTS OF RULES TO DELEGATE AUTHORITY RELATING TO 15C2-11

On December 20, the Commission amended its rules to delegate authority to the Director of the Division of Market Regulation to exempt any initiation or resumption of quotations, either unconditionally or on specified terms and conditions, pursuant to Rule 15c2-11(h) under the Securities Exchange Act of 1934. ENFORCEMENT ACTIONS

INITIAL DECISION BARS SHAW AHMADI-TEHRANI

Administrative Law Judge Max O. Regensteiner has issued an initial decision barring Shaw Ahmadi-Tehrani from associating with a broker or dealer. Based on conduct in 1989-1990 when he was employed by a broker-dealer, Ahmadi-Tehrani was permanently enjoined in April 1993 from violating antifraud and disclosure provisions of the securities laws. He consented to the injunction without admitting or denying the allegations of the Commission's complaint. In May of this year, Ahmadi-Tehrani was convicted of conspiracy to defraud the United States and bank fraud and was sentenced to prison for 50 months, followed by supervised release for five years. The initial decision is subject to Commission review on petition of a party or on the Commission's own initiative. (Initial Decision Rel. #42)

COMPLAINT NAMES COMERICA BANK NBD BANK, N.A. AND MICHIGAN NATIONAL BANK

The Commission announced the filing of a complaint against Comerica Bank (Comerica), NBD Bank, N.A. (NBD) and Michigan National Bank (Michigan National) (collectively, the Defendant Banks) seeking permanent injunctive relief, disgorgement, prejudgment interest, undertakings and penalties.

The complaint charges that each of the Defendant Banks violated Regulation U, 12 C.F.R. Section 221 et. seq. (Regulation U) promulgated under Section 7(d) of the Securities Exchange Act of 1934, 15 U.S.C. Section 78g(d) (Section 7(d)) by extending credit directly or indirectly secured by margin stock, in amounts that exceeded the maximum loan value of the collateral securing the credit.

Simultaneously with the filing of the complaint, each of the Defendant Banks consented, without admitting or denying any liability, to the entry of a permanent injunction against future violations of Regulation U and Section 7(d). Comerica and NBD also each agreed to pay \$100,000, representing a penalty pursuant to the Securities Enforcement And Penny Stock Reform Act of 1990, 15 U.S.C. Section 78u(d)(3). In addition, NBD and MNB agreed to pay \$2,500, and \$8,500, respectively, representing the fees collected on the customer accounts involved. Finally, each of the Defendant Banks agreed to implement procedural safeguards against repeat of the account activity that gave rise to the Commission's complaint. [SEC v. INVESTMENT COMPANY ACT RELEASES

COMERICA BANK, ET AL.

Comerica Bank (Comerica) and Woodbridge Capital Management, Inc. have been granted a conditional temporary order, and a notice has been issued of their request for a permanent order under Section 9(c) of the Investment Company Act exempting applicants from the disqualification provisions of Section 9(a) solely with respect to a securities-related injunction entered against Comerica. The notice gives interested persons until January 11, 1994 to request a hearing on applicants' request for the permanent exemption. (Rel. IC-19960 - December 17)

NBD BANK, N.A., ET AL.

NBD Bank, N.A. (NBD), NBD Bank, and NBD Bancorp, Inc. have been granted a conditional temporary order, and a notice has been issued of their request for a permanent order, under Section 9(c) of the Investment Company Act exempting applicants from the disqualification provisions of Section 9(a) solely with respect to a securities-related injunction entered against NBD. The notice gives interested persons until January 11, 1994 to request a hearing on applicants' request for the permanent exemption. (Rel. IC-19961 - December 17)

MICHIGAN NATIONAL BANK, ET AL.

Michigan National Bank (MNB), Michigan National Corporation, and Independence One Capital Management Corporation have been granted a conditional temporary order and a notice has been issued of their request for a permanent order under Section 9(c) of the Investment Company Act exempting applicants from the disqualification provisions of Section 9(a) solely with respect to a securities-related injunction entered against MNB. The notice gives interested persons until January 11, 1994 to request a hearing on applicants' request for the permanent exemption. (Rel. IC-19962 - December 17)

FIRST INVESTORS CORPORATION, ET AL.

First Investors Corporation, First Investors Management Company, Inc., Executive Investors Corporation, Executive Investors Management Company, Inc., First Investors Life Insurance Company, Glenn O. Head and David D. Grayson have been granted a conditional temporary order and a notice has been issued of their request for a permanent order under Section 9(c) of the Investment Company Act exempting applicants from Section 9(a) of the Act. The temporary order relieves applicants from any ineligibility resulting from injunctions entered by courts in the States of Maine and New York and the Commonwealths of Massachusetts and Virginia on December 20, 1993 enjoining applicants and certain of their affiliated persons from violations of their respective state laws. Interested persons have until January 20, 1994 to request a hearing on the application. (Rel. IC-19967 - December 20)

HOLDING COMPANY ACT RELEASES

ENTERGY CORPORATION, ET AL.

A Memorandum Opinion and Order has been issued denying the requests for a hearing and authorizing a proposal by Entergy Corporation (Entergy), a registered holding company, its service company subsidiary, Entergy Services, Inc., its nuclear power plant operations subsidiary, Entergy Operations, Inc., and a new Entergy subsidiary, Entergy-GSU Holdings, Inc., under which Entergy proposes to acquire Gulf States Utilities (Gulf States), a publicly owned electric and gas utility company. Gulf States is engaged in the generation, transmission, distribution and sale of electricity at retail and wholesale and in the purchase of electricity at wholesale. (Rel. 35-25952)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-93-72) to amend its Guidelines Regarding Communications With the Public About Collateralized Mortgage Obligations. The amendment mandates that members offer to customers educational material concerning Collateralized Mortgage Obligations. Because this proposed rule change constitutes a stated policy, practice or interpretation of an existing rule under Section 19(b)(3)(A)(i) of the Securities Exchange Act of 1934, it became effective upon the Commission's receipt of this filing on December 3. Publication of the proposal is expected in the Federal Register during the week of December 20. (Rel. 34-33357)
