ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS AGAINST WALTER TWISTE, LAIDLAW EQUITIES AND LAIDLAW HOLDINGS ASSET MANAGEMENT

The Commission instituted proceedings against Walter L. Twiste (Twiste), Laidlaw Equities, Inc. (Laidlaw Equities), a broker-dealer registered with the Commission, and Laidlaw Holdings Asset Management, Inc. (Laidlaw Holdings), an investment adviser registered with the Commission. Twiste, Laidlaw Equities and Laidlaw Holdings consented to the findings, sanctions and undertakings without admitting or denying the allegations, except for admitting the injunction entered against Twiste.

The Commission found that Twiste had been enjoined in U.S. District Court for the Southern District of New York from aiding and abetting violations of the antifraud, financial responsibility, recordkeeping, and reporting provisions of the federal securities laws. The complaint alleged that Twiste, president, CEO and director of Laidlaw Equities and CEO, vice chairman and director of Laidlaw Holdings, misappropriated over \$1.1 million from customer accounts and misrepresented assets held in customer accounts from December 1988 through May 1990. Therefore, the Commission barred Twiste from association with any broker, dealer, investment company, investment adviser or municipal securities dealer. Further, the Commission required Laidlaw Equities and Laidlaw Holdings to submit to undertakings including reviewing and instituting new practices and procedures. (Rel. 34-29256)

CIVIL PROCEEDINGS

AMENDED COMPLAINT CONCERNING VINCENT MILITANO

The New York Regional Office announced that it amended its complaint filed in SEC v. Vincent Militano, et al., adding additional charges against Vincent Militano and Milton Sonneberg, former Moore & Schley, Cameron & Co. (Moore & Schley) registered representatives. The amended complaint also named as new defendants John J. Cranley, Jr., Thomas Core and Robert Sayegh, former Moore & Schley partners, and John Kolb and Carl Varrone, former clients of Militano.

The Commission alleged that Cranley, Core, Sayegh, Militano and Sonneberg manipulated the price of Institute of Clinical Pharmacology, plc (ICP) securities, violating Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 through purchases and sales involving undisclosed relationships with other broker-dealers and by artificially withholding ICP ADRs from the marketplace. The complaint charged these defendants with aiding and abetting Moore & Schley's violations of Section 15(c)(1) of the Exchange Act and charged Sayegh with aiding and abetting Moore & Schley's violations of Section 15(c)(2) of the Exchange Act and Rule 15c2-7.

The complaint alleged that Cranley and Core aided and abetted Militano's and Sonneberg's manipulation of the price of Chase Medical Group Inc. (Chase Medical) securities, violating Sections 9(a)(2), 10(b) and the reporting requirements of Section 13(d) of the Exchange Act and Rules 10b-5 and 13d-1. It also alleged that Cranley, Core, Militano, and Sonneberg aided and abetted margin violations.

Kolb and Varrone are charged with violating Section 7(f) of the Exchange Act and Regulation X through purchases and sales of Chase Medical and other securities in margin accounts. They are also charged with aiding and abetting Militano's violations of Sections 9(a)(2) and 10(b) of the Exchange Act and Rule 10b-5 in the Chase Medical manipulation. [SEC v. FINAL CONSENT JUDGMENT OF PERMANENT INJUNCTION OF STEPHEN RASINSKI AND LAWRENCE SMALL

The New York Regional Office today announced that Stephen R. Rasinski and Lawrence M. Small, both of California, agreed to settle insider trading charges in a pending civil action filed on November 13, 1991. The suit alleges that Rasinski and Small knowingly used misappropriated information from advance copies of BusinessWeek magazine to buy and sell securities.

Both defendants have consented to the entry of permanent injunctions against future violations. Rasinski has agreed to disgorge \$137,044.46, a like amount as a penalty and prejudgment interest, with payment of all amounts above \$46,100 being waived based upon his claimed inability to pay. Small has agreed to disgorge \$57,560.15, a like amount as a penalty and prejudgment interest, with the penalty and interest being waived based upon his claimed inability to pay.

Under the proposed consent judgments, which are subject to Court approval, the Commission may seek additional relief and the Court may impose additional sanctions should it be determined that Rasinski or Small have misrepresented or concealed their finances in any material respect. [SEC v. Stephen R. Rasinski and Lawrence M. Small, 90 Civ. 7229, LLS, SDNY, November 13, 1990] (LR-12872)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The Boston Stock Exchange filed a proposed rule change (SR-BSE-91-4) and Amendments No. 1 and 2 under Rule 19b-4 to amend its Rules to require BSE specialists to provide

primary market protection for limit orders entered during BSE's primary trading session that are designated as executable after the BSE close. Publication of the proposal is expected in the Federal Register during the week of June 3. (Rel. 34-29269)

The Depository Trust Company filed a proposed rule change (SR-DTC-91-09) under Rule 19b-4 to revise the adjustable net debit caps of those members that participate in its same-day funds settlement system. Publication of the proposal is expected in the Federal Register during the week of June 3. (Rel. 34-29264)

interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
