ENFORCEMENT PROCEEDINGS

COMMISSION ALLEGES MARKET MANIPULATION, INSIDER TRADING, FALSE AND MISLEADING STATEMENTS, AND/OR SELLING UNREGISTERED SECURITIES BY STEVEN SCHIFFER AND OTHERS

The Commission filed a complaint alleging market manipulation, insider trading, the making of false and misleading statements in Commission filings, and/or the sale of unregistered securities by six defendants. All of the activities related to Phoenix Laser Systems, Inc., a now-defunct company that was in the business of developing a laser workstation to perform eye surgery. The defendants are: Steven H. Schiffer (former chairman and chief executive officer of Phoenix), Joann R. Schulz (Phoenix's former president and chief operating officer), Gary S. Kramer (former investment relations representative of Phoenix), Jonathan Solow (formerly Phoenix's vice president, secretary, and director), Frank J. Cannata (a stockbroker and consultant to Phoenix), and Peter G. Mintz (a stockbroker and analyst, who covered Phoenix for his firm).

The Commission is seeking injunctive relief against all defendants, disgorgement by Schiffer, Schulz, Kramer, and Cannata of all profits made and/or losses avoided resulting from their violations, plus prejudgment interest thereon, and civil penalties from all defendants. The complaint also requests an officer and director bar against Schiffer. [SEC v. Schiffer, et al., 97 Civ. 5853, RO, S.D.N.Y.] (LR-15435)

INVESTMENT COMPANY ACT RELEASES

VARIABLE ACCOUNT THREE

An order has been issued under Section 8(f) of the Investment Company Act declaring that Variable Account Three of Anchor National Life Insurance Company has ceased to be an investment company. (Rel. IC-22780 - August 6)

THE LAZARD RETIREMENT SERIES, INC., ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Lazard Retirement Series, Inc. and Lazard Asset Management (LAM) from Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder. The order exempts applicants to the extent necessary to permit shares of the company and shares of any other investment company that is designed to fund insurance products and for which LAM, or any of its affiliates, may serve as investment adviser, administrator, manager principal underwriter or sponsor, to be sold to and held by variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies; and qualified pension and retirement plans outside of the separate account context. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change (SR-NASD-97-28) filed by the National Association of Securities Dealers under Rule 19b-4 of the Exchange Act to change its membership application procedures, investigations and sanctions procedures, disciplinary procedures, other procedures, and make other conforming changes as required by the settlement agreement entered into with the Commission on August 8. Publication of the approval order is expected to be made in the Federal Register during the week of August 11. (Rel. 34-38908)
