ADMINISTRATIVE PROCEEDINGS

ROBERT SICHTA BARRED

The Commission instituted public proceedings pursuant to Rule 2(e) of the Commission's Rules of Practice and issued an order making findings and imposing sanctions against Robert D. Sichta, Esq. (Sichta). Predicated on fraud in the IPO of Dewani Lauro Marine Product Development Corporation (Dewani), a Hawaiian penny stock company, the Commission's Order finds that Sichta, Dewani's counsel, knowingly prepared Dewani's registration statement filed with the Commission without disclosing the true involvement of its founder and promoter, Laureen M. Farley. Sichta was previously enjoined by the Commission. See SEC v. Dewani Lauro Marine Product Development Corp., et al., (Civil Action No. 90-462 DAE (D.Hawaii) (LR-12515)

The Commission determined to accept the respondent's Offer of Settlement in which he neither admits nor denies the Commission's findings and agrees to be denied the privilege of appearing or practicing before the Commission for three years. (Rel. 34-28234)

LAUREEN FARLEY BARRED

The Commission instituted public proceedings and issued an order making findings and imposing sanctions against Laureen M. Farley (Farley). Predicated on fraud in the IPO of Dewani Lauro Marine Product Development Corporation (Dewani), a Hawaiian penny stock company, the Commission's Order finds that Farley, while branch manager of Royce Park Investments, Inc.'s Honolulu office, founded, controlled and promoted Dewani without proper disclosure of her involvement in Dewani's registration statement or otherwise. Farley was previously enjoined by the Commission. See SEC v. Dewani Lauro Marine Product Development Corp., et al., (Civil Action No. 90-462 DAE (D.Hawaii) (LR-12515).

The Commission determined to accept the respondent's Offer of Settlement in which she neither admits or denies the Commission's findings and agrees to be barred for three years from associating with any broker, dealer, investment company, investment adviser or municipal securities dealer. (Rel. 34-28235)

ROYCE PARK INVESTMENTS CENSURED

The Commission instituted public proceedings and issued an order making findings and imposing sanctions against Royce Park Investments, Inc. (Royce Park), a Colorado-based broker-dealer. Predicated on fraud in the IPO of Dewani Lauro Marine Product Development Corporation (Dewani), a Hawaiian penny stock company, the Commission's Order finds that Royce Park failed to adequately supervise the activities of its Honolulu branch manager, Laureen M. Farley (Farley). Farley founded, controlled and

promoted Dewani without proper disclosure of her involvement to purchasers of Dewani stock through Royce Park.

The Commission determined to accept the respondent's Offer of Settlement in which Royce Park neither admits nor denies the Commission's findings and agrees to be censured and to comply with certain undertakings. (Rel. 34-28236)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
