COMMISSION ANNOUNCEMENTS

SEC PROPOSED INSIDER TRADING LEGISLATION

The Commission today released a letter to the Senate Subcommittee on Securities transmitting the Commission's proposed legislation to define and prohibit insider trading. The Commission had submitted its original proposal to the Subcommittee on August 3, in connection with Subcommittee hearings on S. 1380, insider trading legislation drafted by an Ad Hoc Legislative Committee chaired by Harvey L. Pitt and introduced by Senator Donald W. Riegle, Chairman of the Subcommittee, and Senator Alfonse M. D'Amato.

David S. Ruder, Chairman of the Commission, said, in connection with the proposed legislation, "I believe the Commission has adopted a legislative proposal that will protect the securities markets against misuse of confidential information and will further the Commission's enforcement program. We are pleased to have worked cooperatively with Senator Riegle, Senator D'Amato, and the Ad Hoc Legislative Committee to achieve a positive result." (Press Release 87-84)

NEW ORLEANS PUBLIC SERVICE INC.; ARKANSAS POWER & LIGHT COMPANY

Notices have been issued giving interested persons until December 7 to request a hearing on a proposal by the following companies filed under Release 35-24501, dated November 12: New Orleans Public Service Inc. (NOPSI) - subsidiary of Middle South Utilities, Inc., whereby, in order to satisfy the percentage ownership interests specified in an Agreement for Joint Use of Poles between NOPSI and South Central Bell Telephone Company (Bell), NOPSI would sell to Bell 1,311 40-foot wood poles in place, for a price of \$200,663.13; and Arkansas Power & Light Company - subsidiary of Middle South Utilities, Inc., to amend its charter to provide for the reduction of the par value of its common stock.

NOTICE OF PROPOSED RULE CHANGES

Proposed rule changes have been filed under Rule 19b-4: The National Association of Securities Dealers (SR-NASD-87-49) to revise the specifications and study outline for the Registered Options Principal (Series 4) examination administered by the NASD. (Rel. 34-25126); and The Pacific Stock Exchange (SR-PSE-87-28) to implement a two-year options trading crowd performance evaluation pilot program. (Rel. 34-25127)

Publication of the proposals are expected to be made in the Federal Register during the week of November 16.

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change by filed by the Chicago Board Options Exchange (SR-CBOE-87-48) which places all language concerning stop and stop-limit orders in one rule, and authorizes the election of stop and stop-limit orders by bids and offers beyond S&P 100 index options to include all index options traded on the exchange. APPLICATION FOR REGISTRATION AS A CLEARING AGENCY

The Government Securities Clearing Corporation filed an application for registration as a clearing agency under Section 17A of the Securities Exchange Act of 1934 and Rule 17Ab2-1(c)(1). GSCC's registration, however, would be temporary in that it cannot be effective for more than 18 months from the date of which registration is made effective by the Commission (or such longer period as ordered by the Commission).
