# South Dakota Severe Winter Storm and Record and Near Record Snow – FEMA-1811-DR

## Declared December 12, 2008

On December 1, 2008, Governor M. Michael Rounds requested a major disaster declaration due to a severe winter storm during the period of November 5-7, 2008. The Governor requested a declaration for Public Assistance for 13 counties and 4 Tribal Reservations, emergency protective measures (Category B), including snow removal assistance, under the Public Assistance program for 2 counties and Hazard Mitigation for all counties. During the period of November 20-25, 2008, joint Federal, State, and local Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the State and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On December 12, 2008, President Bush declared that a major disaster exists in the State of South Dakota. This declaration made Public Assistance requested by the Governor available to State and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe winter storm and record and near record snow in Bennett, Butte, Corson, Dewey, Haakon, Harding, Jackson, Meade, Mellette, Perkins, Shannon, Todd, and Ziebach Counties and the portions of the Pine Ridge Reservation, Rosebud Reservation, Cheyenne River Reservation, and Standing Rock Reservation that lie within the designated Counties. This declaration also made emergency protective measures (Public Assistance Category B), including snow removal assistance, requested by the Governor available in Butte and Perkins Counties. This emergency assistance will be provided for any continuous 48-hour period during or proximate to the incident period. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
