### Iowa Severe Winter Storm and Snowstorm – FEMA-1877-DR

## Declared February 25, 2010

On January 28, 2010, Governor Chester J. Culver requested a major disaster declaration due to a severe winter storm and snow storm during the period of December 23-27, 2009. The Governor requested a declaration for Public Assistance, including snow removal assistance, for 12 counties; Public Assistance for 27 counties; and Hazard Mitigation statewide. The Governor further requested direct Federal assistance. During the period of January 11-26, 2010, joint Federal, State, and local Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the State and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On February 25, 2010, President Obama declared that a major disaster exists in the State of Iowa. This declaration made Public Assistance requested by the Governor available to State and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe winter storm and snowstorm in Adair, Audubon, Calhoun, Carroll, Cass, Cherokee, Clay, Crawford, Emmet, Franklin, Fremont, Guthrie, Harrison, Ida, Monona, Page, Pottawattamie, Sac, Shelby, Sioux, and Woodbury Counties. This declaration also made Public Assistance, including snow assistance, requested by the Governor available to State and eligible local governments in the counties of Cherokee, Clay, Emmet, Fremont, Harrison, Ida, Page, Pottawattamie, Sioux, and Woodbury. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

- o Minor Damage home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and
- o Affected some damage to the structure and contents, but still habitable.

The preliminary damage assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
