### West Virginia Severe Winter Storm and Snowstorm—FEMA-1881-DR

## Declared March 2, 2010

On February 10, 2010, Governor Joe Manchin, III requested a major disaster declaration due to a severe winter storm/snowstorm during the period of December 18-20, 2009. The Governor requested a declaration for Public Assistance, including snow removal for 15 counties and Hazard Mitigation statewide. During the period of December 20, 2009, to February 9, 2010, joint Federal, State, and local Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the State and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On March 2, 2010, President Obama declared that a major disaster exists in the State of West Virginia. This declaration made Public Assistance requested by the Governor available to State and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe winter storm and snowstorm in Boone, Calhoun, Clay, Fayette, Greenbrier, Kanawha, McDowell, Mingo, Nicholas, Pendleton, Pocahontas, Raleigh, Ritchie, Roane, and Wyoming Counties. This declaration also made Public Assistance, including snow assistance, requested by the Governor available to State and eligible local governments in the counties of Fayette, Greenbrier, McDowell, Mingo, Nicholas, Pendleton, Pocahontas, Raleigh, and Wyoming Counties. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
