## Connecticut – Severe Storm FEMA-4046-DR

### Declared November 17, 2011

On November 11, 2011, Governor Dannel P. Malloy requested a major disaster declaration due to a severe storm during the period of October 29-30, 2011. The Governor requested a declaration for Public Assistance for seven counties and Hazard Mitigation statewide, including the tribal lands of the Mashantucket Pequot and Mohegan Tribal Nations. During the period of November 7-11, 2011, joint federal, state, and municipal government Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On November 17, 2011, President Obama declared that a major disaster exists in the State of Connecticut. This declaration made Public Assistance, including direct federal assistance requested by the Governor available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe storm in Fairfield, Hartford, Litchfield, Middlesex, New Haven, Tolland, and Windham Counties. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures for all counties and Tribes in the State of Connecticut.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

Major Damage – substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;

o Affected – some damage to the structure and contents, but still habitable.
