Presentation #1

"Obesity and Worker Safety"

Description: Personal health plays a key role in keeping employees productive, safe, injury-free, and economical to the employer. The number one In addition to these presentations, we also have health challenge that we face on the Hanford Site is poor weight management, with 84% of the workforce either overweight or obese. In this presentation, we will look at the epidemiological health analysis of the Hanford worker, discuss why it is important to address obesity and related conditions at the worksite, describe the interventions that have demonstrated success at Hanford, and provide recommendations for future direction.

"Culture and Employee Health: Front Lines to the Corner Office"

Description: The benefits to the employer and the employee in establishing and maintaining a culture of health in the workplace go beyond financial savings. Healthy employees tend to be happier at home and at work, be more productive, and have a higher quality of life. This presentation will illustrate why the programs. workplace is an ideal venue to build a culture of health, how culture influences behavior, the balance between personal responsibility and employer supports, and provide strategies for creating a culture of health for employees of all levels, from leadership to front line employees.

"Hanford Worksite Wellness Programs"

Worksite wellness programs are an important part of maintaining a healthy workforce. This poster will describe our successful worksite wellness programs provided to DOE Hanford and its contractors includ-

ing health coaching, weight management, worksite health fairs, work conditioning and fitness assessments. Through worksite visits, contractor interface and emerging issues (i.e. obesity, tobacco use, aging workforce), our services have been designed to address the needs of the workforce. You will also see how our web-based programs demonstrate creative ways for thousands of employees to learn about, and participate in, health promotion

"BMI and Musculoskeletal Injuries"

This presentation will look at the time period of 2008-2010 and investigate trends among injuries, showing patterns in injury type as well as the body parts most likely to be injured. We will show contributing factors that are related to these injuries, such as occupation and obesity, and will also look more specifically at those workers enrolled in the Human Reliability Program, such as Hanford Patrol, to see if their injury patterns differ from the general Hanford site worker population. This information will provide safety professionals the evidence base needed to focus injury prevention programs in their workplaces.



The popular four-hour training course in Risk Communication—prompted by the Beryllium Corrective Action Plan and required by many contractors for PIC's, planners, line supervisors and certain management will continue to be offered quarterly at HAMMER, led by Dr. Sandy Rock and Regina Lundgren. Risk Communication is defined as a research-based approach for communicating effectively in complex and controversial situations. This introduction provides essential, effective and Hanford-relevant principles and tips for resolving issues about hazards and risks at the Site. Emphasis is placed on the perception of risk and how divergent worldviews and perceptions can and should not interfere with consensus development. Doctor Rock will be giving a presentation on this training at the ISM Champions Workshop at Three Rivers Convention Center on September 15 at 11:00 A.M
