SUBJECT: Timeline for Transmittal of Fiscal Year 2010 Workload Data and Production of User Population Estimates

The Indian Health Service has made great progress over the last nine years in improving the annual user population estimate process. We receive data from 650 feeder sites across the Indian health system and 99% now transmit data electronically. Per the Director's Tribal Leader letter from December 2003 which stated, "*Effective for FY 2004 the user counts will be based on individually received in the National Patient Information (NPIRS) repositories in Albuquerque.*" This provided specific direction and challenges that helped to improve the process. The progress made illustrates the high level effort by all. In accordance with the letter, we have reached the year when no further adjustments will be allowed except for new Tribes. The FY 2010 user populations will solely be based on data submitted in one of the two standard formats (HL 7 or simplified) to the National Data Warehouse (NDW).

We are working to support everyone in the process and it is important for everyone to know, as early as possible, all of the critical milestones to continue to improve the process. This memorandum provides the deadlines for the submission of data for producing the fiscal year (FY) 2010 user population estimates by December 17. This timeline was reviewed by the Area Statistical Officers, and the team involved with producing the user population table has incorporated all suggestions wherever possible. The final deadlines for transmission of FY 2010 direct and contract inpatient, ambulatory care, and dental data to NPIRS/NDW and Workload & User Population Data Mart (WLUPDM) and for production of the user population estimates are on the following page.

This schedule will maintain and support the results of the collaborative effort among the Tribes, the Areas, Office of Information Technology (OIT), and Office of Public Health Support (OPHS) to improve the quality and accuracy of the national data repositories. Monthly workload reports and workload progress reports began January 22 and beginning April 16, the first of four year-to-date user population reports will be posted for review by the Area Statistical Officers. This process provides the Area Statistical Officers the opportunity to review and identify gaps or missing workload data in a timely and continual manner for their respective Areas. NPIRS will begin producing workload reports more frequently as we move closer to the October 28 deadline.

We strongly encourage the Areas to continue to have ongoing communication throughout the year with Tribes and Service Unit Directors in their respective Area on the monthly workload progress and the draft quarterly user population reports for their consultation, review, and feedback. During the Statistical Officers' monthly conference calls, the Division of Program Statistics (DPS) will ask for a report from each Area Statistical Officer regarding the transmission status of registration and encounter data and quarterly ask for a report on their consultation with Tribes and Service Unit Directors on the user populations. This allows for the early identification of any data problems and their timely resolution.

This ongoing communication with Tribes and Service Unit Directors is extremely important because as stated previously for FY 2010 there will be no adjustments allowed except for new Tribes. For new Tribes, an agreed upon user population will be determined when the Tribe comes into the Indian health system and will be used for the first three years. After three years, all user population determinations will be based on the registration and workload data in the National Data Warehouse (NDW). We encourage the Areas to continue to work with the Tribes without three years (FY 2008, FY 2009, and FY 2010) of data to export their data in the proper format so their data can be loaded into the NDW.

In order to meet our goal of completing workload transmission by October 28, 2010 (see below the agreed upon schedule for production of the FY 2010 User Population), we are requesting each area to submit all regular workload and registration data by this date. Areas that meet this deadline will be in a better position to research and resolve data anomalies and other problems in those transmissions by November 10.
