SUBJECT: FY 2006 Allocation Amounts: Emergency Management Performance Grant (EMPG), Metropolitan Medical Response System (MMRS), and Citizen Corps (CCP)

On December 30, 2005, Public Law 109-148 was signed into law, enacting a government-wide rescission of one percent to be applied to all FY 2006 appropriations. As a result, all FY 2006 EMPG award amounts originally published on November 14, 2005, as part of the program guidance have been amended to reflect this rescission. Additionally, allocation amounts have been finalized for both the MMRS Program and CCP. The final award amounts are listed below.
