K19	Centralized Finance	В	Reclamation-wide financial management and accounting services including policy, systems support, fund control, property reconciliation, and cost accounting.
K21	Soil & Water Quality Laboratories	R	Centralized soil and water quality analysis facilities for projects and studies in regional offices.

K47	Denver Common Activities	R	Common services such as personnel and facilities management for Commissioner's Office-Denver organizations.
