Security Guard Uniform

1. **Introduction.**

- A. This Appendix describes the specifications for authorized uniform components to be worn by Bureau of Reclamation security guards at Hoover and Shasta Dams. If Reclamation employed guards are approved at other projects, this uniform will be used. Any procurement of accessories dealing with weapons must be approved in advance by the Director, Security, Safety, and Law Enforcement.
- B. Class A (dress) and Class B (daily wear) uniform styles have been established for Security Guards (below). Requirements for wearing of the specific uniform style will be defined in local Standing Operating Procedures for the guard force.

2. Security Guard Class A (Dress) Uniform.

- A. **Head Gear.** Campaign style hat; navy blue; metal security badge color to match rank.
- B. **Shirts.** Dress style shirt; white or silver-tan.
- C. **Pants.** Dress style pant; LAPD blue.
- D. **Ties.** Navy blue, clip-on. Ties will be worn with a United States flag tie-tack or minibadge tie-tack.
- E. **Jackets.** Double-breasted dress coat: LAPD blue.
- F. Gloves. White.
- G. **Footwear.** This item is not covered by the uniform allowance.
 - (1) **Shoes.** Oxford type; black, leather, laced; rubber soles; highly polished.
 - (2) **Boots.** Tactical boots (lace or zip); black leather; shined and in good state of repair at all times.
 - (3) **Socks.** Quarter or mid-calf length; visible portions must be dark blue or black.
- H. **Official Badges.** All guards will be issued a numbered metal gold or silver badge for wear on jackets and shirts. Badges will be gold for supervisors/leads; others will be silver.
- I. **Shoulder Patches.** Reclamation-issue, "SECURITY" patch worn on each shoulder ½ inch from top seam and centered on arm crease.

Name Tag. Reclamation-issue. Optional with dress uniform.

K. Belts.

- Inner/Dress Belt without Outer Belt. Standard dress belt; black; leather; basket (1) weave: nickel buckle.
- Inner/Dress Belt with Outer Belt (Optional). Nylon; synthetic; buckles or Velcro close.
- (3) **Outer Belt.** Nylon; synthetic; black; nickel buckles or snaps.
- **Accessories Including Duty Gear.** Reclamation-issue. Nylon; match belt design.
- Security Guard Class B (Daily) Uniform.

A. Head Gear.

- (1) **Campaign Hat.** Navy blue; metal security badge color to match rank.
- (2) **Baseball Type Cap.** Plain, black; "SECURITY" in 1-inch uppercase white letters embroidered on the front.
- (3) Fur Troopers Hat. Navy blue; "security wreath badge" (2 ½ x 1 ¾) color to match rank.
- **Shirts.** Individuals will wear their metal badges on the left front of their shirts; name tags on right side above pocket. Reclamation-issue patches will be sewn on both sleeves. All shirts will be worn over a plain white, black, or navy blue v-neck or crewneck t-shirt (this item is not part of the uniform allowance). Supervisors will ensure consistency in color when crew-neck t-shirt will be visible above the collar of the uniform shirt.
 - **Summer.** Uniform style; short sleeve shirt; silver tan.
 - (2) **Winter.** Uniform style; long sleeve shirt; silver tan.
 - **Mock Turtleneck.** Long or short sleeve; navy blue. To be worn under long sleeve shirt in lieu of tie. Supervisors shall ensure conformity in regards to guards wearing clip-on ties or mock turtlenecks.
 - **Sweater.** Commando-style sweater; LAPD blue.
- C. **Pants, All Season, Daily Wear.** LAPD blue.

- D. **Ties.** Navy blue, clip-on. Ties will be worn with a United States flag tie-tack or minibadge tie-tack and are only required for special occasions.
- E. **Jackets.** Jackets will have Reclamation-issued cloth badge sewn on the front, and all other Reclamation-issue patches on sleeves.
 - (1) **Summer Jackets/Windbreaker.** Black; "SECURITY" in 3-inch white letters silk-screened across the back.
 - (2) **Winter Jacket.** Black; "SECURITY" in 3-inch white letters silk-screened across the back.
 - (3) **Rain Jacket.** Black or reflective green, easily storable, "SECURITY" in 3-inch white reflective letters silk-screened across the back.
- F. Gloves. Black; leather, cloth, or synthetic.
- G. **Footwear.** This item is not covered by the uniform allowance.
 - (1) **Shoes.** Oxford type; black, leather, laced; rubber soles; shined and in good state of repair at all times.
 - (2) **Boots.** Tactical boots (lace or zip); black leather; shined and in good state of repair at all times.
 - (3) **Socks.** Quarter or mid-calf length; visible portions must be dark blue or black.
- H. **Official Badges.** All guards will be issued a numbered metal gold or silver badge for wear on jackets and shirts. In situations where use of a metal badge would be a safety hazard, cloth badges will be used. Security badges will be gold for supervisors/leads; others will be silver.
- I. **Shoulder Patches.** Reclamation-issue, "SECURITY" patch worn on each shoulder ½ inch from top seam and centered on arm crease.
- J. **Name Tag.** Reclamation-issue.
- K. Belts.
 - (1) **Inner/Dress Belt without Outer Belt.** Standard dress belt; black; leather; basket weave; nickel buckle.
 - (2) **Inner/Dress Belt with Outer Belt (Optional).** Nylon; synthetic; buckles or Velcro close.
