

Suggested Template for Subordination Agreements

We are providing this sample Subordination Agreement to assist Sponsors with the preparation of an agreement for their specific location and situation. We recommend Sponsors furnish this sample language to their attorney tasked with preparing the actual Agreement.

Limitations of Use

This language serves as a starting point for the Sponsor when preparing their customized subordination agreement. Sponsors must not construe this sample document as being complete and legally sufficient. FAA's provision of this sample agreement does not represent a guarantee, implied or explicit, of legal sufficiency. Sponsors are solely responsible for verifying the legal aspects of all contractual matters, including establishment of consultant agreements.
