Subject:	Sponsor Assignments, Airports Staff

This Memorandum outlines the staff reassignment of States and airport sponsors within the New England Region Airports Division. The objectives of this reassignment are (1) address new work requirements while providing a reasonable balance of work assignments; (2) identify the role of new staff, and (3) begin the process of training staff for new tasks.

An important note: If you have an ongoing planning study, your Planner will not change. The reassignments will generally take place over the next fiscal year, as new projects start. <u>If you have any questions, please contact either Bryon Rakoff (781-238-7610) or Michel Hovan (-7620).</u>

## **Planner Assignments**

The following work assignments have been made:

- Michelle Ricci is taking the lead for all Wildlife Hazard Assessment studies in our region. She will be responsible for all new WHA studies in the region, and will also assist our Certification staff in the review and approval of Wildlife Hazard documents.
- Lisa Lesperance is now the lead State Planner for Massachusetts, and will be responsible for planning at most of the airports in the state (see attached list). However, Michelle will continue to be the planner for all Cape and Island Airports, as well as being one of our environmental specialists. Lisa will continue to be the lead Planner for New Hampshire.
- **Ralph Nicosia-Rusin** is the Planner for all Massport airports, consisting of BOS, ORH, and BED. This will provide Massport with a single planning point of contact.
- Ralph remains the lead State Planner for Maine. However, to address the significant work in the state, **Gail Lattrell** is assigned as planner for airports in Western Maine (see the attached list). Gail will continue to be the lead State Planner for Connecticut and Rhode Island.
- To address Lisa's added workload, **Tracey McInnis** will be joining our team and working with Lisa on Vermont projects. Ultimately, Tracey will be the planner for that state.

### **Engineer Assignments**

Over the last year, we have gained a new engineer (John Merck). In addition, this fall, Amanda Wingerter left our office and was replaced with Barry Hammer. Given these new staff, the engineering staff assignments are as follows:

- John Merck is the lead State Engineer for New Hampshire and Vermont.
- **Barry Hammer** takes over Amanda's airports in Maine, under the guidance of Bob Siris. Bob remains the lead State Engineer for Maine.
- All other staff engineer assignments are unchanged.

Note: New Hampshire airports in italics are under the block grant and are not part of FAA's direct review responsibility.

#### **Roles and Responsibilities**

There has been some question about the responsibilities of planners working at an airport vs. the planner responsible for a state. The following is (I hope) a clarification.

- The lead **State Planners** (i.e. those FAA planning staff who are responsible for working with states) are the point of contact for State Aviation staff. State Planners are responsible for working with the states in the development of a practical, implementable state CIP. They should have a general understanding of what's going on at all airports in their state.
- In Maine and Massachusetts, the State Planners are not responsible for all of the airports; rather, **Airport Planners** have been assigned specific airports or sponsors. They are responsible for oversight of all planning and environmental studies (excepting complex EA's, EIS, or Noise studies which could be managed by an environmental specialist) at these airports. They may also be responsible for land acquisition projects. Airport Planners are the day to day point of contact with those sponsors, and will be most familiar with the sponsor's needs and priorities. They will work with the State Planners to develop the CIP's for their respective airports. If necessary, they would prepare any special justifications for discretionary funding.

The State Planner has the discretion to define the specific role and duties of the Airport Planner in the CIP process.
