New Contracts

LISA

As our current local service contracts approach expiration, we are pleased to announce that the replacement contract is currently with our contracting group, and scheduled for solicitation sometime in February. Evaluation of responses and contract award will take place in mid- to late March.

This contract, tentatively titled the Local Integrated Services Agreement (LISA), will encompass all of the services our customers currently enjoy, as well as some new additions, including PhyBridge Uniphyer, a VoIP enabler that leverages your existing cabling infrastructure in a VoIP migration.

Regional VoIP Contract

With VoIP becoming increasingly common within the Federal Government, we are constantly fine-tuning our portfolio of contract vehicles for VoIP procurement. To that end, GSA Network Services is currently putting together a regionwide VoIP contract that will eventually enable customers across our entire six-state region to easily obtain off-premise hosted VoIP service. Proposals were due on January 16, with evaluation and contract award to occur in mid-February.

PBX Maintenance Contract

For those of you who receive service from a GSA PBX, you may be interested to know that we have recently awarded the new PBX Maintenance Contract to Black Box. You may notice slight cost increases on certain line items on the contract, which is a reflection of the increasing costs vendors charge us for PBX service and support. As PBX technology becomes more antiquated and less common, we expect these costs to continue to go up; thus, we are expanding our telephony service offerings to include affordable VoIP options for our customers (see "New and Upcoming Offerings" article for details). GSA Network Services Project Managers will soon be reaching out to customers to explore options, but please do not hesitate to contact us directly if you would like to examine PBX alternatives in the mean time.



New and Upcoming Offerings

GSA Network Services has expanded our on-premise VoIP offerings to include a new, no-commitment leased IP PBX solution. The AdTran NetVanna ISDN PRI bundle enables agencies to move into a new IP PBX with little upfront investment. The AdTran solution is perfect for customers with basic feature requirements, such as internal four- or five-digit dialing, DID, caller ID, three-way calling, voice mail and e-mail notification of voice mail. Our bundle also includes ten changes to phone set configurations per year.

AdTran is a great addition to our existing ShoreTel premisebased VoIP offering, a feature-rich solution that has been met with enthusiasm by our customers.

As mentioned previously, GSA Network Services will soon be able to offer PhyBridge Uniphyer on contract. This will enable agencies to use their existing cabling infrastructure in a new VoIP deployment. A terrific product, as cabling costs are often a huge part of the overall cost of converting to VoIP.


Finally, we are investigating the viability of implementing a contract vehicle for cable and satellite TV for our customers.

Denver Federal Center Area Network Environment (DANE) Update

Due to the enormity of the project and scarcity of resources available to devote to it, GSA Network Services has experienced some significant delays related to the DANE project, which will eventually outfit the Denver Federal Center with an interconnected, state-of-the-art fiber network. Customer requirements will be collected in the next two months, followed by the development of a business case for funding justification. Pending approval of funding, construction should begin in the Fall 2012 time frame.



Networx Update
