MEMORANDUM FOR THE ADJUTANTS GENERAL OF ALL STATES, PUERTO RICO, THE US VIRGIN ISLANDS, GUAM, AND THE COMMANDING GENERAL OF THE DISTRICT OF COLUMBIA

SUBJECT: (All States Log Number P10-001), Mandated H1N1 Vaccination for Uniformed National Guard Members

1. References.

- 2. Purpose. Clarification of the H1N1 Novel Influenza Vaccine requirement for uniformed National Guard members.
- 3. In accordance with references a-e, any influenza vaccine required for individual medical readiness (which includes the H1N1 Novel Influenza vaccine) will be required for all uniformed National Guard members to perform duties in a Title 32 or Title 10 status.
- 4. While there was initial concern regarding the availability of the H1N1 Novel Influenza vaccine, enough has been acquired to vaccinate all uniformed National Guard members by 30 April 2010.
- 5. Each state will ensure that its uniformed National Guard members be given the H1N1 Novel Influenza vaccine no later than 30 April 2010 with data appropriately entered into respective Service tracking systems. However, noncompliance after 30 April 2010 will be handled by the state in the same manner as noncompliance of any other mandated vaccine.

SUBJECT: (All States Log Number P10-001), Mandated H1N1 Vaccination for Uniformed National Guard Members

- 6. Members should receive the H1N1 vaccine, even if they have a history of H1N1 influenza.
- 7. The H1N1 Novel Influenza virus poses a threat to the health and readiness of our forces. Successful mitigation and prevention is dependent upon vaccination. I appreciate your continued support in our efforts to maintain the wellness and mission capability of our Service members.
