- The scores of five States have been revised to correct scoring errors. These corrections do not affect the funding of any applicant for Fiscal Year 2011. Two additional States (including New York) have been revised to correct reviewer votes on competitive priority 3 (CPP 3). With respect to New York, reviewer #3's vote on CPP 3 is corrected from a "no" to a "yes" vote and reviewer #3's vote on this priority is corrected from a "yes" to a "no" vote. Since the majority vote on CPP3 was not affected, this correction did not result in any changes to New York's overall score.
- * Applicants are eligible to earn up to 10 points for Competitive Preference Priority 2: Including all Early Learning and Development Programs in the Tiered Quality Rating and Improvement System. The total awarded to the applicant for Priority 2 is based on an average of individual reviewer scores in this section.
- ** Applicants are eligible for either 0 or 10 points for Competitive Preference Priority 3: Understanding the Status of Children's Learning and Development at Kindergarten Entry. The total awarded to the applicant for Priority 3 is not based on an average of individual reviewer scores in this section. Rather, 10 points are added to the applicant's Average Total Score if a majority of reviewers determined that the applicant has met the priority.
- *** The Applicant will be determined to have met the absolute priority if the majority of reviewers responded "yes".
- Applicants could choose to respond to two or more criteria from Section C, one or more criteria from Section D and one or more criteria from Section E, as well as either or both of the competitive

preference priorities. A dash (-) indicates that the applicant did not choose to respond to a particular criterion or priority.
