Some sections have been renumbered.

9 FAM 41.58 Notes:

Since over 50 percent of this subchapter has been revised, revisions since the last update **DO NOT** appear in *italics* and *dark magenta*. All new text appears in sections N2, Significance of Approved Petition, N3, Evidence Forming Basis for R Visa Issuance (Use of Petition Information Management Service (PIMS)), N4, Validity of R Visas, and N15, Admission, Extension of Stay, and Readmission. The other sections have been renumbered, beginning with section N5, No Residence Abroad Requirement for R Nonimmigrants because of updates.



- 2. **Change Transmittal** has replaced the term, Transmittal Letter. Change Transmittal was selected as being more appropriate in this age of electronic information transmission. The FAM volume's transmittal acronym and numerical series remains in place.
- 3. Officers are reminded that Department-issued materials not codified in the Foreign Affairs Manual or its supplemental Foreign Affairs Handbook series generally have no regulatory validity (see 2 FAM 1115.2).

1. Remove and discard the old 9 FAM 41.53 Notes (CT:VISA-1133; 12-22-2008, 35 pages) and insert the new 9 FAM 41.53 Notes (CT:VISA-1378; 11-24-2009, 45 pages).

Remove and discard the old 9 FAM 41.58 Notes (CT:VISA-1102; 11-06-2008, 14 pages) and insert the new 9 FAM 41.58 Notes (CT:VISA-1378; 11-24-2009, 10 pages).

2. After inserting the material in the binder, insert this change transmittal letter immediately following the CT Checklist, then fill in the entry line for CT:VISA-1378, and initial.
