Remove 9 FAM 40.51 Exhibit I (CT:VISA-1044, 09-26-2008; 2 pages) and insert the revised 9 FAM 40.51 Exhibit I (CT:VISA-1381, 12-02-2009; 2 pages).

Remove 9 FAM 40.51 Exhibit VIII (CT:VISA-1344, 10-09-2009; 1 page) and insert the revised 9 FAM 40.51 Exhibit VIII (CT:VISA-1381, 12-02-2009; 1 page).
