- N11.1 Text was deleted "Chest X-Ray and Serologic Tests for Applicants Under 15 Years Old"
- N11.2 Text was expanded to two paragraphs "X-Ray Requirement for Pregnant Woman"
- N12.2 c (2) Text was deleted "Referral to U.S. Public Health Service/Center for Disease and Prevention"
- N17 New section added "Applicants Suspected of Being HIV Positive by the Panel Physician"
- 2. **Change Transmittal** has replaced the term, Transmittal Letter. Change Transmittal was selected as being more appropriate in this age of electronic information transmission. The FAM volume's transmittal acronym and numerical series remains in place.
- 3. Revisions since the last update appear in *italics* and *dark magenta*. Other than formal titles, the italics will be removed the next time the material is updated. Only current changes will appear in italics. Italics provide a

historical record of changes.

4. Officers are reminded that Department-issued materials not codified in the Foreign Affairs Manual or its supplemental Foreign Affairs Handbook series generally have no regulatory validity (see 2 FAM 1115.2).

Filing Instructions (Paper Copies)

- 1. Remove and discard the old 9 FAM 42.66 Notes (CT:VISA-1067; 10-09-2008, 15 pages) and insert the new 9 FAM 42.66 Notes (CT:VISA-1391; 01-13-2010, 16 pages).
- 2. After inserting the material in the binder, insert this change transmittal letter immediately following the CT Checklist, then fill in the entry line for CT:VISA-1391, and initial.
