#### Changes

 This Change Transmittal issues updates to **9 FAM 41.54 Notes.** Section N3.3, Transmission of Approved Petition to Post via Kentucky Consular Center (KCC), was removed. Subsequent sections were renumbered. Minor edits to language and references were also made as part of CA/VO's annual 9 FAM review process.

- 2. **Change Transmittal** has replaced the term, Transmittal Letter. Change Transmittal was selected as being more appropriate in this age of electronic information transmission. The FAM volume's transmittal acronym and numerical series remains in place.
- 3. Revisions since the last update appear in *italic* and *dark magenta*. Other than formal titles, the italic will be removed the next time the material is

updated. Only current changes will appear in italic. Italic provides a historical record of changes.

4. Officers are reminded that Department-issued materials not codified in the Foreign Affairs Manual or its supplemental Foreign Affairs Handbook series generally have no regulatory validity (see 2 FAM 1115.2).

### Filing Instructions (Paper Copies)

- 1. Remove and discard the old 9 FAM 41.54 Notes (CT:VISA-1569; 10-04-2010, 33 pages) and insert the new 9 FAM 41.54 Notes (CT:VISA-1693; 09-19-2011, 32 pages).
- 2. After inserting the material in the binder, insert this change transmittal letter immediately following the CT Checklist, then fill in the entry line for CT:VISA-1693, and initial.
