- 1. Remove and discard the old 9 FAM 41.57 Notes (CT:VISA-1549; 09-27-2010, 12 pages) and insert the new 9 FAM 41.57 Notes (CT:VISA-1698; 09-20-2011, 12 pages).
- 2. After inserting the material in the binder, insert this change transmittal letter immediately following the CT Checklist, then fill in the entry line for CT:VISA-1698, and initial.
