Application

This bulletin is intended for use by Part 139 Airport Managers and State Aviation Directors within the States of Iowa, Kansas, Missouri and Nebraska

Background

Part 139.303(c) requires airport operators to train airport personnel with responsibilities in the airport certification program. The Central Region airport certification staff previously distributed a CD in January 2010, with supplemental guidance PowerPoint presentations for use in the required Part 139 training programs. Many of these supplemental guidance presentations have recently been updated due to the new Advisory Circulars issued in 2010, and new presentations have been added.

The presentation, *Inspecting Airfield Marking, Signs and Lighting*, has been replaced with separate presentations for inspecting markings and signs. These supplemental guidance presentations are primarily intended for airport operations and maintenance personnel.
