

Introduction

AT&T Inc. (on behalf of its wholly-owned subsidiary AT&T Mobility Spectrum LLC) (“AT&T”) hereby has set forth at Exhibit A the complete unredacted June 3rd response (“Complete Response”) to the letter dated May 20, 2011, from Ruth Milkman, Chief of the Wireless Telecommunications Bureau, and the General Information Request attached thereto (the “Request”). AT&T is simultaneously submitting to the Commission documents responsive to the Request. (“Document Production”)

On June 3, 2010, AT&T provided a partial response to the Request (“Partial Response”) because at that time a Second Protective Order had not been released by the Commission to protect the Highly Confidential information redacted in the Partial Response. AT&T submitted a Confidential version and a redacted public version of the Partial Response. AT&T is now attaching the Complete Response pursuant to the recently released *Second Protective Order* in this proceeding. The attached Complete Response is identical to the Partial Response, except that the Complete Response is unredacted and, pursuant to the *Second Protective Order*, has been labeled “HIGHLY CONFIDENTIAL INFORMATION – SUBJECT TO SECOND PROTECTIVE ORDER IN WT DOCKET NO. 11-18 BEFORE THE FEDERAL COMMUNICATIONS COMMISSION – Additional Copying Prohibited.”

AT&T also is submitting an additional document that is responsive to Request No. 3(ii). This document contains projections that are currently used by the network engineers in the ordinary course of business. This Highly Confidential document is being submitted as Attachment 3.ii.1 to the Response to Request No. 3(ii) and is located at Exhibit B.

AT&T has taken reasonable efforts to search for, identify and produce documents responsive to the Request and otherwise to respond to the Request, consistent with the breadth of the request and the time period provided for the response. Pursuant to discussions with the Commission Staff, in order to respond in a timely fashion to the Requests, in numerous instances AT&T is producing documents gathered through key word searches of custodial files. With respect to certain document requests, AT&T has supplemented its key word search with the search of files within AT&T reasonably believed to contain the information sought. Exhibit C identifies the files of custodians that were searched for particular requests for documents, the key words used for the search, and the document requests for which AT&T supplemented key word searches with a search of department files reasonably believed to contain the requested information.

Pursuant to discussions with Commission Staff, AT&T is submitting its response consistent with the following qualifications:

- The Commission's request for "strategic plans, policies, analyses, reports and presentations," may be limited to plans, analyses and reports prepared for, presented to, reviewed by, discussed by, or considered by AT&T's board of directors or AT&T's executive management, or any member thereof.
- Custodian files were searched for the period January 1, 2009 forward.
- AT&T has not verified that it has produced "all other documents referred to in the document or attachments" pursuant to Instruction 4.
- AT&T has not searched backup disks and tapes for documents.

AT&T is simultaneously submitting a privilege log in this proceeding. While AT&T has made every effort to ensure that none of the documents it has provided are privileged, in the event that any privileged documents may have been inadvertently produced, any such inadvertently produced privileged materials do not constitute waiver of any applicable privilege.

REDACTED - FOR PUBLIC INSPECTION

AT&T requests that any privileged documents inadvertently produced be returned to AT&T as soon as such inadvertent production is discovered by any party. AT&T reserves all rights to seek the return of any such documents.

AT&T requests the return of all Confidential and Highly Confidential material at the conclusion of this proceeding.
