**SUMMARY:** The Department of Labor is publishing an amendment to SGA 10-10

Combating Exploitative Child Labor by Promoting Sustainable Livelihoods and

Educational Opportunities for Children in Jordan on Grants.gov and the USDOL

The solicitation was originally published on Grants.gov and the USDOL

website on October 6, 2010.

**Amendements:** 

On page 8, Section III. A.1.a., delete the following sentence from the education

section:

"Applicants must develop a package of that supports children's access to

education and training opportunities and that promote improved livelihoods of

their households, in order to."

Replace with the sentence:

"Applicants must develop a package of services that supports children's access to

education and training opportunities and that promotes improved livelihoods of

their households, in order to."

On page 9, Section III. A.1.a., delete the following sentence from the education

section:

"However, USDOL encourages Applicants to provide, including direct

educational services and training, to as many beneficiaries as possible, within the

first year of the project."

## Replace with the sentence:

"However, USDOL encourages Applicants to provide services, including direct educational services and training, to as many beneficiaries as possible, within the first year of the project."

• On page 11, Section III.A.2., delete language in section 2. Strengthening Policies and Capacity on Child Labor, Education, and Sustainable Livelihoods and replace with the following:

"USDOL considers strengthening country capacity to combat exploitative child labor and promote quality education and other sustainable livelihood strategies in Jordan as critical for achieving long-term impact in this effort. USDOL is intending to fund a \$2 million project by December 31, 2010 through ILO-IPEC that will seek to address many of these policy issues. USDOL aims to improve country capacity in Jordan through its IPEC funded project by contributing to the:

1) harmonization of Jordan's legal frameworks with international standards related to child labor, 2) mainstreaming of child labor issues into specific policies or programs at the national, regional, or sectoral level, 3) expansion of child labor concerns in relevant national development policy frameworks, and 4) establishment and/or improvement of a child labor monitoring system (CLMS).

As such, Applicants are not required to propose policy and capacity building interventions in the four areas outlined in the paragraph above, but, after award, must coordinate their work with IPEC to ensure coherence and to avoid duplication of policy and capacity building interventions that aim to address child labor and its root causes in Jordan. Projects funded under this solicitation are encouraged to propose strategies to strengthen the capacity of local Jordanian institutions that the project works with to combat child labor. To the extent feasible, projects should work with the Government of Jordan towards the elimination of the costs associated with schooling, which often create a barrier to education in Jordan. Projects funded under this solicitation are also encouraged to

strengthen the capacity of local institutions to promote access to and improve quality of basic education. Applicants are encouraged to promote policies that seek to ensure local education systems are responsive to the needs of children formerly engaged in exploitative child labor and that actively support their school entry/return and regular attendance. Applicants should also consider strategies to address the relevance of education, including the long term payoff of education in providing school graduates with the skills and knowledge necessary to acquire quality jobs upon completion of their studies. Applicants are encouraged to partner with business to create new jobs, and provide seed capital for youth to start their own business, including working with religious organizations to do so.

Applicants should consider strengthening local mechanisms to enforce Jordan's child labor and education laws and propose creative ideas that address the nexus between better law enforcement, the reduction of exploitative child labor, and the improvement of educational opportunities and the promotion of sustainable livelihoods for children and households."

• On page 31, Section IV.A.1., delete the sentence from the project design and budget section:

"Low administrative costs and amount of resources to direct services (*e.g.*, direct educational and livelihoods services) are preferred."

### Replace with the sentence:

"Low administrative costs and higher amounts of resources to direct services (e.g., direct educational and livelihoods services) are preferred."
