ACTION: Correction. Amendment to SGA 11-04.

SUMMARY: The Department of Labor is publishing an amendment to SGA 11-04 *Project to Combat Exploitative Child Labor in Sugarcane Growing Areas of the Philippines* on <u>Grants.gov</u> and the USDOL website. The solicitation was originally published on <u>Grants.gov</u> and the USDOL website on July 14, 2011.

Amendements:

• On page 29, Section F., remove the sentences from **Dun and Bradstreet Number:**

Applicants must include their unexpired Dun and Bradstreet/ DUNS number in the organizational unit section of Block 8 of the Standard Form (SF)-424. To obtain a DUNS number free of charge, call 1-866-705-5711 or access the following Web site: http://www.dnb.com/us/. Requests for exemption from the DUNS number requirement must be made to the Office of Management and Budget (OMB), Office of Federal Financial Management at 202-395-3993. Any Applicant that does not already have a DUNS number should consider starting the process of obtaining their DUNS number as soon as possible in order to avoid delays that could result in the rejection of an application.

After receiving a DUNS number, Applicants must also register as a vendor with the Central Contractor Registration (CCR) through the following Web site: https://www.bpn.gov/ccr/ or by phone at 1-888-227-2423. CCR should become active within 24 hours of completion. For any questions about registration, please contact the CCR Assistance Center at 1-888-227-2423. After registration, Applicants will receive a confirmation number. The Point of Contact listed by the organization will receive a confidential password, known as a Trader Partnership Identification Number (TPIN) via mail.

Replace with the sentences:

Applicants must include their unexpired Dun and Bradstreet/ DUNS number in the organizational unit section of Block 8 of the Standard Form (SF)-424. Applicants proposing subgrantees or subcontractors must submit each organization's DUNS number as an attachment to the Cost Proposal.

Organizations that do not have a DUNS number can receive a DUNS number at no cost by calling the dedicated toll-free number request line at 1-866-705-5711 or by using the web-based form available at http://fedgov.dnb.com/webform. Registration is brief and can be completed immediately when requested by phone, or within 1-2 business days when requested through the webform.

Organizations that have not registered with Central Contractor Registration (CCR) will need to obtain a DUNS number first and then access the CCR online registration through the CCR home page at https://www.bpn.gov/ccr/default.aspx (U.S. organizations will also need to provide an Employer Identification Number from the Internal Revenue Service that may take an additional 2-5 weeks to become active). Completing and submitting the registration takes approximately one hour to complete and your CCR registration will take 3-5 business days to process.

The Point of Contact listed by the organization will receive a confidential Trader Partnership Identification Number (TPIN) via mail.

• On page 36, Section G., remove the sentence from **Annex B: Work Plan**:

"The Work Plan must correspond to activities identified in the Logframe and the Project Design Narrative."

Replace with the sentence:

"The Work Plan must correspond to activities identified in the Logic Model and the Project Design Narrative."

• On page 43, Section IV., remove the sentence from **A. Application Evaluation** Criteria:

"The criteria outlined below will be used to evaluate applications submitted in response to this solicitation on the basis of 100 points, with up to a possible 5 extra points."

Replace with the sentence:

"The criteria outlined below will be used to evaluate applications submitted in response to this solicitation on the basis of 100 points."

• On page 57, Section VII., remove list of annexes to the technical proposal from **Appendix C: Technical Proposal Format**:
