Project to Combat Rural Exploitative Child Labor in Peru

ACTION: Amendment to SGA 11-07

DATE: November 3, 2011

SUMMARY: The Department of Labor is publishing an amendment to the Solicitation for Cooperative Agreement Applications (SGA) 11-07 *Project to Combat Rural Exploitative Child Labor in Peru* on <u>Grants.gov</u> and the USDOL website. This amendment is being issued in response to decrees on Emergency Zones within Peru. The solicitation was originally published on <u>Grants.gov</u> and the USDOL website on October 13, 2011. Deadline for submission of applications has been extended to **November 28, 2011**.

The original SGA specifically limited project activities to the regions of Huánuco and Huancavelica. Emergency Zones, however, were defined under Supreme Decree N° 075-2011-PCM of September 1, 2011, and Supreme Decree N° 078-2011-PCM of September 12, 2011. The Emergency Zones established by these decrees include some but not all areas of Huánuco and Huancavelica (see Appendix F). Taking into account this unavoidable limitation on areas for project activities and in order to provide Applicants with greater latitude in selecting acceptable target areas, Applicants may now propose activities in any region of Peru, with the following two additional requirements. First, Applicants must not propose work in any areas of the country currently declared by these decrees as an Emergency Zone. Second, Applicants must propose work in a minimum of two and no more than three regions in Peru.

After award, further limitations on the geographical focus for this child labor project might be imposed on the Grantee(s) for security reasons following consultation with the Government of Peru and/or U.S. Embassy.

AMENDMENTS TO SGA 11-07 TEXT:

On page 1, remove the sentences from Key Dates:
"Deadline for Submission of Applications is November 15, 2011 (34 days after publication). Deadline for Submission of All Technical Questions is October 26, 2011 (14 days after publication date)."

Replace with the sentences:

"Deadline for Submission of Applications is November 28, 2011 (47 days after publication). Deadline for Submission of All Technical Questions is November 14, 2011 (33 days after publication date)."

• On page 1, remove the sentence from **Executive Summary**:

"In 2011, the U.S. Department of Labor, Bureau of International Labor Affairs will award up to \$13 million for a technical assistance project(s) to support efforts to eliminate exploitative child labor in the Huancavelica and Huánuco regions of Peru, with a focus on reducing social exclusion and promoting economic opportunities for Peruvian households most vulnerable to the worst forms of child labor."

Replace with the sentence:

"In 2011, the U.S. Department of Labor, Bureau of International Labor Affairs will award up to \$13 million for a technical assistance project(s) to support efforts to eliminate exploitative child labor in a minimum of two and no more than three regions in Peru, with a focus on reducing social exclusion and promoting economic opportunities for Peruvian households most vulnerable to the worst forms of child labor. Applicants must not propose work in any area of the country currently declared by the Government of Peru as an Emergency Zone. A list of current Emergency Zones can be found in Appendix F."

• On page 19, section III, remove the following sentences from **Target Areas**:

"Based on a needs assessment, Applicants should select potential geographical areas in Huancavelica and Huánuco that include children working in the worst forms of rural exploitative child labor in agriculture, mining, and other hazardous work. Selection of specific local target areas of intervention is subject to change following award based on further consultation with the Peruvian government, the U.S. Embassy and USDOL."

Replace with the sentences:

"Based on a needs assessment using available information, Applicants should select potential geographical areas in a minimum of two and no more than three regions in Peru that include children working in the worst forms of rural exploitative child labor in agriculture, mining, and other hazardous work. Applicants may propose work in any part of the national territory of Peru except for those areas of the country currently declared by the Government of Peru as Emergency Zones. See Appendix F for a list of Emergency Zones."

• On page 47, section IV, **Project Design and Budget** remove the following sentence:

"The extent to which the Applicant proposes effective and relevant strategies for identifying direct beneficiaries; ensuring the long-term reduction of exploitative child labor in the two targeted regions of Peru; providing direct educational services for

target children, and promoting sustainable livelihoods for their households as a strategy for removing or preventing children from involvement in exploitative labor."

Replace with the sentence:

"The extent to which the Applicant proposes effective and relevant strategies for identifying direct beneficiaries; ensuring the long-term reduction of exploitative child labor in a minimum of two and no more than three targeted regions of Peru; providing direct educational services for target children, and promoting sustainable livelihoods for their households as a strategy for removing or preventing children from involvement in exploitative labor."

• On page 63, remove Appendix F "Population and poverty rates in Huancavelica and Huánuco by Province":
