AN AGREEMENT BETWEEN _____ AND THE FBI

As consideration for my employment/assignment, or my continued employment/assignment to the Federal Bureau of Investigation (FBI), United States Department of Justice, I hereby agree to be governed by and to comply with the following provisions:

1. I understand that in order to maintain a security clearance, I must be reliable, trustworthy, of good conduct and character, and of complete and unswerving loyalty to the United States.

2. Consideration is being given to my dual citizenship status and its impact on my eligibility for access to classified information. The FBI has determined that as a condition of such eligibility, I must agree that I will not exercise my rights, benefits, privileges, or obligations as a citizen of _____ while employed by the FBI.

3. By signing this document, I agree that I will not:

- (a) Serve in the military or bear arms for a foreign government;
- (b) Accept educational, medical or other benefits from a foreign country;
- (c) Reside in a foreign country to meet citizenship standards;
- (d) Use foreign citizenship to protect financial or business interests in another country;
- (e) Seek or hold office in a foreign country;
- (f) Vote in foreign elections;
- (g) Perform or attempt to perform duties, or otherwise acting, so as to serve the interest of another government in preference to the interests of the United States;
- (h) Use or possess a foreign passport without prior FBIHQ approval.

4. Dual Citizenship Declaration: I understand, that because of the citizenship laws of the country with which I maintain dual citizenship, it is possible that country currently considers me to be its citizen thereof regardless of my valid U.S. citizenship. Notwithstanding such a possibility, I hereby declare that I am a citizen of the U.S. and that my loyalty and allegiance are to the U.S. (Select the appropriate response below by placing an "X" next to the applicable statement.)

I understand that these restrictions are consistent with and do not supersede, conflict with, or otherwise alter the employee obligations, rights, or liabilities created by Executive Orders 10450, 12968, and the "Adjudicative Guidelines For Determining Eligibility For Access To Classified Information."

7. Violations of this loyalty agreement may constitute cause for denial or revocation of my security clearance and/or facility access and may subject me to criminal sanction.

8. I have read this agreement carefully. Each of the numbered paragraphs of this agreement is severable and if a court should find any of these paragraphs to be unenforceable, I agree that the remaining provisions will continue in full force.

9. I accept the above provisions as conditions of my employment/assignment or continued employment/assignment by the FBI. I agree to comply with these provisions during my employment and/or assignment with the FBI.
