19 IT IS HEREBY ORDERED that Defendant Qunesha Clewis, individually or
20 through any entity, and anyone working with her or under her direction, are
21 PERMANENTLY ENJOINED, pursuant to 26 U.S.C. §§ 7402 and 7407 from directly
22 or indirectly:

- 23 1. acting as a federal income tax return preparer;
- 24 2. preparing or filing (or helping to prepare or file) or directing others to
25 prepare or file federal income tax returns, amended returns, or other
26 related documents and forms for others;
- 27 3. understating customers' liabilities as subject to penalty under 26
28 U.S.C. § 6694;

- 1 4. engaging in any other activity subject to penalty under 26 U.S.C.
- 2 §§ 6694, or 6695 or any other penalty provision of the Internal
- 3 Revenue Code; and
- 4 5. engaging in any other conduct that interferes with the administration
- 5 or enforcement of the internal revenue laws.

6 IT IS FURTHER ORDERED that the Court retains jurisdiction to enforce this
7 injunction and the United States may engage in post-judgment discovery to
8 monitor the compliance of Qunesha Clewis with this injunction.

10 IT IS SO ORDERED, ADJUDGED AND DECREED.
