## **Management Services Center Reorganization**

Dear Schedule Partner

The Management Services Center (MSC), in an effort to improve efficiency of acquisition operations, has determined it necessary to reorganize its staff and multiple award schedule programs into two distinct divisions: Pre Award and Post Award.

As a result of this major realignment, all modifications and options for MOBIS, PES, Logworld, Language, Environmental and Consolidated will now be processed out of one division made up of two branches (one focusing on modifications and one focusing on contract options).

- So how will this affect my contract? While many of our industry partners will continue to work with the contract specialist/contracting officer currently assigned to their contract, we do have approximately 1000 contracts that do require reassignment.
- When will this change actually become effective? The change will become effective on October 26, 2009.
- Where do I check to see if there has been a change and/or who my contract specialist/contracting officer is? All contracts can be viewed at <a href="www.gsa.gov/eLibrary">www.gsa.gov/eLibrary</a> on or after October 26, 2009 to find your assigned contract specialist/contracting officer. Please be advised that it is extremely important that you check this site for any noted changes to your contract point of contact.
- What if I have a modification or option in process? In most cases, those modifications and options currently in house are being completed by the person originally assigned. We do have approximately 40 Professional Engineering Services (PES) options being reassigned however all affected contractors have been or will be contacted by October 26, 2009. While some files may have to be transferred, all actions will be completed as quickly as possible.

MSC workload is currently at a record level, which has caused increased processing time. However our goal is to complete the reorganization as quickly as possible with the least amount of interruption to any actions you may have in house. This realignment is intended to improve service and efficiency in the post award process. #### **LogWorld Update**

Congratulations LogWorld contractors! LogWorld sales have gone up to \$837 Million dollars this year. This is a 17 % increase over 2008 sales. Each year LogWorld sales have increased, even in times of financial turmoil.

If you are not sharing in this prosperity, now is a good time to review some basic marketing tips. - Make sure someone in your company is checking eBuy on a daily basis because a lot of purchases are made through the eBuy system. You have complete access to bid on the tasks placed against your awarded Special Item Numbers (SINs). (An agency might only select 3 companies to be notified about the task order but any company, who sees the task order in eBuy, is eligible to bid.)
- Make sure your GSA Advantage file is up to date and readable. Agencies do research in eLibrary with word searches. If you file is in .pdf format it is possible that the search software will not look at your file. For Schedules providing services (such as LogWorld) it is critical that agencies can find your company with a word search. It is strongly recommended that your GSA Advantage and eLibrary file be either .txt, .doc or .rtf.

SIN 874-597 still needs more contractors so that there is competition on this SIN. 874-597 allows a company to do the minor construction required on task orders like installing a warehousing system (perhaps opening a section of wall so that a conveyor belt can go through the wall, or running an electrical outlet to a new location so that a computer can be positioned in a specific spot, or placing a pedestrian door on a loading dock). There are millions of reasons to use this SIN



in conjunction with your LogWorld task. This SIN allows LogWorld contractors to provide a greater scope of service in one contract vehicle – the agency doesn't have to contract separately for the odd, small repair needed on so many logistical tasks.

Do you know your GSA Contracting Officer? An easy way of identifying this person is through eLibrary. Pull up either site (GSA eLibrary or GSA Advantage) and put your contract number in the search box (for example: GS-10F-0251V). Your company name will be displayed in red. Click on your company name and a page of information will come up which includes or GSA CO with contact information.

#### **Language Schedule Information**

Dear Schedule Partner,

The MSC receives calls periodically asking about contractors that provide Visual and Hearing Impaired services. We also receive calls asking if the scope of the schedule covers more advanced Linguistic Analytical services and which contractors offer those services. In response to these calls the customers are directed to schedules e-Library were they can search through a list of vendors who offer these services or they are walked through GSA Advantage and shown how they can narrow their search down.

Neither one of these responses offered the customer a quick and easy solution. We want to make it quicker and easier for the customer to find you. And we also want a solution that made the contractors who offered these types of service more visible to the customer.

So, when the Language Schedule was refreshed on September 16, 2008, significant changes were made. These changes included the addition of two new Special Item numbers (SINs). These SINs were developed to better identify services offered under the schedule to meet the demands of our customers. To read a description of the new SINs please click on the red links below.

#### 382 5 SERVICES FOR THE VISUAL AND HEARING

If you are interested in having your company name and text file listed under these new SINs and have services/labor categories <u>currently</u>



<u>awarded</u> under you contract **and** they fall within the scope of one or more of the new SIN(s), you may submit a written modification request to have the new SIN(s) added to our current contract. You will need to be specific in your request and identify each labor category/service you wish to delete from the current SIN and add to the new SIN. Resultant services that are awarded under the new SIN(s) will not be duplicated under other SIN(S).

For example, if you have these services awarded under SIN 382-2 and request a modification to have them added to 382-4 and your contract is modified, they will be deleted under SIN 382-2. The intent of the additional SINs is to segregate the more specialized services based on customer demands and ordering patterns.

If you have the capability of providing the services that fall within the scope of the new SIN(s) but they are not listed in your current contract and you wish to have them added to your contract, you must request a written modification in accordance with the modification clause, 552.243-72. You will also need to submit a technical proposal for the services proposed, a price proposal, your latest commercial pricelist (if applicable) and Commercial Sales Practices information with the request.

Please include a list of government agencies (including contact information) that you provide these services to with all modification requests. Please do not include any other type of modification request with the additional SIN request in order to expedite the process. Other types of modification should be submitted separately. #### **Eligibility to Use GSA Sources of Supply**

GSA Order ADM 4800.2F, Eligibility to Use GSA Sources and Services, provides detailed information regarding those agencies and organizations that have been determined to be eligible to use GSA Schedule contracts. The GSA Order also provides definitive guidelines concerning eligibility requirements and limitations for a variety of other GSA sources of supply and services. This is a good reference to have in your tool kit as you market your services to various entities.
