# Report on College Credit Card Agreements

## Purpose

The Board of Governors of the Federal Reserve System (the “Board”) submits this report in accordance with Section 305(a) of the Credit Card Accountability Responsibility and Disclosure Act of 2009 (the “Credit CARD Act”), Pub. L. No. 111–24, 123 Stat. 1734 (2009), Section 127(r) of the Truth in Lending Act, 15 U.S.C. § 1637(r). Section 305 of the Credit CARD Act requires the Board to submit to the Congress, and to make available to the public, an annual report that lists certain information submitted to the Board concerning agreements between credit card issuers and institutions of higher education (“institutions”) or certain affiliated organizations, such as alumni associations or foundations, that provide for the issuance of credit cards to college students (“college credit card agreements” or “agreements”). This is the second annual report by the Board pursuant to Section 305 of the Credit CARD Act.

## Introduction

Section 305 of the Credit CARD Act and the Board’s implementing regulations, 12 C.F.R. § 226.57(d), require credit card issuers to submit to the Board each year a copy of any college credit card agreement between the issuer and an institution of higher education or an alumni organization or foundation affiliated with an institution of higher education (an “affiliated organization”)<sup>1</sup> that was in effect at any time during the preceding calendar year. Issuers also are required to submit the following information with respect to each agreement: (1) the number of credit card accounts opened pursuant to the agreement (“college credit card accounts”) that were

<sup>1</sup> In some cases, issuers submitted to the Board agreements with other types of organizations, such as fraternities, sororities, and professional or trade organizations, that relate to the issuance of credit cards to college students. Such agreements are included in this report and categorized as agreements with “other organizations.”

open at year-end (regardless of when the account was opened); (2) the amount of payments made by the issuer to the institution or organization during the year;<sup>2</sup> and (3) the number of new college credit card accounts that were opened during the year.

Issuers were required to make their second annual submission to the Board by March 31, 2011. This submission comprised college credit card agreements to which the issuer was a party during 2010 and information regarding payments and accounts as of December 31, 2010.<sup>3</sup>

This report is based on the information and agreements submitted to the Board by credit card issuers. Because some agreements address the provision of other financial products (such as deposit accounts) as well as credit cards, payments made by issuers under these agreements may not relate solely to credit card accounts. In addition, some or all of the accounts opened pursuant to these agreements may have been opened by individuals who are not students (such as alumni, faculty, and staff of an institution of higher education). Furthermore, card issuers’ submissions do not include information regarding credit card accounts opened by students independent of a college credit card agreement (such as when a student responds to an offer made to the general public).

<sup>3</sup> Issuers were required to make their initial submission to the Board by February 22, 2010. That initial submission comprised college credit card agreements to which the issuer was a party during 2009 and information regarding payments and accounts as of December 31, 2009. The Board’s report regarding those initial submissions was released in October 2010 and is available on the Board’s public website at [www.federalreserve.gov/pubs/reports\\_other.htm](http://www.federalreserve.gov/pubs/reports_other.htm).

In 2011, the Board received corrected information for 2009 from Banco Popular de Puerto Rico, Pennsylvania State Employees Credit Union, and PNC Bank, N.A. In addition, information for 2009 regarding Purdue Federal Credit Union’s college credit card agreement was inadvertently omitted from the Board’s initial report. Corrected information for 2009 is included in Appendix C to this report. All comparisons to 2009 information in this report reflect these corrections.

The Board also notes that, because issuers were required to submit all college credit card agreements to which they were a party at any time during 2010, issuers' submissions may include agreements that terminated in 2010 or 2011 and therefore are no longer in effect.

Information included in this report also is available on the Board's public website at [www.federalreserve.gov/collegedebitcardagreements](http://www.federalreserve.gov/collegedebitcardagreements). In addition, under Section 304 of the Credit CARD Act and the Board's implementing regulations, 12 C.F.R. § 226.57(b), the public can obtain college credit card agreements between a card issuer and an institution of higher education directly from the institution.

Pursuant to Title X of the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010, responsibility for collecting and submitting to the Congress annual reports regarding college credit card agreements will transfer to the newly established Consumer Financial Protection Bureau on the designated transfer date, July 21, 2011.

## Overview of College Credit Card Agreements

As presented in **table 1**, the Board received 1,004 college credit card agreements from 21 credit card issuers for 2010. Although the number of issuers increased from 2009 to 2010, the number of agreements, total number of college credit card accounts open at year-end, amount of payments by issuers, and number of new college credit card accounts opened during the year all declined.

### Credit Card Issuers

As presented in **table 2**, 21 credit card issuers submitted agreements to the Board for 2010. Four new issuers submitted agreements for 2010, and one issuer from 2009 submitted no agreements for 2010, resulting in a net increase of three issuers.

### New Issuers

Of the four new issuers that submitted agreements for 2010, three were credit unions, each of which submitted a single agreement with an affiliate of a local university: (1) Pen Air Federal Credit Union's agreement with the University of West Florida Foundation; (2) University of Illinois Employees Credit Union's agreement with the University of Illinois Alumni Association; and (3) USC Credit Union's agreement with the University of Southern California Alumni Association. The University of West Florida Foundation and the University of Illinois Alumni Association each previously had agreements with FIA Card Services, N.A. ("FIA"), a subsidiary of Bank of America Corporation. These agreements terminated in 2010 and 2009, respectively.

The fourth new issuer, Capital One, N.A., is an affiliate of Capital One Bank USA, N.A., which submitted an agreement for 2009.

### Withdrawing Issuer

Commerce Bank terminated its sole agreement in 2009 and was not a party to any college credit card agreements in 2010. Commerce Bank's agreement was with Southwest Baptist University.

### Issuers Submitting the Largest Number of Agreements

As in 2009, FIA submitted the largest number of agreements for 2010. FIA submitted 848 agreements, more than 15 times as many as any other issuer. Also as in 2009, the issuers submitting the second and third largest number of agreements were U.S. Bank National Association ND ("U.S. Bank")<sup>4</sup> and Chase Bank USA, N.A. ("Chase"), with 54 and 28 agreements, respectively. UMB Bank, N.A. ("UMB"), which for 2009 submitted only 6 agreements, submitted 23 agreements for 2010, the fourth largest number.

<sup>4</sup> For 2009, U.S. Bank submitted agreements and related information regarding the following four affinity relationships: the American Association of University Women; the American Military Society; Heritage Affinity Enterprises, LLC; and the Ohio State Bar Association. Because these organizations are not institutions of higher education or affiliated organizations under Section 305 of the Credit CARD Act and the Board's rules, U.S. Bank was not required to include these agreements in its 2009 submission to the Board and did not include them in its 2010 submission. All references to 2009 information in this report include these relationships. All references to 2010 information in this report do not.

### College Credit Card Agreements

As presented in [table 3](#), issuers submitted 1,004 college credit card agreements for 2010, a net decrease of 41 agreements, or approximately 4 percent, from 2009.

#### Agreements Terminated in 2009

As [table 3](#) also shows, 71, or approximately 7 percent, of the 1,045 agreements in effect in 2009 were terminated at or before year-end 2009. A complete list of these agreements is provided as [Appendix B](#) to this report. The issuer with the largest number of agreements terminated in 2009 was FIA, with 59 agreements terminated.

Most of the agreements terminated in 2009 were associated with college credit card programs with a few hundred or a few thousand open accounts. A notable exception, however, is the University of Illinois Alumni Association's agreement with FIA, which terminated in 2009. For 2009, this agreement was one of the top 10 based on both total number of open accounts (25,528 open accounts as of December 31, 2009) and payments by the issuer (\$3,272,457). The University of Illinois Alumni Association entered into a new college credit card agreement with University of Illinois Employees Credit Union in 2010.

#### New Agreements in 2010

As [table 3](#) also shows, issuers entered into 34 new agreements in 2010.<sup>5</sup> While the overall number of agreements submitted to the Board decreased, some issuers had a net increase in the number of agreements to which they were a party. The issuer with the largest number of new agreements in 2010 was UMB, with 17 new agreements.

#### Agreements Terminated in 2010

As presented in [table 4](#), 231 agreements, or approximately 23 percent of the 1,004 agreements that were in effect in 2010, were terminated by year-end 2010. These agreements are included in [Appendix A](#) to this report. The issuers with the largest numbers of agreements terminated in 2010 were FIA (214 agreements, or approximately 25 percent of its agreements) and

<sup>5</sup> Several new agreements result from an institution or organization entering into a new agreement after termination of a previous agreement with a different issuer, not a new institution or organization entering the affinity credit card market. For example, as described above, the University of Illinois Alumni Association's agreement with FIA was terminated in 2009, and the association entered into a new agreement with University of Illinois Employees Credit Union in 2010.

Chase (11 agreements, or approximately 39 percent of its agreements).

### Institutions of Higher Education, Affiliated Organizations, and Other Organizations

As presented in [table 5](#), approximately 37 percent of agreements in effect in 2010 were between a credit card issuer and an institution of higher education. An additional 36 percent were between a credit card issuer and an alumni association affiliated with an institution of higher education. Approximately 7 percent were with foundations affiliated with an institu-

tion of higher education, 17 percent with other organizations, and 2 percent with more than one institution or organization.<sup>6</sup>

### Open College Credit Card Accounts

As presented in [table 1](#) and in [table 6](#), the total number of open college credit card accounts at year-end declined from 2009 to 2010 by approximately 17 percent. While some issuers had increased numbers of open accounts at year-end 2010, these increases were offset by larger declines experienced by other issuers.

### Largest Numbers of Open Accounts at Year-End

[Table 7](#) presents the 10 college credit card agreements with the largest numbers of open accounts as of December 31, 2010. These 10 agreements represent approximately 19 percent of all open college credit card accounts as of December 31, 2010.

As [table 7](#) shows, the seven agreements with the largest number of open accounts at year-end 2010 also were the top seven for 2009. Of the three agreements that were among the top ten in 2009 but not in 2010,

one was terminated in 2009 (the University of Illinois Alumni Association's agreement with FIA), one was terminated in 2010 (the University of Notre Dame du Lac's agreement with Chase), and one was not reported for 2010 (Heritage Affinity Enterprises, LLC's agreement with U.S. Bank<sup>7</sup>). The agreements

ranked 11th, 12th, and 13th at year-end 2009 replaced these agreements in the top 10 for 2010.

### Payments by Credit Card Issuers

As presented in table 1 and in table 8, the total amount of payments made by issuers to institutions and organizations under college credit card agreements declined from 2009 to 2010 by approximately 13 percent. Six issuers made increased payments under their college credit card agreements in 2010, and six made decreased payments. However, the

decreases in payments were larger than the increases, resulting in an overall decline.

### Largest Payments by Issuers

**Table 9** presents the 10 college credit card agreements with the largest payments made by the credit card issuer in 2010. These 10 agreements represent

approximately 24 percent of all payments by issuers pursuant to college credit card agreements in 2010.

As table 9 shows, five of these agreements also were among the agreements with the ten largest payments in 2009. Of the five agreements among the top ten for 2009 but not for 2010, one was terminated in 2009

(the University of Illinois Alumni Association's agreement with FIA), two were terminated in 2010 (Chase's agreements with the University of Notre Dame du Lac and the Greater University of South Carolina Alumni Association), and two remained in effect but involved smaller payments by the issuer in 2010 (FIA's agreements with the Wisconsin Alumni Association and the Golden Key International Honour Society).

Of the five agreements among the top ten for 2010 but not for 2009, four were in the top fifteen for 2009. The Ex-Students Association of the University of Texas's agreement with FIA, which was ranked 96th for 2009, with payments of \$182,029, was ranked second for 2010, with payments of almost \$2.4 million.

### New College Credit Card Accounts

As presented in table 1 and in [table 10](#), the total number of new college credit card accounts opened by all issuers declined by approximately 17 percent from 2009 to 2010. While some issuers opened a greater number of new accounts in 2010 than in 2009, more issuers experienced declines.

### Largest Numbers of New Accounts Opened

[Table 11](#) presents the 10 college credit card agreements with the largest numbers of new college credit card accounts opened in 2010. These 10 agreements

represent approximately 23 percent of all new college credit card accounts opened during 2010.

As [table 11](#) shows, six of the ten agreements listed also were among the top ten based on number of new accounts opened in 2009. Of the four agreements among the top ten for 2009 but not for 2010 (FIA's agreements with the Alumni Association of the University of Michigan and the Regents of the University of Michigan, the California Alumni Association and the Regents of the University of California, the UCLA Alumni Association, and the Ex-Students Association of the University of Texas), all remained among the top fifteen for 2010.

Of the four agreements among the top ten based on new accounts opened for 2010 but not for 2009, two are new agreements that first took effect in 2010—the University of Notre Dame du Lac's agreement with FIA and the University of Illinois Alumni Association's agreement with University of Illinois Employees Credit Union. The University of Notre Dame du Lac previously had an agreement with Chase that terminated in 2010. The University of Illinois Alumni Association previously had an agreement with FIA that terminated in 2009. The Alumni Association of the University of Virginia's agreement with FIA first took effect in October 2009 and had only limited new account activity in 2009. The Association of Graduates of the United States Air Force Academy's agree-

ment with USAA Savings Bank was ranked 13th in 2009.

pursuant to the agreement during 2010; and (9) the number of new accounts opened pursuant to the agreement during 2010.

[Appendix B](#) to this report lists college credit card agreements that were in effect at some time during 2009 but were terminated by year-end 2009. This table also is organized alphabetically by the name of the institution or organization. (Agreements terminated in 2010 are included in [Appendix A](#). These agreements are marked as no longer in effect on January 1, 2011.)

In 2011, the Board received corrected information for 2009 from Banco Popular de Puerto Rico, Pennsylvania State Employees Credit Union, and PNC Bank, N.A. In addition, information for 2009 regarding Purdue Federal Credit Union’s college credit card agreement was inadvertently omitted from the Board’s initial report. Corrected information for 2009 is included in [Appendix C](#) to this report. All comparisons to 2009 in this report reflect these corrections.
