Chairman Diaz's Comments on SECY-06-0028

I commend the staff for providing a set of recommendations that will enhance the efficiency and flexibility of the ACMUI, while assuring that an effective composition of the membership will be maintained. There are many factors which will impact the NRC regulatory framework for the medical arts, notably among them the expansion of our jurisdiction to include naturally occurring and accelerator-produced radioactive material (NARM) and the efforts of the Interagency Radiation Source Protection and Security Task Force. The staff should remain cognizant of ongoing changes and developments and move expeditiously to recommend changes to the ACMUI's composition to ensure that it continues to provide expert advice to the Agency.







Comments from Commissioner Merrifield on SECY-06-0028:

I understand and support the staff desires to improve and streamline the process for appointing members to the Advisory Committee on the Medical Uses of Isotopes (ACMUI). However, I do not approve eliminating the Commission totally from the selection process. I recognize the ACMUI was initially established to directly support the staff. I personally respect the advice provided by the ACMUI and have, on occasion, directly discussed medical issues with the Chairman of the ACMUI. Therefore, the Commission should be directly involved in the final selection process. To make it perfectly clear concerning which recommendations I approve and disapprove, I will address all five recommendations individually.

1. I approve the staff request to reduce the size of the ACMUI by eliminating the position of interventional cardiology physician.
2. I approve authorizing the Director, IMNS, in the Office of NMSS to approve the Federal Register announcement of vacancies on the ACMUI.
3. I approve authorizing the Director, NMSS, to appoint members of the ACMUI based on recommendations of the screening panel only after consulting directly with the Commission. I do not approve the Director, NMSS appointing members without first consulting with the Commission.
4. I approve the staff's request that ACMUI members be appointed under the advisory committee appointment process in accordance with Management Directive 10.12, "Use of Advisory Committee Members" to permit staggered termination dates.
5. I approve the staff request that ACMUI member's terms of service be increased from three to four years with the maximum number of terms remaining at two.

I appreciate the staff efforts to develop the set of recommendations in SECY-06-0028 that would ensure continuity in the membership of the Advisory Committee on the Medical Use of Isotopes (ACMUI) and provide for a more efficient and effective means of recruiting and selecting members to the ACMUI. The staff, in this paper, seeks to use Management Directive (MD) 10.12, "Use of Advisory Committee Members," to streamline its process by adapting the MD to handle the entire process within the Office of Nuclear Material Safety and Safeguards. While I generally support the staff recommendations in this paper, and believe that implementation of MD 10.12 would ensure continuity of the committee, the staff should continue to consult the Commission prior to appointing members to the ACMUI.
