SUBJECT:	2008 ANNUAL REPORT ON COMMISSION ADJUDICATION
PURPOSE:	To provide the Commission a perspective on the adjudicatory caseload and the Commission's role in adjudication during calendar year 2008.

# **INTRODUCTION:**

The Commission has authority to review decisions of Presiding Officers and the Atomic Safety and Licensing Boards. The Office of Commission Appellate Adjudication (OCAA) assists the Commission in this adjudicatory role by monitoring cases and preparing the Commission's appellate decisions. The Commission may exercise appellate authority either when a dissatisfied party to an NRC adjudicatory proceeding seeks review of a board's or presiding officer's decision, or when the Commission, on its own initiative, determines that review is warranted. The Commission may also offer guidance to the licensing boards on significant novel questions raised in an ongoing proceeding, as when a board certifies a question or refers a ruling to the Commission. In addition, NRC regulations give the Commission original jurisdiction to resolve particular categories of adjudications, such as reactor license transfer cases.

I am providing the Commission this report on agency adjudications for calendar year 2008 (CY 2008) as part of OCAA's monitoring role over adjudicatory matters. This report updates information in OCAA's last Annual Report (SECY-08-0009, January 17, 2008) and includes additional information, in table form, on published Commission decisions (CLIs) issued in CY 2008.

## COMMISSION ADJUDICATORY ACTIVITIES

## 1) <u>Commission Adjudicatory Decisions in CY 2008</u>

CY 2008 was a typical adjudicatory year for the Commission in terms of output. The Commission issued 29 decisions, essentially the same as its average of 28.6 over the five prior calendar years.<sup>1</sup> These decisions spanned a wide variety of proceedings, including:

- four actively contested reactor license renewals (Oyster Creek, Pilgrim, Vermont Yankee, and Indian Point),
- a materials license for an on-site ISFSI (Diablo Canyon),
- a materials license for possession and use of licensed material in an industrial irradiator (Pa'ina),
- matters before the Pre-License Application Presiding Officer (PAPO) concerning disputes over the electronic availability of documents in the Licensing Support Network (Yucca Mountain),
- one license transfer (Palisades *et al.*),
- one reactor license amendment regarding a power uprate (Millstone), and
- issuance of a subpoena by the agency's Office of Investigations (Shapiro).

OCAA drafted 25 of last year's 29 Commission decisions.<sup>2</sup> Of those 25 decisions, 8 upheld or denied review of board orders,<sup>3</sup> and one decision reversed a board order admitting a

OCAA supported the Commission in preparing for and holding the first Commission-level adjudicatory hearing in nearly 20 years, a Subpart K hearing in the *Diablo Canyon* ISFSI proceeding. The Commission issued 4 decisions related to the *Diablo Canyon* case, following remand of the case from the U.S. Court of Appeals for the Ninth Circuit.<sup>5</sup> Further, in a significant expansion of its role, OCAA provided extensive support to the Commission in adjudicating several pre-application matters regarding DOE's construction authorization application for a geologic repository at Yucca Mountain, Nevada.<sup>6</sup> OCAA also prepared the hearing notice for the Yucca Mountain matter.<sup>7</sup>

The balance of the Commission's decisions addressed other matters, including a license transfer matter of original Commission jurisdiction.<sup>8</sup>

The Commission's decisions continue to interpret and clarify NRC regulations and applicable statutes, including the Atomic Energy Act of 1954, as amended, and the National Environmental

Policy Act (NEPA). Significant OCAA work in CY 2008 included decisions:

- Clarifying the scope of underwater irradiator licensing proceedings; specifically, that such a proceeding properly may encompass siting-related safety contentions (*Pai'na Hawaii*, CLI-08-03);and that NEPA does not require the NRC to analyze the potential impacts on health of consuming irradiated food, permitting the agency to credit the Food and Drug Administration's safety determinations regarding the consumption of irradiated food (*Pa'ina Hawaii*, CLI-08-16).
- Identifying circumstances in which the NRC might disqualify a party's counsel from participating in an NRC proceeding (*Yucca Mountain*, CLI-08-11).
- Confirming that the NRC Staff is accorded the authority to perform acceptance reviews of license applications (*Yucca Mountain*, CLI-08-20).
- Reiterating that the agency has not, and will not, litigate claims regarding the adequacy of the NRC Staff's safety review process in licensing adjudications (*Oyster Creek* et al. license renewals, CLI-08-23).

In preparing draft decisions, OCAA provides the Commission with multiple draft decisions (or alternative discussions within a draft) on particularly difficult legal or policy issues which, in CY 2008, included *Yucca Mountain* (CLI-08-14), *Oyster Creek* et al. (CLI-08-23) and *Indian Point* (CLI-08-29). These alternatives are intended to give the Commission options on how to proceed. In addition, our Commission papers routinely point out legal issues, and possible legal and policy implications of particular courses of action, that the Commission might wish to consider. OCAA strives to submit its draft decisions expeditiously, and has nearly always been successful in meeting this goal. Our overall average turnaround time (between receiving the final relevant document and transmitting OCAA's draft decision to the Commission) was 37 days for the 31 draft decisions that OCAA submitted to the Commission in CY 2008. See the attached table, "Commission Adjudicatory Decisions, January – December 2008." Our median turnaround time was 34 days. For CLIs of average complexity, we aim to provide the Commission with a draft order and Commission paper within 60 days (90 days in the most complex of cases) of the filing or issuance of the last document necessary for consideration in drafting the order. All but three of our draft decisions met their respective targets in CY 2008.

# 2. <u>Pending Commission Appeals/Petitions for Review</u>

As of December 31, 2008, 6 draft decisions were before the Commission in the following cases:

- Shaw Areva MOX Services materials license application (NRC Staff's request for interlocutory review)
- Shieldalloy materials license amendment (Licensing Board's Memorandum to the Commission)
- *Bellefonte* and *Lee* combined license applications (referred rulings to the Commission)
- *Crow Butte* uranium recovery application (appeals of licensing board decision granting a hearing to multiple petitioners)
- *Oyster* Creek license renewal application (petition for review of merits decision rejecting intervenors' contention).

#### 3. <u>Anticipated Adjudicatory Matters</u>

OCAA expects that the Commission will face the following significant adjudicatory matters in CY 2008:

- Disputes in the *Yucca Mountain* construction authorization matter, particularly regarding contention admissibility. (As of December 31, 2008, several extensive intervention petitions and requests to participate as an interested governmental entity have been referred to the Atomic Safety and Licensing Board Panel.)
- Continued disputes regarding heavily contested license renewal applications, including *Indian Point*, *Pilgrim*, *Vermont Yankee*, and *Prairie Island*.
- Additional challenges based on the NEPA terrorism issue in multiple dockets.
- Continued disputes regarding multiple COL applications (as of December 31, 2008, intervention petitions have been granted by, or are pending before, Atomic Safety and Licensing Boards in the *Bellefonte*, *Calvert Cliffs*, *Shearon Harris*, *Summer*, and *Vogtle* cases)

# COMMISSION ADJUDICATORY TECHNICAL SUPPORT PROGRAM

The Commission Adjudicatory Technical Support (CATS) program was established as a separate adjudicatory employee organization to provide technical support to OCAA and the Commission during the licensing period for a high-level waste repository. In light of schedule uncertainties and changes resulting from delays in the Department of Energy's submission of a repository license application, the CATS program has been in a minimalist, maintenance mode since April 2006. The Acting Director of OCAA is currently serving as Director of the CATS program. In CY 2008, in anticipation of activity in the *Yucca Mountain* adjudicatory proceeding in CY 2009, OCAA prepared a comprehensive update to the list of individuals identified to serve as part-time adjudicatory employees to assist the Commission and OCAA with respect to the high-level waste repository adjudication.<sup>9</sup>

In addition, in SRM-COMSECY-07-0027, "Plan for Commission Conduct of Mandatory Hearings on Applications for Combined Licenses" (Feb. 12, 2008), the Commission approved the proposed plan for Commission conduct of mandatory hearings on applications for combined licenses. In connection with this approval, the Commission directed that the CATS program be expanded in purpose and staff to ensure that the Commission has sufficient independent staff in

place, with appropriate expertise, to allow for additional support. The Commission directed OCAA to present a staffing plan to the Commission that would appropriately develop the CATS staff to be able to assist in accomplishing the Commission's role in reviewing new reactor applications in mandatory hearings. OCAA provided that staffing plan to the Commission in May 2008.<sup>10</sup>
