# Hazardous Substance Response Plans for Vessels

#### I. Application

- A. Owners/Operators of tank vessels transporting/storing hazardous substances (CWA list 40 CFR 116.4) in bulk
- B. Isomers and hydrates, as well as solutions of 10% or more by weight

#### **II.** Plan Contents

- A. General notification
- B. Notification procedures, list of contents
- C. Shipboard source control procedures
  - i. Dependent on actions vessel plans to take
- D. Risk-based decision support process
  - i. Describe process to identify, evaluate, control, and communicate risk
- E. Response resources (equipment/personnel)
- F. Training and exercises
- G. Chemical-specific appendix
- H. Vessel-specific appendix
- I. On board checklist and emergency procedures (unmanned barges)

### III. Qualified Individual Requirements

- A. Like oil plan requirements + OSHA incident commander training (29 CFR 1910.120)
- B. QI must have full authority to implement response actions

#### IV. Exercises

- A. Same as oil plans; hazsub exercises may be substituted for oil exercises
- B. QI Notification quarterly
- C. Spill management team tabletop annually
- D. Equipment deployment annually
- E. Entire plan every 3 years

## V. Contracted/Owned Equipment/Timeframes

- A. Air & Water monitoring within 2 hours
- B. PPE within 2 hours
- C. Modeling within 2 hours

- D. Firefighting 24 hours
- E. Lightering location dependent (12-36 hours)
- F. Salvage 12 hours

#### VI. Identified Equipment

- A. Insoluble floaters
- B. Insoluble sinkers

#### VII. Technical Specialists (access to):

- A. Product Specialist
- B. Toxicologist
- C. Certified Marine Chemist
- D. Certified Industrial Hygienist
- E. Chemist or Chemical Engineer

#### VIII. Chemical-Specific Appendix

- A. CHRIS Manual suffices
  - i. Physical and chemical class
  - ii. Hazard and hazard class
  - iii. Shipping info
  - iv. Exposure limit

#### IX. Certifications

- A. O/O certifies that risks have been evaluated and resources listed in plan are adequate for responding to WCD
- B. Statement that all resource providers acknowledge being listed in plan

#### X. Plan Submission

- A. 60 days prior to transfer operations
- B. Plan good for 5 years

- A. Qualified Individual

- E. 10% Criterion
