1	The Department of Defense (DoD) had obligations of \$39.3M during the week ending November 27, 2009, bringing the cumulative obligation of Recovery Act funds to \$3,560.4M, which is 47.9% of available DoD Recovery Act funds. This includes \$2,737.5M for the Facilities Sustainment, Restoration and Modernization (FSRM) program which had new obligations of \$29.6M this week; \$594.6M for the Military Construction program; \$163.6M for the Near Term Energy-Efficient Technologies (NTEET) program with \$6.2M in obligations this week; \$39.3M for the Energy Conservation Investment Program (ECIP); and \$25.3M for the Homeowner's Assistance Program including \$4.1M in new obligations. Total obligations to date reflect over 2,700 contract actions with non-Federal vendors. Over 75% of contract actions were to small businesses (56% of contract dollars).	Continue to award contracts and monitor execution.
3	There were an additional \$29.6M in new FSRM obligations for the week including \$17.5M for Army projects and \$12.1M for Defense-Wide funded projects. For the week, Army obligations included \$16.8M to repair training area tank trails at Fort Bliss, TX. Defense Wide obligations included \$11.4M to modernize outpatient clinic spaces at Beale Air Force Base (AFB), CA.	
4	The \$6.2M increase NTEET projects obligations was primarily \$4.3M for the Air Force's Ultra-High Efficiency Multi-junction Solar Cells project and \$1.5M for the Army's lightweight, flexible, cost effective solar energy photovoltaic project.	
5	The Homeowner's Assistance Program had \$4.1M in new obligations during the week primarily in payments to service members and their families.
