The Migratory Bird Conservation Commission

Section 2 of the Migratory Bird Conservation Act of February 18, 1929 (Act), as amended, established the Migratory Bird Conservation Commission.

Section 2. A Commission to be known as the Migratory Bird Conservation Commission, consisting of the Secretary of the Interior; as Chairman; the Administrator of the Environmental Protection Agency; the Secretary of Agriculture; two Members of the Senate, to be selected by the President of the Senate; and two Members of the House of Representatives, to be selected by the Speaker; is created and authorized to consider and pass upon any area of land, water, or land and water that may be recommended by the Secretary of the Interior for purchase or rental under this Act, and to fix the price or prices at which such area may be purchased or rented; and no purchase or rental shall

be made of any such area until it has been duly approved for purchase or rental by said Commission. Any Member of the House of Representatives who is a member of the Commission, if reelected to the succeeding Congress, may serve on the Commission notwithstanding the expiration of a Congress. Any vacancy on the Commission shall be filled in the same manner as the original appointment. The ranking officer of the branch or department of a State to which is committed the administration of its game laws, or his authorized representative, shall be a member ex officio of said Commission for the purpose of considering and voting on all questions relating to the acquisition, under said sections, of areas in his State. For purposes of said sections, the purchase or rental of any area of land, water, or land and water includes the purchase or rental of any interest in any such area of land, water, or land and water.

The Migratory Bird Conservation Fund

The Migratory Bird Conservation Fund provides the Department of the Interior with monies to acquire migratory bird habitat. There are three major sources of money for the Fund. The most well-known source is the revenue received from the sale of Migratory Bird Hunting and Conservation Stamps, commonly known as Duck Stamps, as provided for under the Migratory Bird Hunting and Conservation Stamp Act of March 18, 1934, as amended. The other two major sources include appropriations, as authorized by the Wetlands Loan Act of October 4, 1961, as amended, and import duties collected on arms and ammunition, as authorized by the Emergency Wetlands Resources Act of 1986.

Two land acquisition programs are financed from the Migratory Bird Conservation Fund. The first program purchases major migratory bird areas under the authority of the Migratory Bird Conservation Act, as amended. Lands and interests in land acquired through this program are considered and approved by the Migratory Bird Conservation Commission. The second

program acquires small natural wetland and pothole areas, and interests therein, designated as Waterfowl Production Areas. These wetlands and associated uplands are located mainly in the Prairie Pothole Region of the upper Midwest. They are acquired under the authority of the Migratory Bird Hunting and Conservation Stamp Act, as amended, and do not require approval from the Commission.

During Fiscal Year 2006, the Department of the Interior obligated a total of \$9,360,975 for the acquisition of land and interests in land totaling 14,759 acres in major migratory bird conservation areas. The Department also obligated \$17,634,863 for projects in Waterfowl Production Areas totaling 36,703 acres.

A total of \$38,937,217 was available for obligation from the Migratory Bird Conservation Fund during FY 2006. Obligations for all Migratory Bird Conservation Fund land acquisition functions during the fiscal year totaled \$38,255,979.

MBCC Approvals During Fiscal Year 2006

In Fiscal Year 2006, the Migratory Bird Conservation Commission approved the 35,756-acre acquisition boundary of Glacial Ridge National Wildlife Refuge in Polk County, Minnesota. The Commission also approved boundary additions, totaling 179,216 acres, at eleven previously-approved refuges, and the purchase price of 7,131 acres, at twenty previously-approved refuges.

Glacial Ridge National Wildlife Refuge (NWR) was authorized on October 12, 2004, under the legal authorities of the Migratory Bird Conservation Act, February 18, 1929, and the Emergency Wetland Resources Act of 1986. Glacial Ridge NWR is located along the glacial ridge of historic Lake Agassiz, approximately 10 miles east of Crookston, Minnesota, and sits in the upper reaches of more than 10 sub-watershed basins that flow into the Sandhill and Red Lake River watersheds. The refuge is within the prairie pothole region, an area known for its historically high waterfowl production. There are 35,756 acres within the approved acquisition boundary, 2,309 of which were donated by The Nature Conservancy (TNC).

The landscape of Glacial Ridge NWR was carved by wind and water over 12,000 years ago, as water levels in glacial Lake Agassiz fluctuated. The variety of prairie grasslands and wetlands that

formed provided for a very diverse and continentally important biological community. A high percentage of the original, pre-settlement wetlands of this area have been drained over the last century, and surface mining activities still pose a strong threat to the less than one percent of native tallgrass prairie habitat remaining in Minnesota. Glacial Ridge NWR is the center point for the restoration of this fragile ecosystem. The Service and its partners' efforts are directed to restoring the landscape that includes more than 12,000 acres of shallow and deepwater wetlands, wet prairie, and natural stream watercourses. The restored tallgrass prairie would provide breeding habitat for several waterfowl species including the northern pintail, blue-winged teal, canvasback, mallard, and redhead, and will benefit more than 20 species of grassland songbirds that are declining nationally.

There are 56 ownerships within the refuge, with a wide range of acreages (10 – 20,000+ acres). Tract 12 is located in the historically treeless area of the tallgrass

prairie. The property was farmed for many years; however, it is currently not being cultivated and contains a mixture of grasses and forbs. Minnesota DNR property lies on its northern border and TNC property lies on its western and southeastern border. The tract contains four restored wetlands, and several existing wetlands that provide excellent migratory bird habitat.

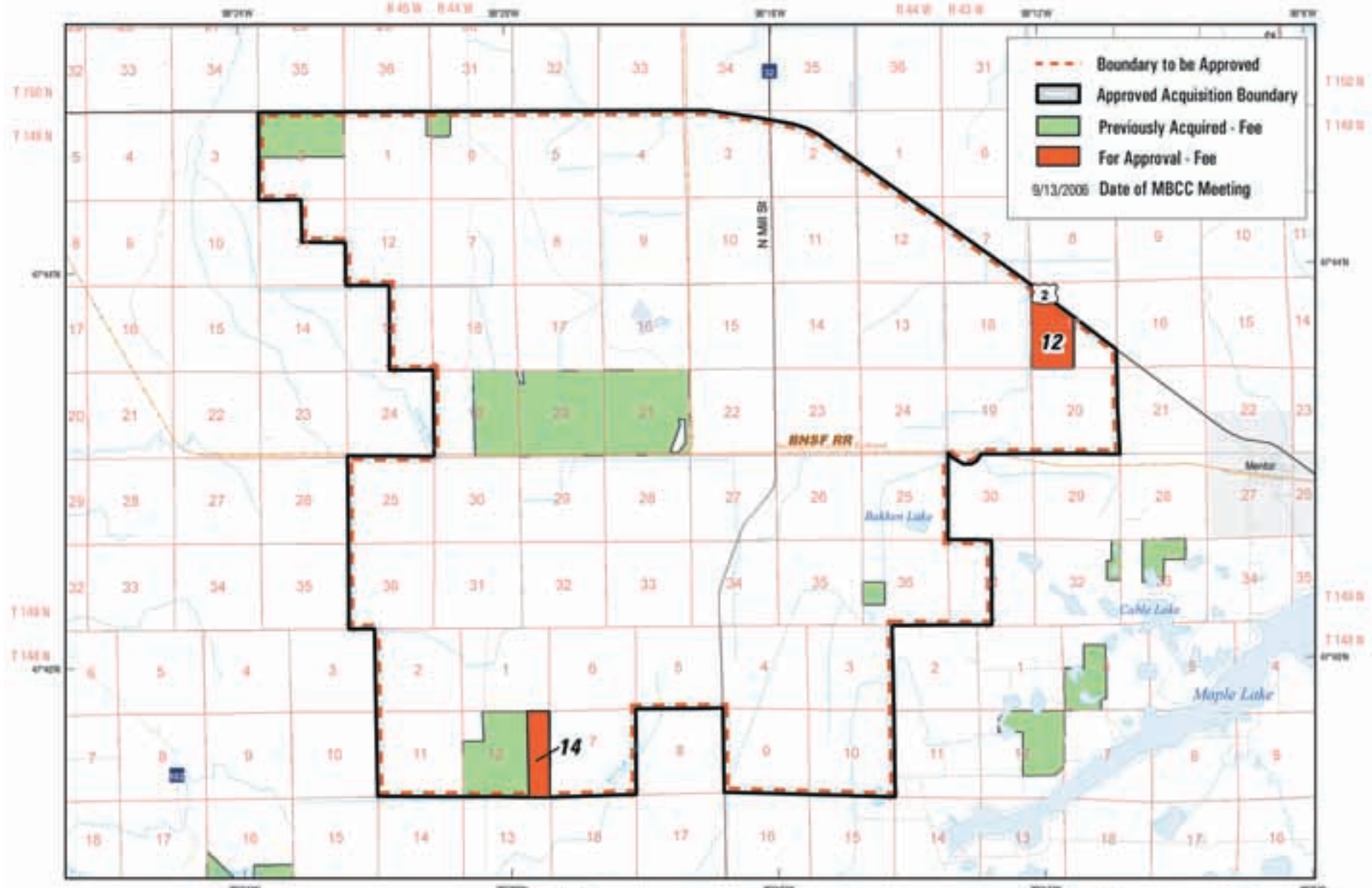
Tract 14 is located on an old beach ridge on the southern boundary of the refuge. The tract consists of several restored wetlands, and former cropland that has been seeded to native grasses. Minnesota DNR property lies on its southern border and TNC property lies on its western border. The tract supports nesting habitat for the northern pintail, and shorebirds including marbled godwits, Upland sandpipers, and Wilson's phalaropes.

The Commission approved the 35,456-acre refuge boundary, and gave price approval for 402 acres, in two ownerships, on September 13, 2006.

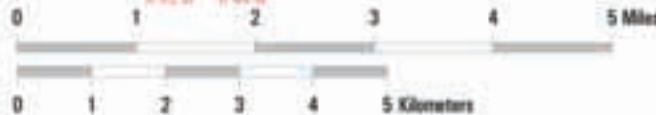


Glacial Ridge National Wildlife Refuge

National Wildlife Refuge Boundary Addition Approvals

White River National Wildlife Refuge *Desha, Monroe, and Phillips Counties, Arkansas*

White River National Wildlife Refuge was authorized by Executive Order 7173 on September 4, 1935, as a refuge “to effectuate further the purposes of the Migratory Bird Conservation Act (45 Stat. 1222) ...as a refuge and breeding ground for migratory birds and other wildlife.” Land was acquired under various emergency relief programs, and the “Arkansas-Idaho Land Exchange Act of 1992” resulted in the transfer of 40,749 acres of primarily bottomland hardwood wetlands to the refuge. The exchange, along with other land acquisitions, joined the north end of the White River NWR to the south end of Cache River NWR. To date 141,196 acres have been acquired, which includes 10,559 acres purchased with Migratory Bird Conservation Commission approval and funds.

White River NWR lies in the floodplain of the White River near where it meets the Mississippi River; and is one of the largest remaining bottomland hardwood forests in the Mississippi River Valley. One of the primary purposes of the refuge is to preserve and protect habitat for wintering migratory waterfowl and other migratory birds. The area is designated as one of the six original flagship areas for the North American Waterfowl Management Plan, and has also been recognized as a Wetland of International Importance under the Ramsar Convention, and as a Globally Important Bird Area by the American Bird Conservancy. The White River and Cache River basins of Arkansas are considered the #1 wintering areas for mallards in North America; however, large concentrations of other waterfowl species such as the wood duck, gadwall, and green-winged teal winter on the White River NWR. The refuge provides critical breeding, migration,

and wintering habitat for waterfowl and neo-tropical migratory birds, and a major north-south corridor in the Mississippi Valley.

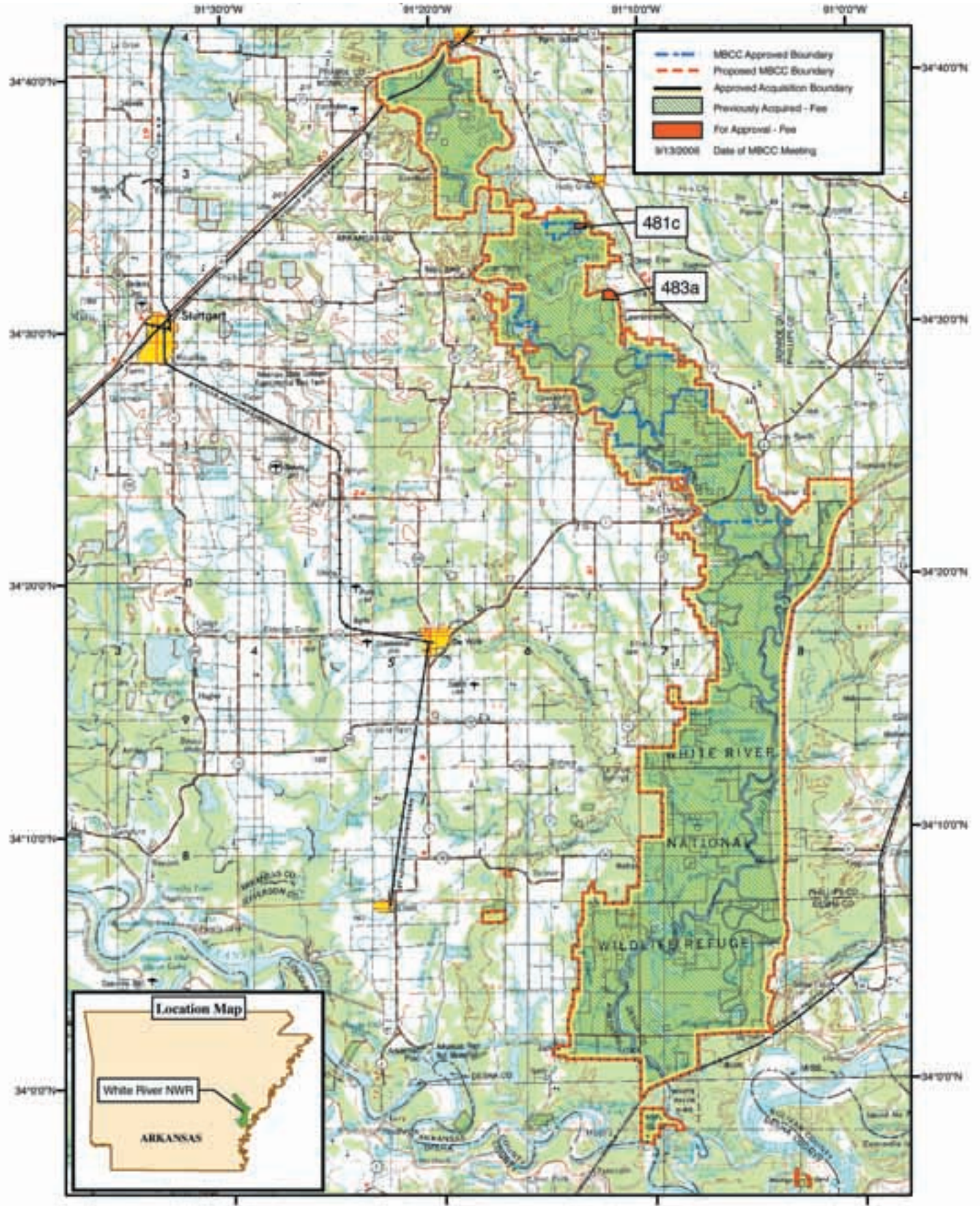
The 172,924-acre boundary approval has expanded the Service’s ability to offer outdoor recreation opportunities, including waterfowl hunting, fishing, and wildlife observation, an important public use, particularly with the sighting of the ivory-billed woodpecker, thought to be extinct. Both of the tracts approved for acquisition provide wintering and nesting habitat for waterfowl, including mallards and wood ducks.

The Commission approved the 172,924-acre refuge boundary, and gave price approval for 226 acres, in two ownerships, on September 13, 2006. This aligned the Migratory Bird Conservation Commission’s approved boundary with the Service’s existing refuge boundary.

**Sunkhaze Meadows
National Wildlife Refuge**
Penobscot County, Maine

Sunkhaze Meadows National Wildlife Refuge was established in 1988, with the acquisition of 9,300 acres from The Nature Conservancy. Subsequent Service-approved expansions have increased the boundary to 11,784 acres. Sunkhaze Meadows NWR is located near Bangor, Maine, about five miles north of the University of Maine at Orono. The refuge straddles Sunkhaze Stream, which enters the Penobscot River just north of Old Town. The Commission approved Sunkhaze Meadows NWR as a new refuge on September 10, 2003, and gave price approval for the acquisition of 951 acres.

This refuge protects and provides the necessary breeding habitat, food, cover,

and travel corridors in the Atlantic Flyway for the American black duck and ring-necked duck. The area is regionally ranked high in the North American Waterfowl Management Plan, and is listed as a high priority in the Northeast Atlantic Coast area because of its importance to the American black duck. Sunkhaze Meadows NWR also protects and provides important habitat for neo-tropical migrants and the American woodcock. Over 145 species of birds have been recorded on the refuge, including all of Maine's 23 species of warblers. The habitat is a wetland complex consisting of wet meadows, shrub thickets, wooded swamps, and open riverine habitat, along with plant communities associated with peat lands such as shrub heath, wooded cedar, and spruce bogs. Residential and commercial development is steadily increasing at the edge of the refuge.

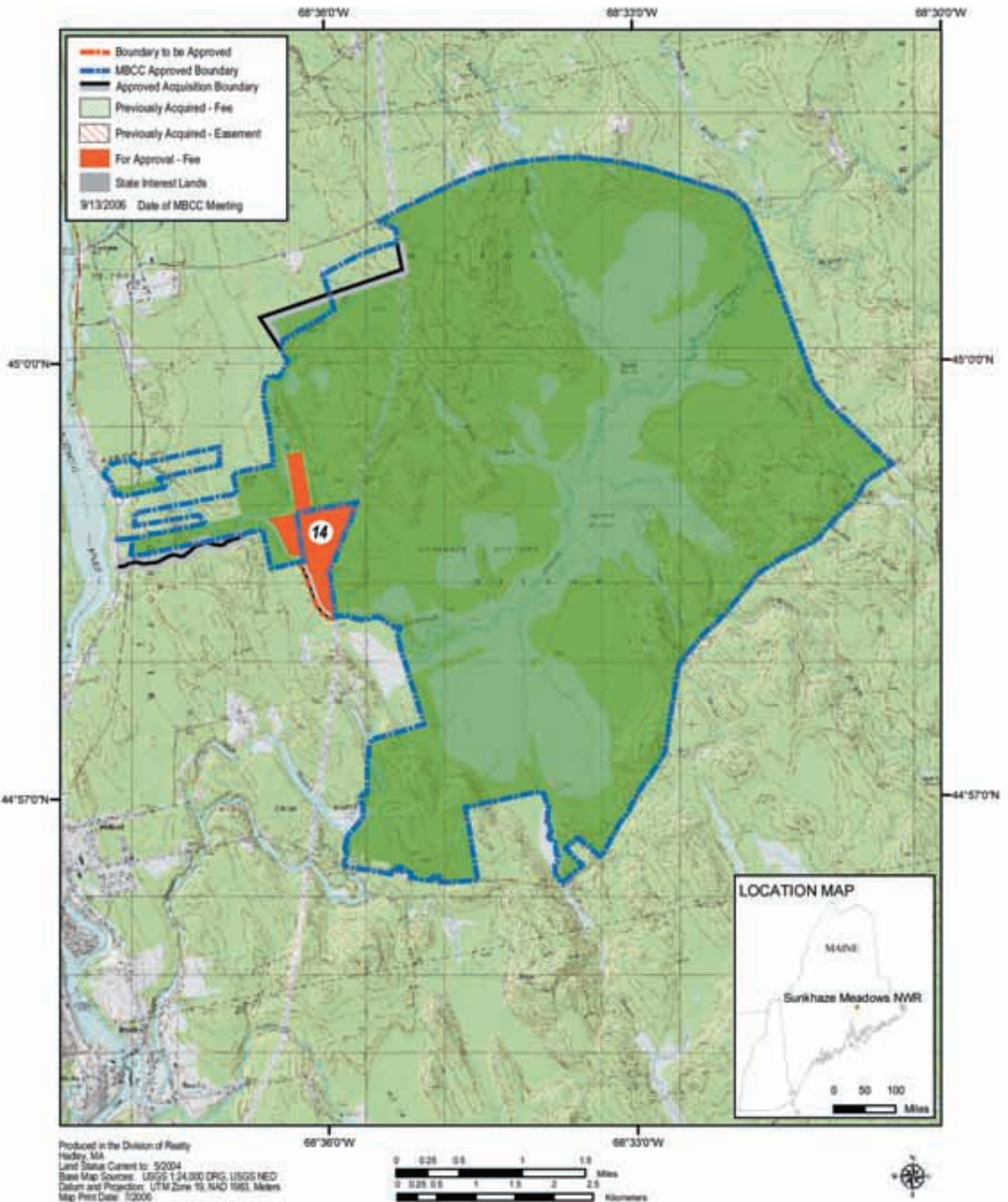
The tract approved for acquisition consists of 219 acres, with 9,000 feet of frontage on Sunkhaze Stream and Dudley Brook, with accompanying wetlands. It runs through the refuge in a secluded, remote area, and was historically used for timber harvesting. The acquisition of this parcel will enhance adjacent refuge lands by greatly increasing continuity of waterfowl habitat at a crucial location. It is ideally suited for recreational purposes with its extensive stream frontage, and is one of the last tracts to be acquired for the refuge. The Service plans to manage this tract for the benefit of the American black duck, ring-necked duck, neo-tropical migrant songbirds, and the American woodcock.

The Commission approved the 184-acre refuge boundary addition and gave price approval for a 219-acre tract on September 13, 2006.

Blackwater National Wildlife Refuge
Dorchester County, Maryland

Blackwater National Wildlife Refuge was authorized in 1932 as a waterfowl sanctuary. Before it was designated as a refuge, the marshland along the middle Blackwater River was managed as a fur farm. The refuge and its adjacent marshes and waters are one of the Chesapeake Bay's most important and productive estuarine assets. They support a wide diversity of aquatic and emergent plant communities, which provide optimum habitat for large concentrations of waterfowl. Blackwater NWR is part of the Chesapeake Marshlands NWR Complex, which includes Blackwater NWR, Martin NWR, and Susquehanna NWR. The Director approved the Land Protection Plan, as part of the

Comprehensive Conservation Plan, for the Complex on July 19, 2006, including authorization to add 15,545 acres to Blackwater NWR. The acquisition boundary at Blackwater NWR is now 43,796 acres.

Areas in and around Blackwater NWR are undergoing tremendous land use changes. Timber harvesting for saw timber and pulp production, and land clearing for agricultural purposes, are seriously reducing available habitat and degrading water quality. The tracts approved for acquisition are approximately 295 acres of forested wetlands that protect critical waterfowl habitat. They are located in the southwest area of Blackwater NWR, close to the headwaters of Coles Creek, where the water regime is mostly fresh. These tracts

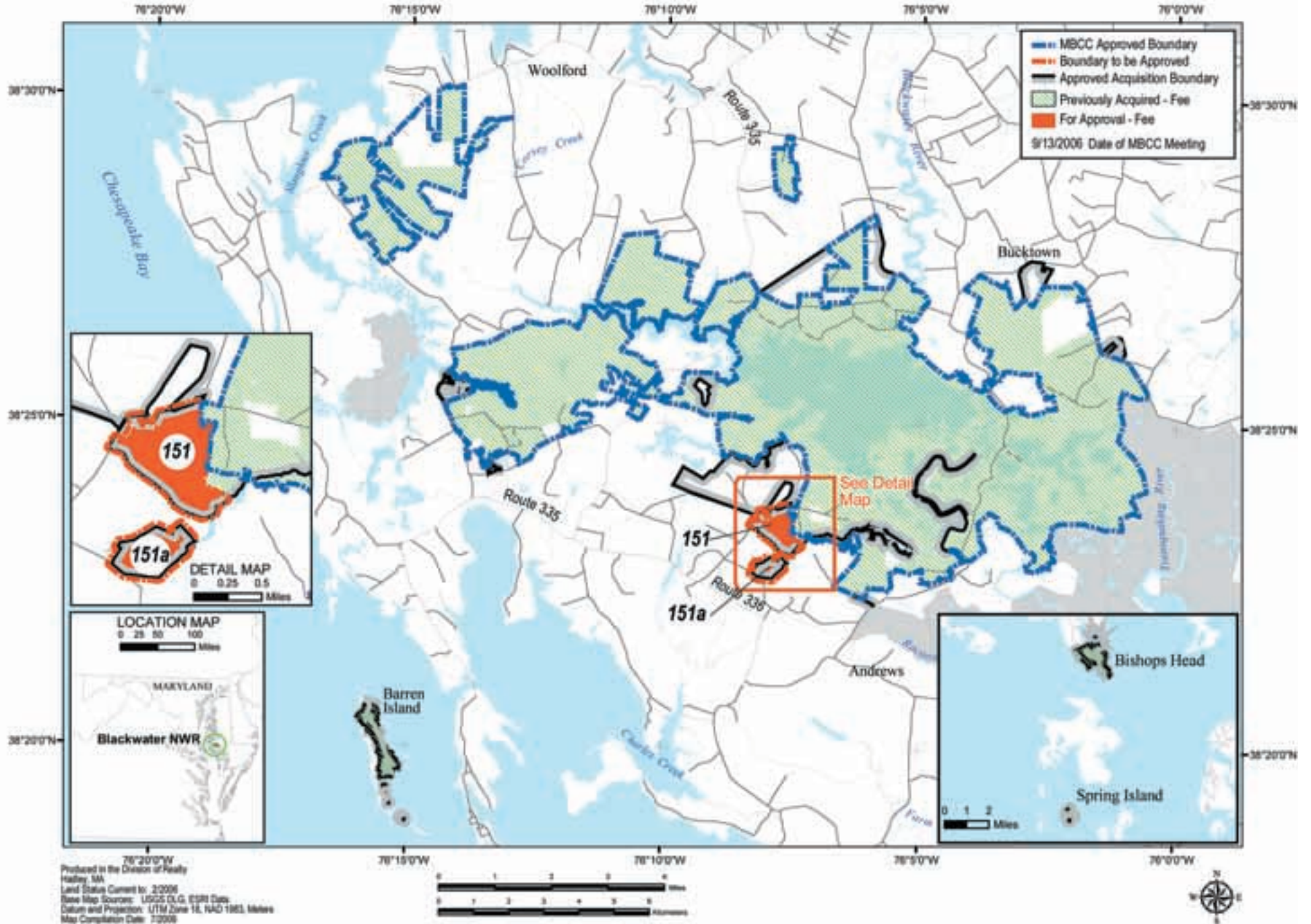
have an abundance of oaks, including a diversity of red and white oak species. The woodlands remain flooded throughout the winter, making soft and hard mast available for wintering waterfowl species, principally for the mallard, American black duck, and wood duck. Numerous species of other migratory birds, including the bald eagle, songbirds, and webless water birds, also utilize this area for nesting, roosting, and foraging. The Service plans to manage these tracts to promote and enhance waterfowl habitat, particularly for American black ducks, wood ducks, and other high priority migratory birds.

The Commission approved the 295-acre refuge boundary addition and gave price approval for these tracts on September 13, 2006.

Legislation creating the Silvio O. Conte National Fish and Wildlife Refuge (NFWR) was signed by President Bush in 1991. The late Congressman Silvio O. Conte had introduced legislation to authorize a national fish and wildlife refuge within the Connecticut River watershed, and it was renamed the Silvio O. Conte National Fish and Wildlife Refuge Act. When the final Environmental Impact Statement (EIS) for Silvio O. Conte NFWR was completed, the Service's Regional Director signed a Record of Decision on December 13, 1995, authorizing a 91,500-acre complex within the 7.2 million-acre Connecticut River watershed. The Service identified sixty-five Special Focus Areas (SFAs) important for resource protection in Connecticut, Massachusetts, New Hampshire, and Vermont. The refuge was officially established on October 3, 1997, with the acquisition of the 3.8-acre Third Island, located in the Connecticut River in Deerfield, Massachusetts.

The Silvio O. Conte NFWR was established to protect, conserve, and enhance habitats and populations of native wildlife species, and to provide nesting habitat for waterfowl species, including the American black duck, wood duck, common and hooded merganser, blue- and green-winged teal, and Canada goose. Conservation and protection of the American black duck are specifically identified in the Silvio O. Conte National Fish and Wildlife Refuge Act. The refuge also provides nesting habitat for other migratory birds, including the American woodcock. The EIS identifies SFA number 24 as the Mt. Tom/Mill River/Holyoke Range focus area, containing 8,200 acres. Breeding surveys have found 75 species of birds in the SFA, and high use by migrating warblers, including blackburnian, black-throated blue, blue-winged, northern parula, and yellow-rumped warblers. The 2,000-acre Mill River Division is a portion of the 8,200-acre SFA, and is located on the westerly bank of the Connecticut River, at the confluence of the Mill River in Northampton, Massachusetts. Upon completion of the refuge's Comprehensive Conservation Plan, which has just begun, the 2,000-acre boundary may be modified to include areas to the north.

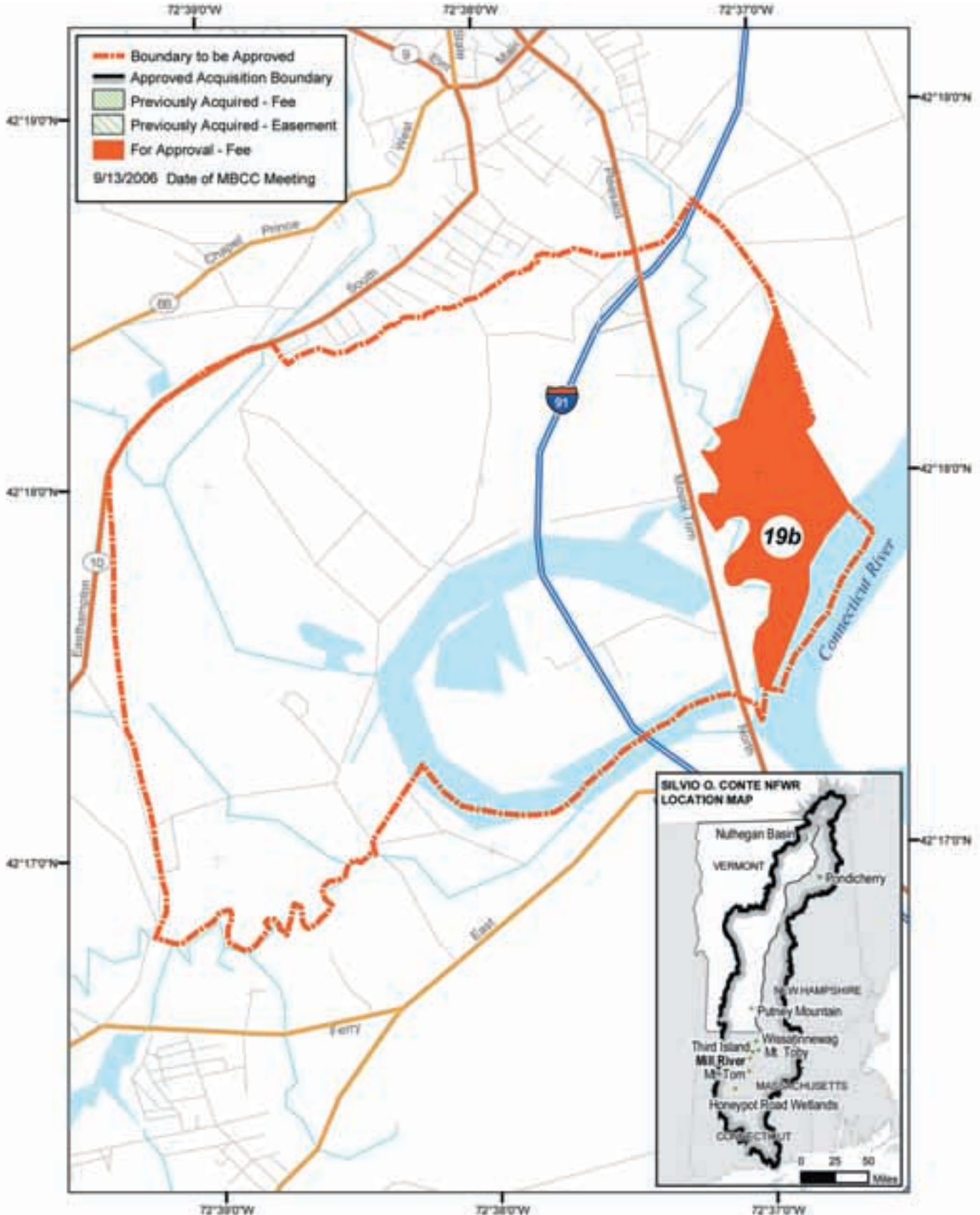
Tract 19b is within an area known as "the meadows," and consists of a mix of wooded wetlands, river shoreline, fields with early successional habitat, and two ponds. It abuts Mill River on the west, and the ponds connect to the main stem of the Connecticut River through a narrow channel. The property is on the river side of the Northampton dike, so it occasionally floods. Sheet water flooding on agricultural fields, when it occurs, creates ideal habitat for migrating waterfowl. The property provides ideal feeding, resting, and nesting habitat for the American black duck, common and hooded merganser, blue- and green-winged teal, and the American woodcock. The Service plans to manage Tract 19b with an emphasis on promoting and enhancing habitat for nesting waterfowl, wading birds, and other high priority migratory birds, including warblers and the American woodcock.

The Commission approved the 2,000-acre refuge boundary addition, in fee and easement, and gave price approval for a 107-acre tract on September 13, 2006.

Detroit River International Wildlife Refuge
Wayne and Monroe Counties, Michigan

Detroit River International Wildlife Refuge (IWR) was authorized on December 21, 2001, by Public Law 107-91, the Detroit River International Wildlife Refuge Establishment Act, and expanded on May 19, 2003, by Public Law 108-23, the Ottawa National Wildlife Refuge Complex Expansion and Detroit River International Wildlife Refuge Expansion Act. It is the first international refuge in North America, and habitat for 29 species of waterfowl, 65 kinds of fish, and 300 species of migratory birds is conserved, protected, and restored on more than 5,000 acres along the lower Detroit River in Michigan and Canada.

The Commission approved the Detroit River IWR as a new refuge on June 25, 2003. The refuge includes islands, coastal wetlands, marshes, shoals and riverfront

lands along 44 miles of the lower Detroit River and western Lake Erie from Zug Island south to the Michigan/Ohio border. The refuge also includes Mud Island, Calf Island, and Grassy Island, lands formerly managed by the Service as Wyandotte National Wildlife Refuge. The 394-acre Wyandotte NWR was re-designated as part of the refuge.

Three million ducks (including canvasbacks, redheads, American black ducks, mallards, scaup, ring-necked ducks, mergansers, and buffleheads), geese, swans, and coots migrate annually through the Great Lakes region. Within the refuge boundary, over 300 species of birds have been documented in the Detroit-Windsor area, of which about 150 species breed in the immediate vicinity. This corridor has been recognized in the North American Waterfowl Management Plan as part of one of the Areas of Continental Significance

to North American Ducks, Geese, and Swans. Some 300,000 diving ducks stop in the Lower Detroit River on their fall migration from Canada to the east and south each year to rest and feed in beds of water celery.

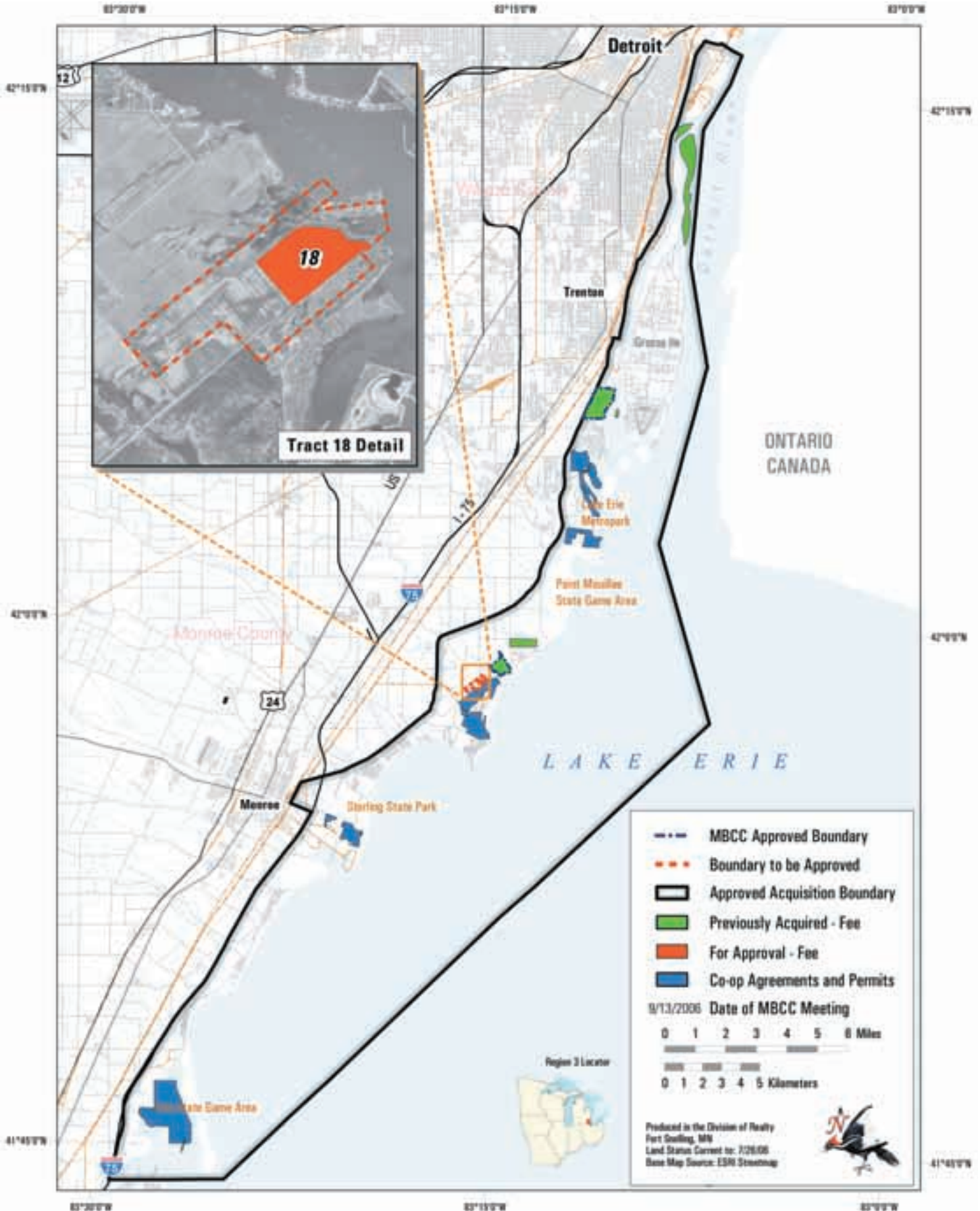
Tract 18 lies six miles northeast of Monroe, Michigan, along the southern shore of Swan Creek, and is close to the cities of Detroit (30 miles north) and Toledo (20 miles south) in Monroe County, Michigan. The topography of the land is nearly level; it lies in the 100 year flood plain. Tract 18 is an important property in the waterfowl migration corridor, and is important for its role as a migratory and nesting area for shorebirds, land birds, and raptors.

The Commission approved the 63-acre refuge boundary addition and gave price approval for this tract on September 13, 2006.

Lake Umbagog National Wildlife Refuge
Coos County, New Hampshire;
Oxford County, Maine

The Lake Umbagog National Wildlife Refuge project area includes diverse and extensive palustrine, lacustrine, and riverine wetland complexes recognized as some of the finest wildlife habitat in New Hampshire and Maine. “Umbagog,” pronounced “Um-BAY-gog,” is a Native American word which means clear water. The habitat and abundant wildlife found around Lake Umbagog have long been recognized as special and important by Anasagunticook Native Americans, who hunted, trapped, and traded around the lake and its rivers, and to European settlers, who brought farming and logging to the area. The glacial geology, northern climate, and the meandering and seasonally flooding Magalloway and Androscoggin Rivers have created a unique and richly diverse environment.

Located on the northern part of the New Hampshire/Maine border, about 1/3 of the project area includes wetland

habitat in Maine. Both states are setting aside additional lands to complement the protection of the Lake Umbagog watershed, and they have both listed Lake Umbagog as a priority site for acquisition under the Atlantic Coast Joint Venture of the North American Waterfowl Management Plan. The Emergency Wetlands Resources Act of 1986 also identified Lake Umbagog for protection. A portion of the project area has already been designated as the Floating Bog National Natural Landmark by the National Park Service.

The refuge consists of a large amount of forested wetlands important to waterfowl species, including the American black duck, whose populations are declining, and cavity nesting species such as the wood duck, common goldeneye, and hooded merganser. Wildlife values include waterfowl production and migration habitat, and the first bald eagle nest in New Hampshire since 1949 is located in the project area. Lake Umbagog is the most productive breeding site for the common loon in New Hampshire, and is recognized as one of the most important

breeding areas in the northeastern United States for its high nesting success.

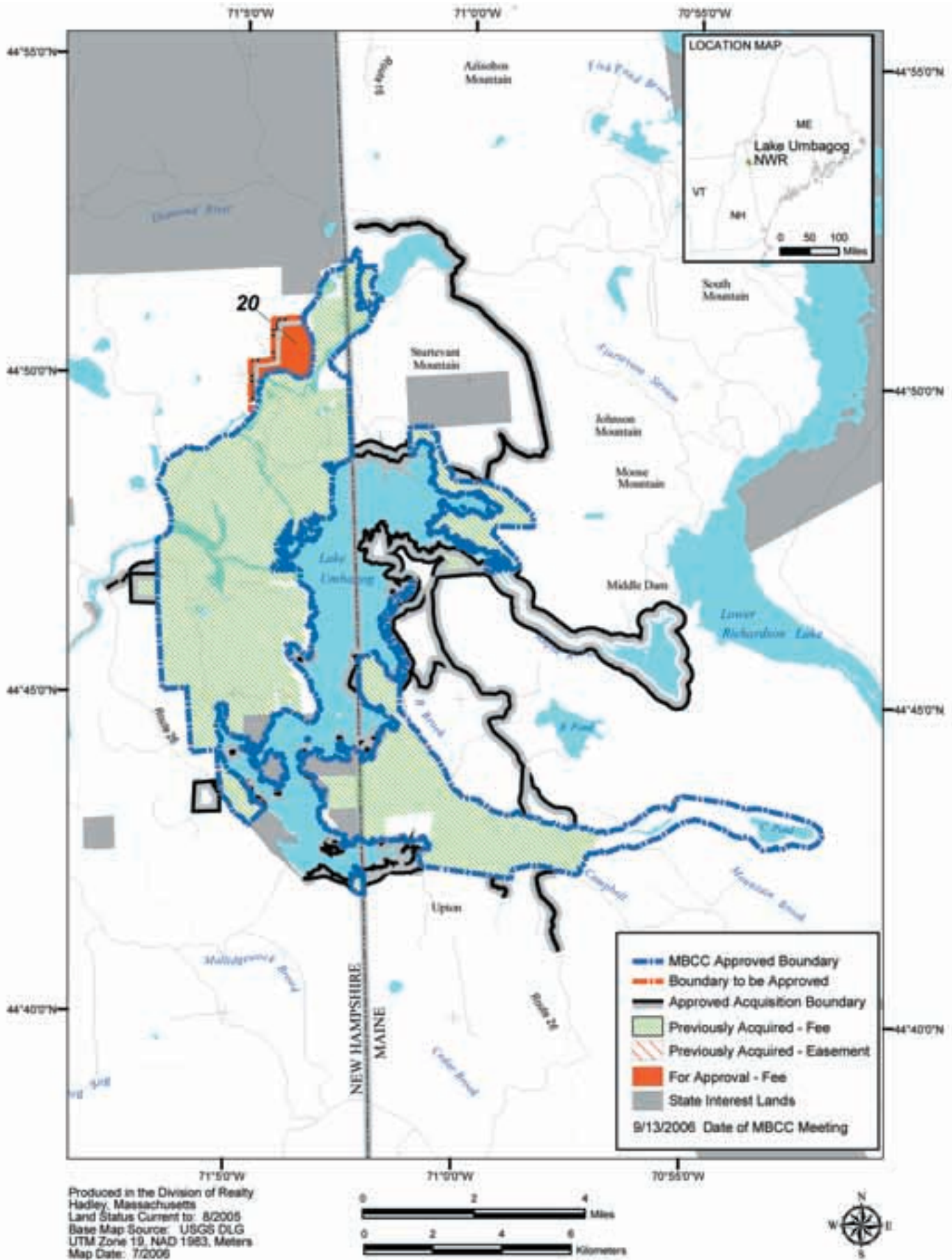
Tract 20 is located on the northwestern boundary of the refuge in the Magalloway River drainage. It has dispersed wetlands and mixed forest lands with a high conifer content, and provides excellent nesting habitat for the American black duck, hooded merganser, and common goldeneye. In addition, the property provides excellent habitat for the American woodcock, blackburnian warbler, and Cape May warbler. The Service plans to actively manage the property to enhance the values to migratory birds, including waterfowl, songbirds, and the American woodcock. In particular, the Service plans to re-water ditches that were drained by the previous owner, a timber company, and focus on manipulating the new growth from the selective cuts to help benefit migratory birds.

The Commission approved the 392-acre refuge boundary addition and gave price approval for this tract on September 13, 2006.

William L. Finley National Wildlife Refuge was approved by the Migratory Bird Conservation Commission on February 19, 1963, to provide wintering habitat for the dusky Canada goose and other waterfowl species in order to reduce crop damage on private lands. All of the land in the original boundary has been acquired. The Commission approved adding a new unit to the refuge, the Snag Boat Bend Unit, at its June 20, 2000, meeting. The Snag Boat Bend Unit includes 341 acres of land adjacent to the Willamette River in Linn County. The Service recently approved the addition of 42 acres to this Unit.

The refuge is located within the Pacific Flyway, and is a part of the Western Oregon Refuge Complex, located in the Willamette Valley of Western Oregon. The primary management goal of the Complex is to provide wintering habitat for the dusky Canada goose. Wintering waterfowl flocks start migrating north in March, and shorebirds migrate through in April. Thousands of geese, ducks, and swans graze on the refuge fields during the winter. During the summer months, waterfowl, including mallards, hooded mergansers, and wood ducks nest on the refuge.

The tract approved for acquisition was utilized for agricultural and recreational

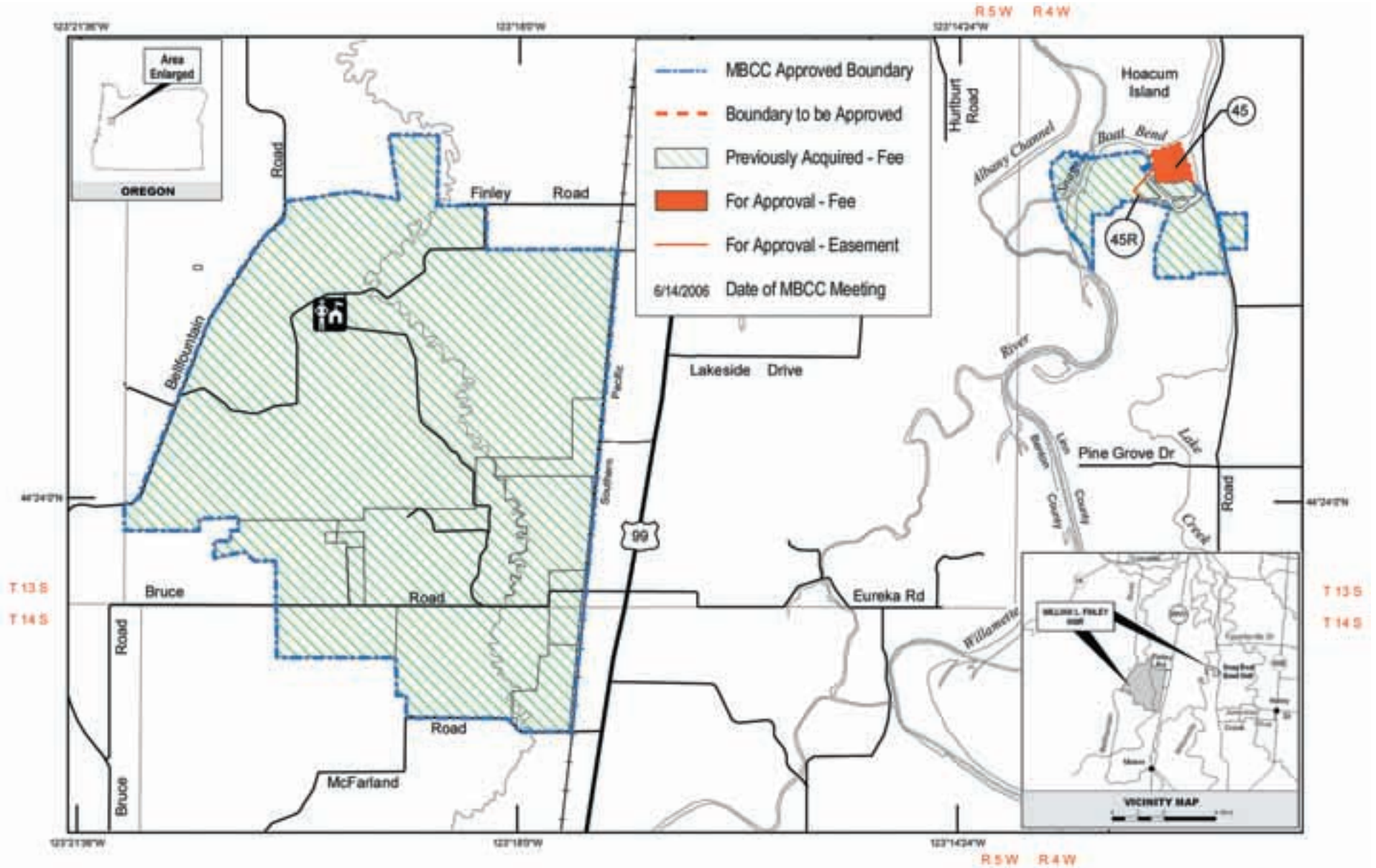
purposes, and a portion of it had previously been converted to wetlands as mitigation for a State Department of Transportation project. Improvements consist of two wells which will be used in the management of the refuge. This boundary expansion and price approval includes 36 of the 42 acres recently added to the Snag Boat Bend Unit. The remaining six acres may only be acquired if title issues concerning State ownership are resolved.

The Commission approved the 36-acre refuge boundary addition and gave price approval for this tract on June 14, 2006.

San Bernard National Wildlife Refuge was approved by the Migratory Bird Conservation Commission on February 27, 1968. To date, 39,590 acres have been acquired. In 1997, the Service approved the Austin's Woods Conservation Plan, authorizing the acquisition of up to 28,000 acres of satellite units to be added to the San Bernard NWR. To date, 11,917 acres have been acquired for the Austin's Woods Unit, by transfer from the Federal Deposit Insurance Corporation; by donations from various entities; with mitigation funds; with North American Wetlands Conservation Act grant funds;

and with Migratory Bird Conservation Act funds.

The Austin's Woods Unit is part of a productive and valuable wetland complex providing wintering, migration, and resident habitat for waterfowl, wading birds, neo-tropical migratory birds, and other wetland-dependent wildlife species. Thousands of waterfowl winter in the area. Mottled duck, a species of concern, use the area, as well as the green-winged teal, gadwall, and the black-bellied whistling-duck.

The tracts approved for acquisition have been used primarily for recreational photography and other wildlife-

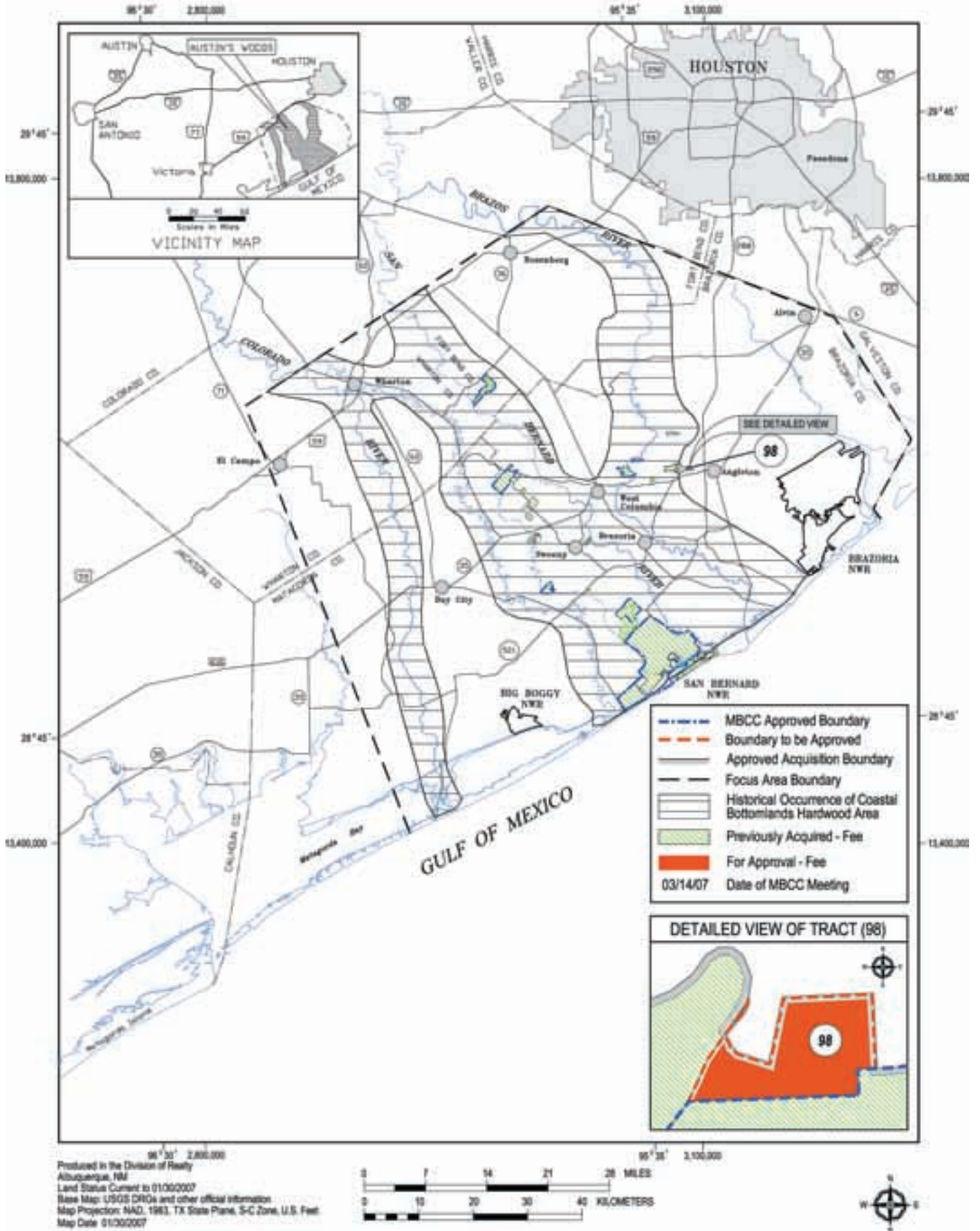
dependent recreation. The Service plans to administer them as part of the Austin's Woods Unit of the existing refuge. Management of the area will be directed toward habitat conservation and enhancement for waterfowl, wading birds, and other wildlife that depend on the gulf coastal zone. The tracts lie within the Mid-Coast Initiative of the Gulf Coast Joint Venture of the North American Waterfowl Management Plan, and support the objectives of the North American Waterfowl Management Plan.

The Commission approved the 2,132-acre refuge boundary addition and gave price approval for these tracts on March 8, 2006.

Trinity River National Wildlife Refuge
Liberty County, Texas

Trinity River National Wildlife Refuge was established on January 3, 1994, with the purchase of 4,400 acres of bottomland hardwood and associated wetland habitats in Liberty County, Texas. These lands were purchased with Land and Water Conservation Fund dollars. The Commission approved the initial 20,110-acre refuge boundary on June 14, 1994. Upon approval of the Lower Trinity River Floodplain Habitat Stewardship Program on March 4, 1999, the refuge boundary was expanded to 79,600 acres.

The Trinity River NWR protects remnant bottomland hardwood and associated wetland habitats for migrating, wintering, and breeding waterfowl. The refuge has been identified as a priority

project for the East Texas Bottomland Hardwood Initiative, a component of the Lower Mississippi Valley Joint Venture, and the North American Waterfowl Management Plan. It represents one of the few remaining high quality areas for waterfowl species in East Texas, and provides essential foraging and/or roosting habitat for the wood duck, mallard, gadwall, American wigeon, blue- and green-winged teal, lesser scaup, and mottled duck. mature cavity trees dispersed throughout the area provide important nesting habitat for wood ducks and the black-bellied whistling-ducks, and numerous colonial water bird rookeries are found in swamps throughout the project area.

Tract 61a lies within the 100-year floodplain of the Trinity River, and consists of 104 acres. The land has 800

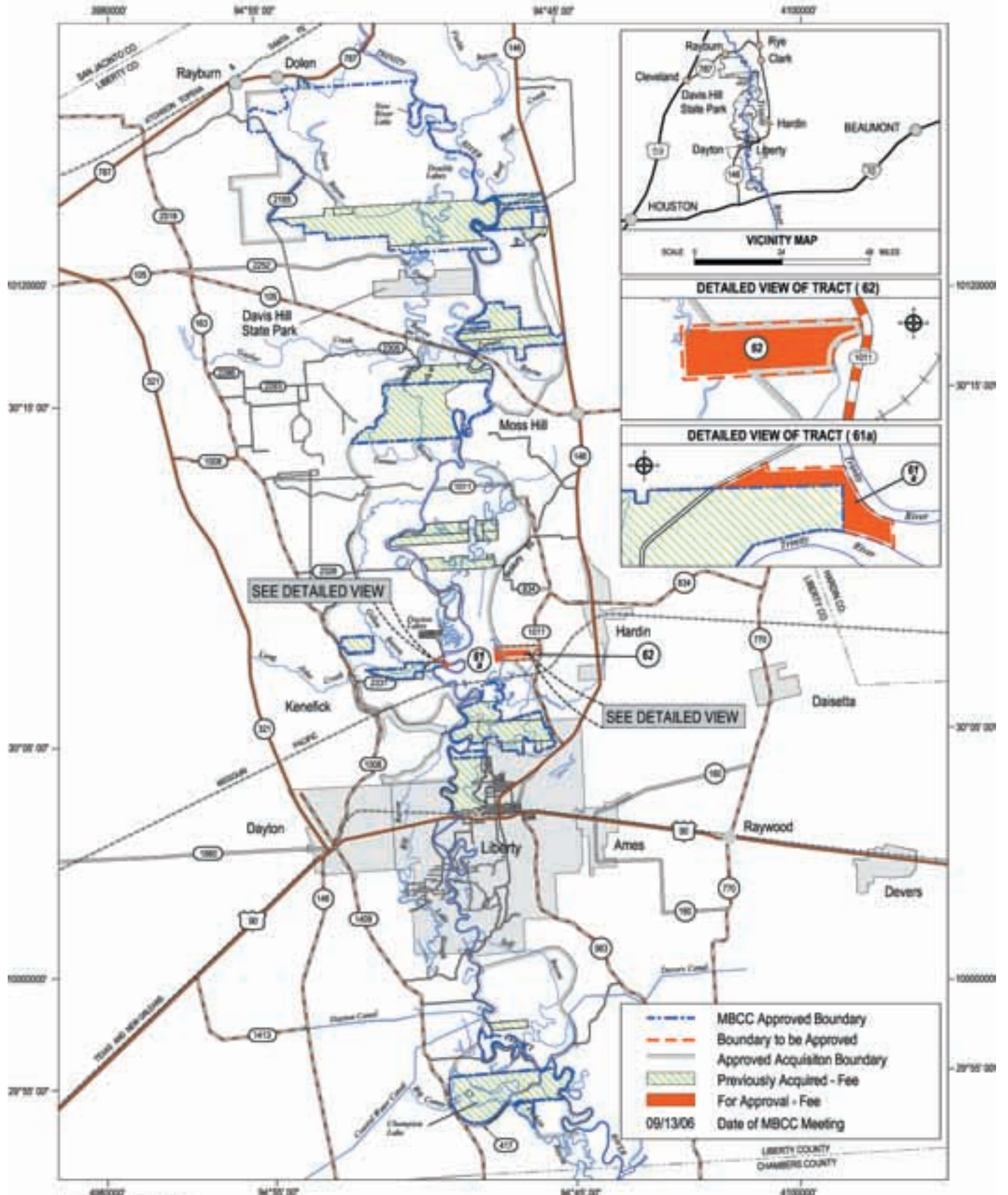
feet of frontage on the north side of Trinity River, and one fork of the Gillen Bayou cuts through the west end of the property. Tract 62 lies within the 100-year floodplain of Trinity River and consists of 366 acres. It is an unimproved property used for recreation. McMurtry Bayou crosses the central portion of the property, and Lake Bayou crosses near the western property line. The Service plans to manage both tracts as important waterfowl habitat within the Trinity River floodplain, and the acquisitions will assist in meeting the established habitat protection goals for the East Texas Bottomland Hardwood Initiative.

The Commission approved the 470-acre refuge boundary addition and gave price approval for these tracts on September 13, 2006.

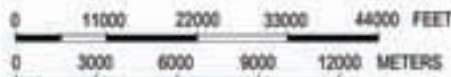


Trinity River National Wildlife Refuge

Missisquoi National Wildlife Refuge
Franklin County, Vermont

Missisquoi National Wildlife Refuge was established on February 4, 1943, with the purchase of 1,582 acres. At present, the refuge totals 6,560 acres, and is located in the vicinity of Swanton and Highgate, Vermont. The refuge includes most of the Missisquoi River delta where it enters Lake Champlain, and is composed mainly of woodland swamp, hayfields, brushy/shrubby early succession fields, and forests. The floodplain and marshes of the delta provide a major resting and feeding area for migratory waterfowl.

Through the years, the refuge has maintained and enhanced critical migration and nesting habitat for migratory waterfowl species. Over 15,000 snow geese use the refuge during the fall migration. Nesting species include the wood duck, mallard, American black duck, common goldeneye, and hooded merganser. Total waterfowl production usually exceeds 1,000 young, and is enhanced by an actively managed nest box program as well as maintenance of managed impoundments that provide excellent brood-rearing cover.

The previous landowners allowed the Service to flood the tract approved for acquisition, greatly enhancing the management of the adjacent refuge marsh; however, the current landowner did not allow the Service to flood the parcel. Consequently, this decreased water retention on refuge lands. By acquiring the tract, the Service's management capability will be greatly improved because the tract and adjacent refuge lands can be flooded as needed.

The Commission approved the 10-acre refuge boundary addition and gave price approval for this tract on March 8, 2006.

Legislation creating the Silvio O. Conte National Fish and Wildlife Refuge (NFWR) was signed by President Bush in 1991. The late Congressman Silvio O. Conte had introduced legislation to authorize a national fish and wildlife refuge within the Connecticut River watershed, and it was renamed the Silvio O. Conte National Fish and Wildlife Refuge Act. When the final Environmental Impact Statement (EIS) for Silvio O. Conte NFWR was completed, the Service's Regional Director signed a Record of Decision on December 13, 1995, authorizing a 91,500-acre complex within the 7.2 million-acre Connecticut River watershed. The Service identified sixty-five Special Focus Areas (SFAs) important for resource protection in Connecticut, Massachusetts, New Hampshire, and Vermont. The refuge was officially established on October 3, 1997, with the acquisition of the 3.8-acre Third Island, located in the Connecticut River in Deerfield, Massachusetts. The Nulhegan Basin Division was approved

by the Commission on June 23, 1999, and consists of approximately 26,912 acres, and is part of a 200,000-acre conservation partnership comprised of the State of Vermont, TNC, The Conservation Fund, and Essex Timber Company.

The Silvio O. Conte NFWR was established to protect, conserve, and enhance habitats and populations of native wildlife species, and to provide nesting habitat for the American black duck, wood duck, common and hooded merganser, blue- and green-winged teal, and Canada goose. Conservation and protection of the American black duck are specifically identified in the Silvio O. Conte National Fish and Wildlife Refuge Act. The refuge also provides nesting habitat for other migratory bird species, including the American woodcock. The EIS identifies SFA number 45 as the Nulhegan Basin focus area containing 71,900 acres. The 26,912-acre Nulhegan Basin Division is a portion of the 71,900-acre SFA, and consists of bogs, freshwater wetlands, and surrounding spruce fir and mixed hardwood forest. It provides nesting habitat for species including the American black duck, ring-necked duck, wood duck, hooded

merganser, and common loon. It also provides extensive contiguous forest for breeding migrant land birds. The North American Waterfowl Management Plan and Lower Great Lakes/St. Lawrence Joint Venture Plan identified key American black duck breeding habitat in this area of northern Vermont.

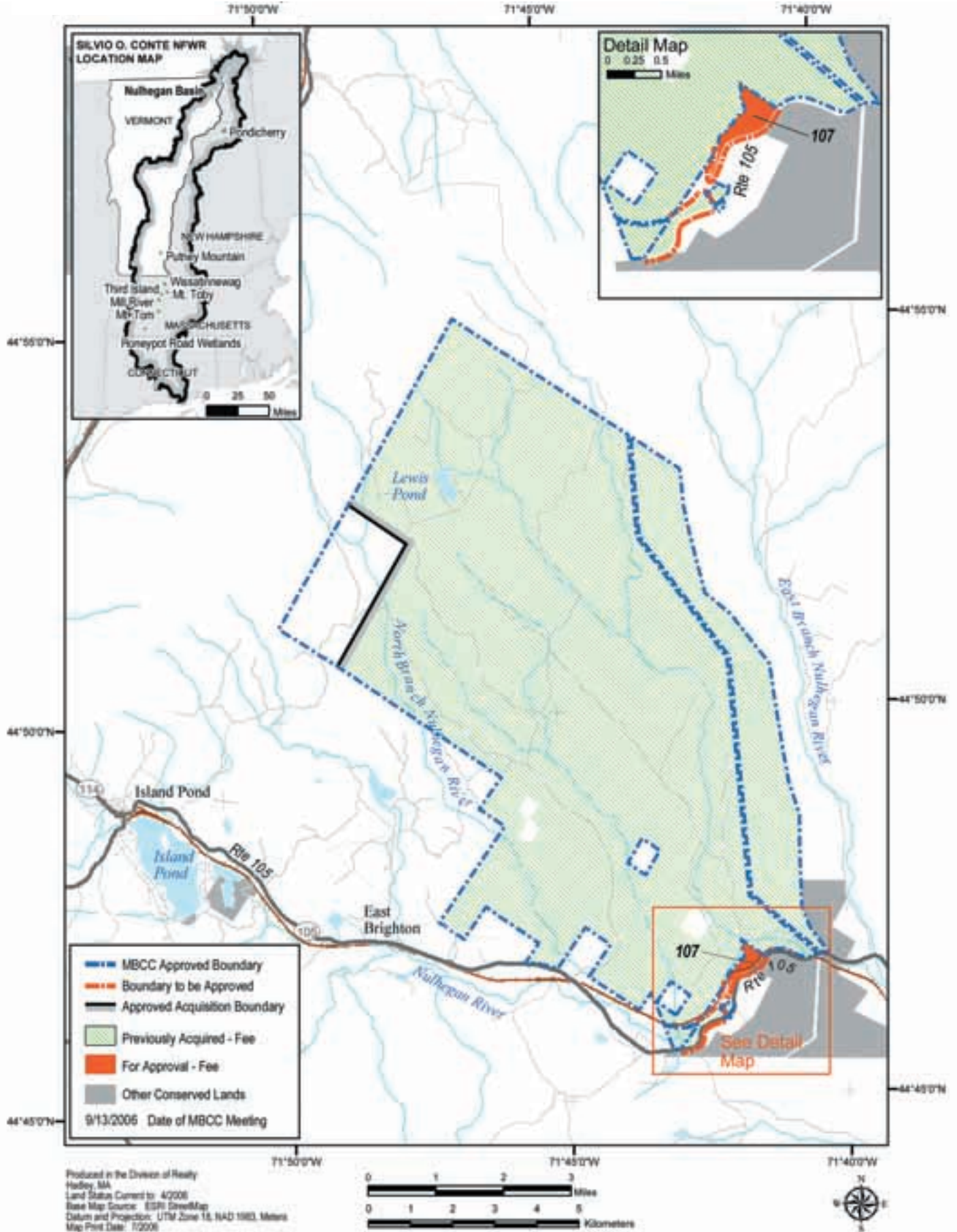
Tract 107 has long frontage along the south bank of the Nulhegan River, a small, slow-moving, and meandering river. The property consists of extensive marshland and a red pine plantation, and has been managed for wildlife values and commercial timber. The Service plans to manage the property with an emphasis on promoting and enhancing waterfowl values for the American black duck and other wetland-dependent migratory birds, and acquisition of the tract will protect the frontage along the main stem of the Nulhegan River and provide breeding habitat for black ducks.

The Commission approved the 120-acre refuge boundary addition and gave price approval for a 76-acre tract on September 13, 2006.

Eastern Shore of Virginia National Wildlife Refuge was established by the transfer of 174 acres from the Air Force to the Service on August 27, 1984. The refuge lies within the New England/Mid-Atlantic Coast Bird Conservation Region (BCR 30) and the Mid-Atlantic Coastal Plain Physiographic Area (Area 44). In 1979, the United Nations Educational, Scientific and Cultural Organization designated the Virginia Coast as a Biosphere Reserve. Lands added with assistance from TNC included 369 acres in 1986, and the 108-acre Skidmore Island in 1987. In 2001, the Service added a 260-acre tract with funding approved by the Migratory Bird Conservation Commission. This addition was augmented by 116 marsh acres, in a transaction facilitated by TNC.

Because of its unique geographic location at the Southern Tip of the Delmarva Peninsula, the Eastern Shore

of Virginia NWR provides a critical link for waterfowl in the Atlantic Flyway. It provides critical migratory stopover habitat for five high-priority and six priority duck species, as designated by the North American Waterfowl Management Plan. These species are the northern pintail, American black duck, mallard, lesser scaup, greater scaup, Atlantic brant, wood duck, redhead, canvasback, ring-necked duck, and American wigeon.

To meet the goals established in the refuge's 2004 Comprehensive Conservation Plan (CCP), particularly the goal of permanent protection and stewardship of habitat by public agencies, several conservation interests organized to establish the Southern Tip Cooperative Conservation Initiative. The 147-acre tract approved for acquisition, which was identified as a priority in the CCP, is comprised of wetlands, the bulk of which are declining wetland types. The acquisition of this key tract will augment the Commonwealth of Virginia's oceanside holdings at this location.

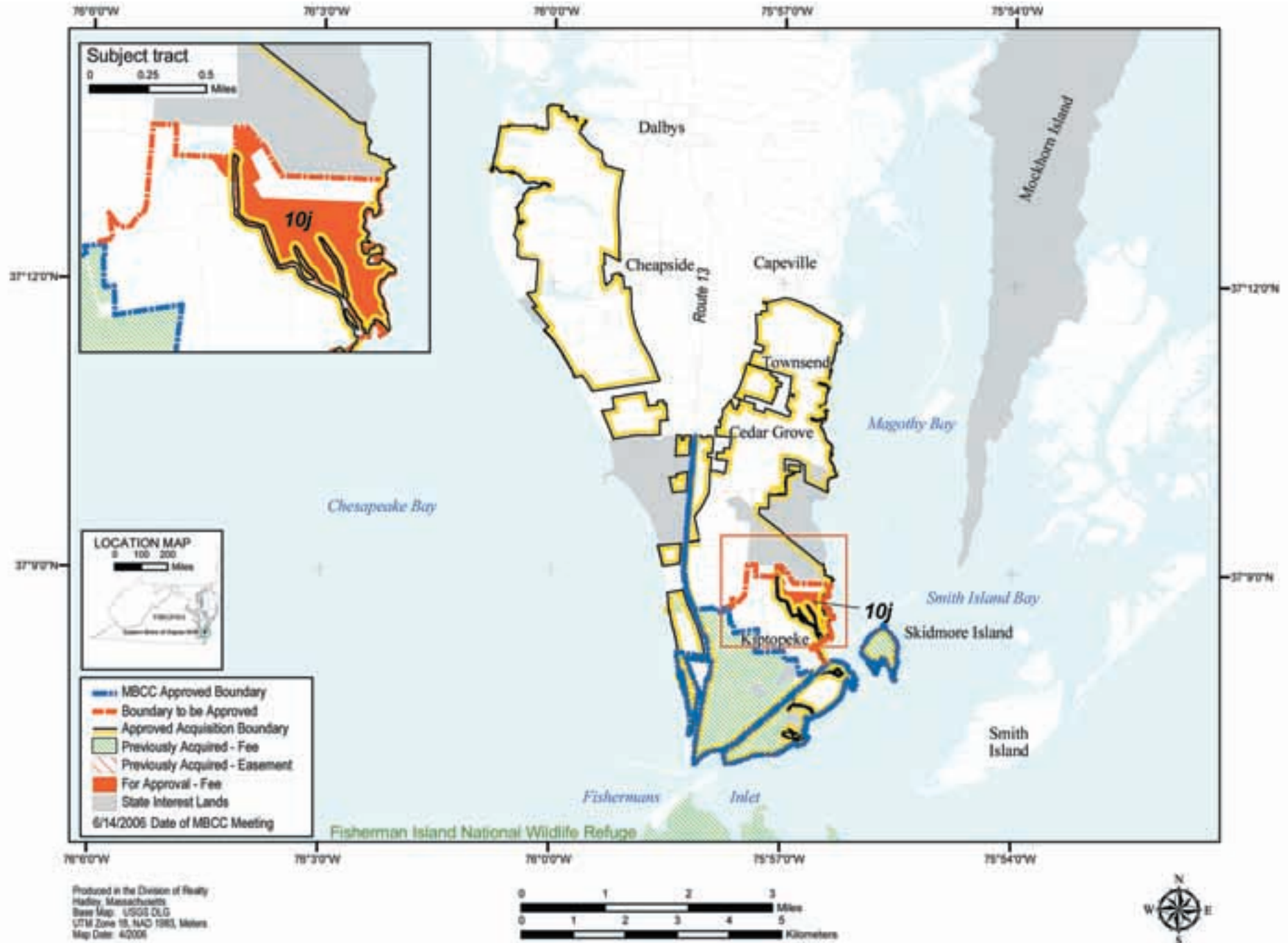
The Commission also gave boundary addition approval for a 380-acre tract between the subject property and the refuge, and TNC currently holds a first right of refusal on the property. Also included in the boundary addition approval were 63 acres of upland and freshwater wetlands that were contemporaneously conveyed by TNC to the Service, using \$1,000,000 from a North American Wetlands Conservation Act grant and \$230,630 of Land and Water Conservation Funds. These properties will contribute significantly to the block of public lands at the Southern Tip (which also includes the 1,896 acre Fisherman's Island NWR) that will provide a total of 4,535 acres of contiguous critical stopover, resting, and feeding opportunities for migratory birds en route between their breeding and wintering habitats.

The Commission approved the 590-acre refuge boundary addition and gave price approval for a 147-acre tract on June 14, 2006.

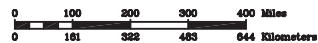


National Migratory Bird Refuge Areas

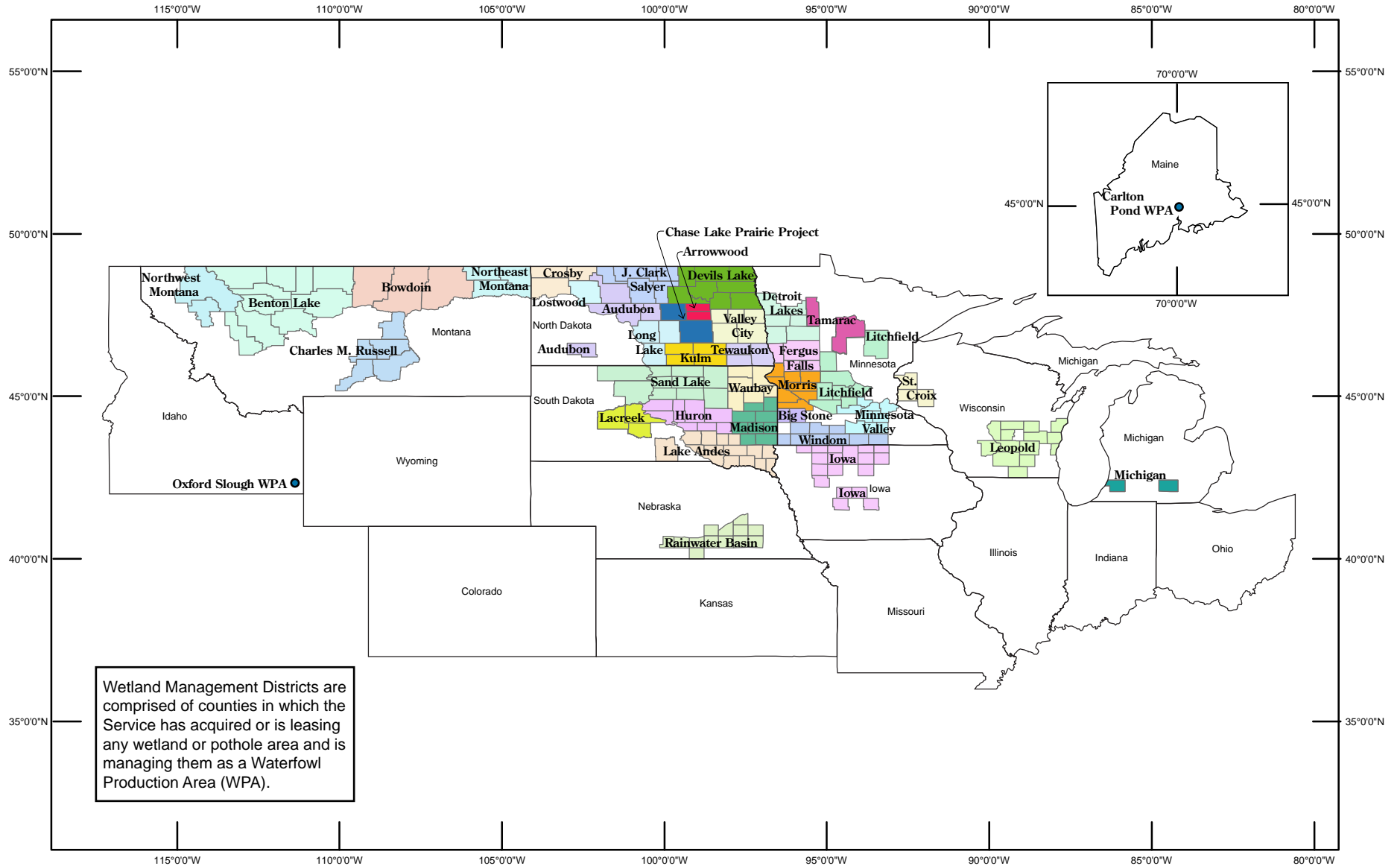

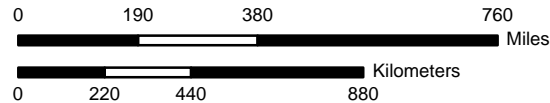

The information contained in this report includes those acquisitions and dispositions of land and interests therein that are purchased with Migratory Bird Conservation Fund monies or acquired under the authority of the Migratory Bird Conservation Act. It also includes other migratory bird areas such as those that are transferred to the Fish and Wildlife Service under the authority of Public Law 80-537 to carry out a migratory bird management program (these will appear on Table One).

In an ongoing effort to improve data quality, the figures in Tables One and Two may show minor changes from previous annual reports. Lands in which the Service previously acquired a less-than-fee interest (leases and easements) may be purchased in fee during the year, and

the number of easement or lease acres will show a decrease and the number of purchased acres will show an increase. The acreage appearing in the Approvals and Summary of Land Acquisitions sections of this report will not appear in Tables One or Two until after the tracts are acquired and the funds are actually expended. Also, a newly approved refuge will not appear on Table One until a tract is acquired.

North American Wetlands Conservation Fund - Migratory Bird Conservation Commission Approvals for Fiscal Year 2006 (Summary)

The Migratory Bird Conservation Commission approved 84 standard wetlands conservation project proposals for funding in Fiscal Year 2006 under the North American Wetlands Conservation Act. A total of \$66,717,373 from the North American Wetlands Conservation Fund (Fund), together with \$200,206,002 in partner funds, are supporting 46 projects in the United States, 22 in Canada, and 16 in Mexico. The following tables provide summary and detailed allocation information.
