New Service Grants Encourage Wildlife Conservation in Latin America and the Caribbean

The U.S. Fish & Wildlife Service today announced it is awarding more than \$1,000,000 in 51 grants for wildlife conservation programs in 21 countries throughout Latin America and the Caribbean. These grants, awarded through the Service's *Wildlife Without Borders* program, will be matched by an additional \$4,000,000 from partnership organizations, generating a total of \$5,405,000 for conservation.

"Many wildlife species we see in our own backyards at certain times of the year, are also enjoyed by people in other countries in our shared hemisphere at other times," said Service Director Steve Williams. "These grants provide the seed money to encourage the growth of the on-the ground conservation cooperation for the benefit of migratory wildlife and border species."

Conservation projects funded this year vary from species specific efforts aimed at helping imperiled wildlife such as sea turtles, pronghorn antelope, tapirs and monarch butterflies, to broader capacity building initiatives such as the creation of in-country university courses designed to train local people in managing and conserving wildlife. Grant recipients include U.S. and foreign-based conservation groups, academic institutions and foreign government wildlife agencies.

"The wide range of applicants this past year reflects a growing awareness of the need to conserve wildlife globally," said Kenneth Stansell, the Service's Assistant Director for International Affairs. "Many applicants are using a variety of creative solutions to address threats such as habitat loss to biodiversity in the Western Hemisphere."

"Collaborations between the U.S., foreign governments, and not-for-profit organizations are key to saving endangered wildlife." Says grant recipient Barbara Bramble, Director of National Wildlife Federation's Partnership for Wildlife Program. "Initiatives such as the *Wildlife Without Borders* grant programs make important conservation partnerships possible."

The U.S. Fish and Wildlife Service is the principal Federal agency responsible for conserving, protecting and enhancing fish, wildlife and plants and their habitats for the continuing benefit of the American people. The Service manages the 95-million-acre National Wildlife Refuge System, which encompasses 544 national wildlife refuges, thousands of small wetlands and other special management areas. It also operates 69 national fish hatcheries, 64 fishery resources offices and 81 ecological services field stations. The agency enforces federal wildlife laws, administers the Endangered Species

Act, manages migratory bird populations, restores nationally significant fisheries, conserves and restores wildlife habitat such as wetlands, and helps foreign and Native American tribal governments with their conservation efforts. It also oversees the Federal Assistance program, which distributes hundreds of millions of dollars in excise taxes on fishing and hunting equipment to state fish and wildlife agencies.
