

#### 1. General Situation

- 1.1. A powerful 7.2-magnitude earthquake struck eastern Turkey on Sunday (23 October 2011). Seismic activity has remained on going ever since.
- 1.2. A subsequent series of larger earthquakes has hit the area of Van (Erdemit), on the evening of 9 November. UN OCHA reports that the first quake took place at 19:23 UTC at 5.6 magnitude and seven minutes later another tremor with a magnitude of 4.5 hit Van. The US Geological Survey locates the epicenter at 16km (10 miles) south of Van.
- 1.3. Schools remained closed until 14 November and the Van University will be closed until January 2012. Media reports indicate that 74 teachers lost their lives in the earthquake. The Ministry of Education of Turkey has assigned 800 new teachers to the area to avoid any setback in the education system in the region.
- 1.4. Additionally, the International Organization for Migration (IOM) will ensure that 2.500 people receive blankets and other supplies to protect against extreme winter conditions. The World Health Organization (WHO) expects to support the delivery of urgent psychiatric services and emergency life-saving traumatic care. UN Children's Fund (UNICEF) aims to help up to 1.680 children resume the education in a safe learning environment.
- 1.5. As a result of quakes 6 villages Dağönü, Güveçli, Alaköy, Dibekdüzü, Gedikbulak and Mollakasim have been almost destroyed. Five tent cities and two Mevlana type house cities have been established and the Turkish Red Crescent





Society (TRCS) has dispatched 27.496 tents as well as blankets, sleeping bags and heaters. As of 3 November, TRCS has provided shelter for 137.514 beneficiaries.

- 1.6. According to the Turkish Disaster and Emergency Management Presidency the death toll resulting from the quakes between the period of 23 October 11 November has reached 644 people and the number of injured has reached over 4.200 and the number of alive people have been rescued by crews from the rubble is 255.

- 3. The Government of Croatia offers 50 tents as humanitarian assistance to Turkey. The offer has been accepted by Turkey. Transportation of the tents will be organized through the Turkish branch of FEDEX.

- 6. Total financial assistance to Turkey:
  - 6.1. The UN-OCHA Central Emergency Response Fund (CERF) has allocated US\$ 3.4 million to provide shelter, education as well as mental health and psychological support to thousands of people affected by the recent earthquake in Turkey. With

the CERF funding, UNHCR will work with the Turkish Red Crescent Agency, and the Disaster and Emergency management Agency of the Prime Minister to provide shelter for 20.000 people.

6.2. Totally 211. 600 million TL (appr. €100 million) have been collected since the first earthquake, including international financial support.

### 7. Points of Entry / Delivery:

Donated materials are to be transported by land to an "Assistance Delivery Centre", which is being set up in Van and a second one in Erzurum Airport for air transportation. It is important that assistance is delivered directly to these centres. Assisting countries should apply to the Ministry of Foreign Affairs of Turkey.
