## **BNL Unveils Guest Information System**

Over the past two years, Brookhaven has developed a Laboratory-wide Human Resources database. When complete, the database will include all guests, contractors, and employees. On January 8th, the Guest Information System (GIS) portion of this database will officially become available for use by off-site guests.

The GIS has a web front-end that will enable guests to pre-register before arriving at Brookhaven. This will simplify the procedures for processing guest appointments for Brookhaven and simplify the check-in process for guests when they arrive at Brookhaven. The database also has a feature that will generate IA-473s for foreign nationals, which will make life easier for all concerned.

All guests coming to Brookhaven for their first visit should go to the following web site and register as soon as they know they will be visiting Brookhaven. First-time guests of the Laboratory, individuals who do not hold a BNL ID card, must also notify BNL of their arrival date. The Users' Center has put an Arrival Notification Form on the web, <http://www.phy.bnl.gov/users/usersCenter/arrivalForm.html> to make this easier for guests of the RHIC & AGS facilities. We request that notifications be made 48 hours prior to your arrival at Brookhaven.

## **Guidebook for Guests**

Guidebook for Guests Conducting Research. This BNL Guidebook was developed to familiarize individuals coming to Brookhaven to conduct research at a research department, user facility, or research center. A PDF version is available at <https://sbms.bnl.gov/standard/13/1306e011.htm>

The Guidebook provides information on issues that Guests should address before arrival, upon arrival, and when leaving Brookhaven. Environmental, health and safety issues are addressed throughout the Guide, and facility-specific contact personnel are referenced throughout and listed in an appendix.

There is a lot of useful and helpful information contained in the Guidebook and guests are encouraged to read it before coming to Brookhaven. Users should take note of the following:

● Although identification has always been required to obtain a BNL ID card, the types of identification that are acceptable have been defined in the Guidebook. US citizens are asked to bring one of the following: a driver's license, a pictured government ID card, a passport, or a social security card. Foreign nationals are asked to bring their passports and visas.

● Guests will be asked to sign a Commitments and Expectations Statement each time they are issued an ID card. This statement is a simple one-page document that outlines what a guest can expect from Brookhaven and what Brookhaven expects of its guests. ## ***Housing Upgrades***

- For those who may not have already heard, the dormitories now have Ethernet capability. Ethernet connections in the apartments are scheduled to be available in 2001.
- VCRs are available from the Housing Office for three-day use by guests of Brookhaven. Machines are available on a first-come, first-serve basis.
- Battelle Memorial Institute and SUNY @ Stony Brook provided funding for the installation of TV satellite receivers for the apartments, Guest House, each of the four dormitories, the Recreation Building, and the Brookhaven Center. They also purchased five large-screen TVs that now reside in the Brookhaven Center and the lobbies of the dormitories.
- On-site dairy delivery is now available in the apartment area. Guests can order milk, eggs, butter, cheese, yogurt, juice, soda, breads and muffins and have it delivered to their apartments, on Mondays and Thursdays. Details are available from Housing or the Users' Center.

Brookhaven's Staff Services Division, which administers Brookhaven's on-site housing, now has an on-line reservation request form. One of the first changes was to severely restrict the use of clear text passwords protocols, such as telnet and ftp. ## **Training**

Collider-Accelerator Users' Training is now being held on Mondays at 1:00 p.m. in Building 911. This enables adequate time to complete check-in at the Users' Center, as well as, provide time for the Users to check-in with the experimental offices and get their Job Training Assessment completed prior to attending the Collider-Accelerator Users' Training.

AGS Special Users' Training is now called AGS Fixed-Target Training. This training course now provides equivalency for ODH (0), Stop Work, Emergency Planning, High Radiation Module, ET, and reciprocity for DOE-trained Radiation Worker I. It is scheduled on an as-needed basis.
