**Overview of Requirements**

President Bush, with strong backing from Congress and the American people, is steadfastly committed to combating terrorism worldwide. Supporting the active and reserve forces engaged in stabilizing the Middle East region and “winning the peace” in Iraq and Afghanistan is an investment in democracy. To sustain the level of support necessary to continue our operations in Iraq and Afghanistan, the Department of Defense (DoD) requires an additional \$65.6 billion in fiscal year (FY) 2004. The Department requests that the Congress provide these additional resources as emergency, non-offset supplemental appropriations. This request will finance the incremental costs above the Department’s peacetime budget that will be incurred for three ongoing and evolving military operations: OPERATION IRAQI FREEDOM (Iraq), OPERATION ENDURING FREEDOM (primarily Afghanistan), and OPERATION NOBLE EAGLE (defend the homeland). Expedient approval of this emergency supplemental request is essential for U.S. military forces to maintain the safety and security of our Nation.

Since the terrorist attacks on the United States on September 11, 2001, the Department has fully engaged the enemy and sustained a vigilant posture to combat terrorism worldwide. Operational intensity remains high. In April 2003, in addition to operations in Afghanistan and other areas around the world, the United States led a coalition of forces into action in Iraq and secured the end of the Baathist regime within a short period of time. Immediately following the major combat phase of military operations in Iraq, the President signaled the beginning of concentrated efforts with U.S. international partners to stabilize the environment within Iraq, reestablish civil order, and ensure security of the Iraqi people.

This \$65.6 billion supplemental request includes the following emergency funding requirements to continue to conduct military operations on the ground in Iraq, Afghanistan, and other areas around the world.

\* The Supplemental requirements are partially offset by funding available in the Iraq Freedom Fund (IFF), part of the FY 2003 Emergency Wartime Supplemental Appropriations Act (P.L. 108-11). Approximately \$0.7 billion in IFF resources will be used to provide Small Arms Protective Inserts (body armor plates) for deployed troops, finance the destruction of munitions caches discovered in Iraq, and provide family support counseling for families of U.S. forces deployed to Iraq and Afghanistan.

\* Includes military pay and operation support costs for Reserve and National Guard members, who are called to active duty on a full-time basis to backfill for those Active personnel deployed overseas in support of OIF (\$0.6 billion) and OEF (\$0.5 billion) and therefore are accounted for in those operations.

**I. OPERATION IRAQI FREEDOM (OIF):** The FY 2004 emergency supplemental request includes \$51.5 billion to accomplish military objectives of OIF. The objectives include conducting stability and support operations throughout Iraq; capturing Hussein regime loyalists; and stopping terrorist activities.

Currently, there are five U.S. military divisions and two multinational divisions led by the British and the Polish forces in Iraq. For FY 2004, the Department anticipates that more countries will commit troops to the stabilization effort to include the deployment of two additional multinational Divisions of ground troops. These multinational Divisions will sustain a level of effort in FY 2004 comparable to that in FY 2003. Securing additional military support in Iraq from coalition partners will emphasize the international commitment to a free Iraq, maintain security in that nation, and reduce the burden on U.S. military forces.

**II. OPERATION ENDURING FREEDOM (OEF):** The FY 2004 emergency supplemental request includes \$10.5 billion to support continuing U.S. efforts to track down terrorists and provide stability, primarily in Afghanistan. The military objectives of OEF include destroying terrorist training camps and infrastructure, capturing Al Qaeda leaders, stopping terrorist activities, and preventing the re-emergence of international terrorist organizations. For example, in Afghanistan, the U.S. objectives include destroying the Al Qaeda organization, training the Afghan National Army, conducting civil-military operations, and providing other support for the emerging government of Afghanistan. In Cuba, the United States is holding detainees at Guantanamo Bay (GTMO) in order to obtain tactical intelligence on current and future terrorist operations, remove Al Qaeda/Taliban terrorist from the battlefield, and facilitate prosecution of those who have committed crimes.

**III. OPERATION NOBLE EAGLE (ONE):** The FY 2004 emergency supplemental request includes \$2.2 billion to support continuing efforts to defend the United States from airborne attacks, maintain U.S. air sovereignty, and defend top-priority U.S. facilities from a potentially hostile threat. In addition, the supplemental funding will finance quick-reaction ground forces and transport aircraft on ground alert to respond to national emergencies.

**IV. COALITION SUPPORT:** The FY 2004 emergency supplemental request includes \$1.4 billion to reimburse coalition countries for logistical and military support provided to the U.S. military in connection with military operations in Iraq and Afghanistan. The U.S. support for coalition partners helps to ensure that their contributions yield the maximum benefit to the overall operations of U.S. forces fighting terrorism worldwide.

**Detailed Requirements**

The Department is requesting \$65.6 billion in this emergency supplemental request to respond to the demands of ongoing military operations in Iraq and Afghanistan, while carrying on its daily operations around the globe, and to fund other critical requirements. This request will fund the incremental costs above the peacetime budget that are necessary to sustain the Department's commitment of time and resources to combat terrorism worldwide. The summary displays the supplemental request in six major cost categories:

**I. Military Operations:** \$53.3 billion is required to support continuing military operations in Iraq and Afghanistan and in the United States to protect the homeland.

This supplemental funding is critical for stabilization and security operations within Iraq. The U.S. forces must continue to disarm terrorists, whose aim is to disrupt the peaceful rebuilding of Iraq, and to provide the stability needed to establish a new Iraqi-led government. The funds provided by this emergency supplemental request will also support continued military operations in other areas of interest, such as Afghanistan, where a significant effort is needed to destroy the terrorist cadre and support an emerging democracy. The \$53.3 billion supplemental requirement includes:

- \$22.2 billion for personnel and personnel support costs, including reserve mobilization and health care costs for Reserve and National Guard personnel who are on active duty supporting military operations on a full-time basis; and
- \$31.1 billion to conduct ongoing military operations to include financing flying hours, ship steaming days, ground operations, special airlift missions, increased associated ship and aircraft maintenance, logistics support, fuel purchases, base support, and other Operation and Maintenance (O&M) requirements.

**II. Depot Maintenance:** \$2.8 billion is required to finance critical depot maintenance for weapons and weapon system platforms requiring service after the wear and tear of combat operations. The harsh desert environment and punishing conditions of war cause significantly more damage and corrosion to equipment than the usual peacetime, training activities. In general, equipment used in OIF and OEF will require a more intensive overhaul and repair cycle than the typical maintenance program. Restoring equipment to mission-capable status is an important element of readiness.

The uncertainties in the international political environment, combined with the known challenges that the United States faces in its continued pursuit of terrorists, drives the Department to seek rapid force reconstitution as a high priority. The Department must ensure that U.S. forces have the sufficient deterrent and “swiftly defeat” warfighting capabilities to support future operations and for the transformation of our military forces. A prudent investment in depot maintenance helps meet that readiness objective.

**III. Procurement and RDT&E:** \$5.6 billion is required for procurement of critical equipment and for RDT&E, including some classified programs, in support of OIF and OEF. The bulk of the equipment to be procured in support of military requirements for logistics support, spare parts, theater communications, equipment for the deploying Reserve Component units, and replacements for basic soldier gear such as night vision goggles. It also includes the needed funding for U.S. Special Operations Command (USSOCOM) forces, including ammunition, intelligence support equipment, aircraft modifications, and targeting/tracking equipment. This emergency supplemental also includes a request for funds to procure 747 additional Up-Armored High Mobility Multi-purpose Wheeled Vehicles (HMMWVs). These vehicles are essential in providing improved ballistic protection against small arms fire to forces in theater.

**IV. Military Construction:** \$0.4 billion is required for construction of military facilities in host nation countries in support of OIF and OEF, such as constructing water and wastewater treatment facilities to support base camps for troops in Iraq; repairing an airfield runway and aircraft ramps; and constructing a new aerial port facility.

**V. Defense Working Capital Funds:** \$0.6 billion is required to purchase fuel at increased market prices.

**VI. Other Activities:** \$2.8 billion is required for various other related activities in support of OIF and OEF:

- \$1.9 billion for coalition support to key cooperating nations; lift and sustainment of one multinational division; and reimbursement of funds for drawdown used under the Afghan Freedom Support Act of 2002. There is also flexibility to pay for the lift and sustainment of a second multinational division if it occurs.
- \$0.9 billion for administrative and operating costs for the Coalition Provisional Authority (CPA); and for classified programs (Intelligence Community Management Account).

**CHAPTER 1: MILITARY OPERATIONS  
Detailed Justification**

While the major combat phase of Operation Iraqi Freedom (OIF) is over, the Department must continue its security stabilization efforts in Iraq. These deployments are in addition to the usual daily military operations around the globe. Ongoing military operations (i.e., OIF, OEF, and ONE) will require U.S. presence next year in Iraq, Afghanistan, and other areas around the world. To support these U.S. worldwide commitments, a substantial number of Guard and Reserve personnel will remain mobilized during FY 2004. Without additional funds in FY 2004, the Services would have to divert funds from their readiness and investment accounts to finance the continuing costs of operations. This diversion of funds would seriously degrade the combat readiness of U.S. forces and would weaken the nation's ability to react to future threats. Therefore, \$53.3 billion of the \$65.6 billion emergency supplemental request is required for the following military operation requirements:

**I. PERSONNEL AND PERSONNEL SUPPORT**

This supplemental request includes \$22.2 billion (\$18.6 billion for military personnel and \$3.6 billion for civilian personnel and personnel support costs) to provide the required resources for the military and civilian personnel supporting major military operations (i.e., OIF, OEF, and ONE). The estimate for military and civilian personnel includes incremental pay, special pay, and entitlements above the normal monthly personnel compensation costs for military and civilian personnel participating in or directly supporting ongoing military operations. It also includes the costs to pay military personnel affected by military stop loss programs and additional military personnel maintained on active duty above the normal end strength levels to sustain the readiness levels of deploying units. The \$22.2 billion request includes the following requirements for personnel and personnel support:

In response to the terrorist attacks on the United States on September 11, 2001, the President invoked his authority (10 U.S.C 12302) to order to active duty Ready Reserve members and delegated his authority to the Secretary of Defense in Proclamation 7463 of September 14, 2001. This declaration of national emergency has been revalidated a second time, thereby, extending the authority to order to active duty Ready Reserve members. In FY 2004, the anticipated force structure in Iraq is expected to

decrease from five U.S. active Army divisions to two-plus U.S. active Army divisions, indicating a decline in active military personnel and the associated military personnel pay costs required to sustain them in theater. Three to four multi-national divisions (MNDs) are presently factored into the force plan, two currently in place and one to two expected to arrive in FY 2004. However, there is uncertainty as to whether these latter MNDs will be in place by the end of FY 2004. Therefore, our supplemental budget request recognizes this potential and prudently funds four Reserve Enhanced Separate Brigades (ESBs) (~17,500 endstrength). Should multinational replacements not occur, resources will be available to train, equip, and field U.S. (i.e., ESBs) replacements in a timely manner. The supplemental request finances the full incremental pay, special pay, and entitlements above the normal monthly personnel compensation costs for these Reserve and National Guard members, offsetting any funding decreases realized from the decline in the active force.

The force structure plan calls for an average of 113,000 active military personnel to sustain the National Security Strategy performing combat and stabilization operations. An estimated additional 192,000 average strength Reserve and National Guard personnel will be required. These members provide critical support in the areas of security and force protection, infantry, special operations, transportation, chemical and biological, intelligence, civil affairs, combat air patrols, communications, strategic and tactical airlift, air refueling operations, and aero-medical staging capabilities.

In order to sustain current operations, additional funding is required immediately to provide pay, allowances, subsistence, and other personnel costs for Reserve and Active Component personnel activated for duty in support of OIF, OEF (including the Horn of Africa), and ONE.

The estimate also includes funding for enhanced special pays, including Imminent Danger pay (IDP), Family Separation Allowance (FSA), and Hardship Duty Pay (HDP) for OIF and OEF deployed personnel in theater or in direct operational support. The FY 2003 Emergency Wartime Supplemental Appropriations Act (P.L. 108-11) increased IDP temporarily by \$75 per person per month (from \$150 to \$225 per month) and FSA by \$150 per month (from \$100 to \$250 per month), effective from October 1, 2002 through September 30, 2003. The Department intends to continue paying IDP and FSA at these increased rates through December 31, 2003. Beginning on January 1, 2004, the Department's plan is to begin paying an additional \$225 per month in HDP to military personnel serving in OIF/OEF in a combat zone. This would maintain the same level of special pay as IDP and FSA, via increased rates HDP. Further, it would increase the special pay amount for members without dependents, who are serving in those same combat zone locations, by \$150 (these latter members received a \$75 increase in special pay only via IDP) as a result of P.L 108-11, whereby married members serving alongside them had received a total increase of \$225 (an additional \$75 in IDP and an additional \$150 in FSA). The same increase in special pays should be normalized for *all* troops in combat, regardless of marital or dependency status. The additional \$225 per month being paid to members in combat should be in recognition of the risk that they all face -- not drawing any distinctions as to their marital status or number of family dependents.

The Military Personnel request is comprised of the following costs:

- Imminent danger pay, family separation allowance, hardship duty-location pay, subsistence, and other military personnel requirements for active personnel participating in or directly supporting OIF, OEF, and ONE (\$3.6 billion).
- Basic military pay, special pay, and entitlements for Reserve and National Guard members called to active duty on a full-time basis to provide essential military operation support or backfill for those active personnel deployed overseas in support of OIF, OEF, and ONE (\$12.5 billion).
- Personnel-related costs for additional military personnel maintained on active duty above the normal strength levels and affected by military stop loss programs to sustain the readiness levels of deploying units (\$2.5 billion).

Additional funds are required to finance the civilian pay and benefit expenses for civilians hired on a temporary basis to mitigate force protection shortfalls. During FY 2004, the Air Force will hire temporary civilian employees to backfill active duty forces who are deployed and civilian employees who were called to active duty.

Funds are required to finance the incremental costs of temporary duty allowances, specialized clothing, and personnel equipment peculiar to the area of operations. Further, the supplemental request also includes special medical support for mobilized Guard and Reserve members and their dependents, who, as a result of their mobilization, are eligible to receive health care from the Department. In addition to the mobilization-related health care costs, funds are also required to

support other health care requirements, such as post deployment health care and replenishment of frozen blood stocks. The Operation and Maintenance (O&M) costs to support deployed Reservists and National Guardsmen are usually paid from the Services' Active O&M accounts, while all health care costs are paid from the Defense Health Program.

**II. MILITARY OPERATIONS SUPPORT**

This supplemental request includes \$31.1 billion to finance the incremental increase in costs due to military operations support for OIF, OEF, and ONE. This request includes the incremental military support for four U.S. Army National Guard Enhanced Separate Brigades that would be deployed if insufficient troop contributions are made from other countries for multinational divisions.

The \$31.1 billion request for military operations support includes the following requirements.

The Military Operations Support request is comprised of the following costs:

- \$16.9 billion for incremental flying hours and increased flightline spares, ship steaming days, ground operations, special airlift missions, increased associated ship and aircraft maintenance, additional logistics support, and fuel purchases.
- \$8.3 billion for transportation costs, including:
  - \$7.2 billion for transportation support for rotational deployment of personnel by air and major equipment items by sea.
  - \$0.9 billion for increased over ocean transportation costs related to overseas shipment of inventory from defense distribution depots. The inventory consists of spare parts, depot level repairables, food, clothing, and medical items. The volume of over ocean shipments increased by almost three hundred percent in FY 2003 because of the high reliance on air transport to move troops and critical equipment to the theater. working to reduce the proportion of air transport used and to lower the costs but, even with strict management controls, CENTCOM will continue to need air transport for the most critical items and equipment.

- \$1.1 billion Command, Control, Communications, Computers, and Intelligence (C4I) capabilities throughout the region.

**CHAPTER 2: DEPOT MAINTENANCE**

**Detailed Justification**

This FY 2004 supplemental request includes \$2.8 billion for incremental depot maintenance of weapons and weapon system platforms requiring service after the wear and tear of combat operations in Iraq, Afghanistan, and other areas elsewhere in support of OIF and OEF. The harsh desert environment and conditions of war cause significantly more damage and corrosion to equipment than the usual peacetime, training activities. In general, equipment used in OIF and OEF will require a more intensive overhaul and repair cycle than the typical maintenance program. The Department must restore these assets to mission-capable status in order to prevent any degradation in the readiness level. These military assets must be available for any future combat operation.

The roofs of two adjoining aerial port bays of the existing aerial port facility at Dover AFB collapsed from the weight of record snowfalls over the President's Day weekend in 2003. The roof structure over two additional bays was also damaged. These four bays comprise approximately 70 percent of the cargo processing capability of the facility. Dover AFB is the home of the largest and busiest aerial port on the East Coast; as such it supports OIF, OEF, and other operations throughout Europe, Africa and Southwest Asia. Efficient, orderly and safe processing of palletized cargo is necessary to prevent delays in the supply pipeline. Without a new facility, Air Mobility Command will be unable to meet the East Coast airlift throughput requirement. This project is critical to meet the warfighter's throughput requirements. The lower capacity workaround established with temporary structures introduces risk to both personnel and equipment. Additionally, fire and occupational safety and health regulations will continue to be waived to operate under current conditions.

Appropriating the funding in the Iraqi Freedom Fund (IFF), with its own transfer authority, provides the flexibility needed to allocate funding to those components that are actually incurring costs. It is an important financing mechanism needed to help the Department address the unpredictable scope, duration, and intensity of these military operations. These funds would be held in the IFF pending transfer to the components.

Within the total IFF request, funds would be available for supplies, services, transportation, and other logistical support to one multinational division of ground troops supporting military and stability operations in Iraq.

Funding is also provided for personnel, personnel support, and post-war operation support costs for two Army National Guard Enhanced Separate Brigades and one Marine Expeditionary Force (MEF) that are planned for deployment only if the multinational divisions are not ready to deploy or the changes in the security situations require the presence of these U.S. forces.

**CHAPTER 8: GENERAL PROVISIONS**

Sec. \_\_\_\_\_. Section 202(b) of the Afghanistan Freedom Support Act of 2002 (Public Law 107-327) is amended by striking "\$300,000,000" and inserting "\$600,000,000".

This provision would allow the Department of Defense to drawdown an additional \$300 million under the Afghanistan Freedom Support Act of 2002. This drawdown is necessary to support requirements for training and equipping the Afghan National Army (ANA) and accelerating the pace of that training so that the ANA can take an increasingly larger role in the fight against terrorism.

Sec. \_\_\_\_\_. Upon his determination, that such action is necessary in the national interest, the Secretary of Defense may transfer between appropriations up to \$5,000,000,000 of the funds made available to the Department of Defense in this Act: Provided, That the Secretary shall notify the Congress promptly of each transfer made pursuant to this authority: Provided further, That the transfer authority provided in this section is in addition to any other transfer authority available to the Department of Defense: Provided further, That the authority in this section is subject to the same terms and conditions as the authority provided in section 8005 of the Department of Defense Appropriations Act, 2004.

This provision would provide the Department with needed flexibility by allowing up to \$5 billion of the funds appropriated in this act to be transferred between accounts. The Secretary of Defense will notify the Congress not more than five days after such transfers, and this transfer authority will be in addition to any other transfer authority provided the Department. The reference to section 8005 of the Department of Defense Appropriations Act, 2004 assumes that the provision included as section 8005 in both the House-passed H.R. 2658 of the 108<sup>th</sup> Congress and the Senate Amendment thereto will be contained in the Act as ultimately enacted.

Sec. \_\_\_\_\_. a) Transfer Authority.--Subject to subsection (b), the Secretary of Defense may transfer not more than \$500,000,000 of the funds appropriated to the Department of Defense in this Title to the contingency construction account, authorized under section 2804 of title 10, United States Code, to carry out military construction projects not otherwise authorized by law. Funds so transferred shall be merged with and be available for the same purposes and the same time period as the appropriation to which transferred. The transfer authority under this section is in addition to any other transfer authority available to the Department of Defense.

(b) Conditions on Transfer.--A transfer of funds under subsection (a) may not be made until the end of the 7-day period beginning on the date the Secretary of Defense submits notice to the appropriate committees of Congress certifying that the transfer is necessary to respond to, or protect against, acts or threatened acts of terrorism or to support Department of Defense operations in Iraq, and specifying the amounts and purposes of the transfer, including a list of proposed projects and their estimated costs.

(c) Notice of Obligations.--Notwithstanding section 2804(b) of title 10, United States Code, when a decision is made to carry out a military construction project using funds transferred to the contingency construction account under subsection (a), the Secretary of Defense shall notify the appropriate committees of Congress no later than 15 days after the obligation of the funds for the

project, specifying the estimated cost of the project and including form 1391.

(d) Definitions.--For purposes of this section, the terms "appropriate committees of Congress", "military construction", and "military installation" have the meanings given such terms in section 2801 of title 10, United States Code, except that, with respect to military construction in a foreign country, the term "military installation" includes, not only buildings, structures, and other improvements to real property under the operational control of the Secretary of a military department or the Secretary of Defense, but also any building, structure, or other improvement to real property to be used by the Armed Forces, regardless of whether such use is anticipated to be temporary or of longer duration.

This section would allow the Secretary of Defense to transfer up to \$500 million from funds appropriated in this title to the contingency construction account to fund military construction projects not otherwise authorized. This provision requires the Secretary to notify the appropriate committees in Congress seven days prior to making the transfer. Moreover, the Secretary must notify the appropriate committees in Congress no later than 15 days after the obligation of funds for the project and provide the estimated cost of the project and form 1391 notification and explanation. This authority is necessary for the Secretary to carry out urgent projects in support of Operation Iraqi Freedom, Operation Enduring Freedom, and Operation Noble Eagle.

Sec. \_\_\_\_\_. Funds appropriated in this Act, or made available by the transfer of funds in or pursuant to this Act, for intelligence activities are deemed to be specifically authorized by the Congress for purposes of section 504 of the National Security Act of 1947 (50 U.S.C. 414).

This section would provide that funds appropriated in this Act, or made available by the transfer of funds in this Act, for intelligence activities are deemed to be specifically authorized by the Congress for purposes of section 504 of the National Security Act of 1947 (50 U.S.C. 414).

Sec. \_\_\_\_\_. During fiscal year 2004, the Secretary of Defense may transfer amounts in or credited to the Defense Cooperation Account under section 2608(b) of title 10, United States Code, to such appropriations or funds of the Department of Defense as he shall determine for use consistent with the purposes for which such funds were contributed and accepted: Provided, That such amounts shall be available for the same time period as the appropriation to which transferred: Provided further, That the Secretary shall report to the Congress all transfers made pursuant to this authority.

Pursuant to the statute establishing the Defense Cooperation Account (10 U.S.C. 2608) funds in the Defense Cooperation Account may be obligated or expended only to the extent and in the manner provided in subsequent appropriations Acts. This proposal would provide the necessary appropriation for the remainder of the fiscal year.

Sec. \_\_\_\_\_. Sections 1318 and 1319 of Public Law 108-11 shall remain in effect during fiscal year 2004.

This provision would augment existing authority regarding travel and transportation allowances for family members of members of the Armed Forces who are ill or injured as a result of

service on active duty in support of Operation Iraqi Freedom, Operation Enduring Freedom, or Operation Noble Eagle. In addition to the existing transportation benefit, this provision authorizes the payment of per diem to family members traveling to and from hospital visits and while at the site during visits. This provision also would authorize the Department to provide civilian attire suitable for wear by the member during their hospital stay and travel to home station as long as the cost to the government does not exceed \$250.

Sec. \_\_\_\_\_. From October 1, 2003 through December 31, 2003, (a) the rates of pay authorized by section 310(a) of title 37, United States Code, shall be increased to \$225; and (b) the rates of pay authorized by section 427(a)(1) of title 37, United States Code, shall be increased to \$250.

This provision would sustain the increase in the statutory maximum payable for Imminent Danger Pay from \$150 to \$225 per month, and for Family Separation Allowance from \$100 to \$250 per month from October 1, 2003 through December 31, 2003.

(a) Section 305(a) of title 37, United States Code, is amended by striking out "\$300" and inserting in lieu thereof "\$600".

This provision would increase the statutory maximum payable for Hardship Duty Pay (HDP) from \$300 to \$600 per month from January 1, 2004 until September 30, 2004.

This provision would allow the Department to provide training and equipment to those forces serving alongside or in place of U.S. military forces in Iraq and Afghanistan, including the New Iraqi Army, and to friendly nations fighting terrorism in the nearby region.
