**Chair Caroline C. Hunter called the Federal Election Commission to order in an open meeting at 10:20 A.M. on Thursday, May 24, 2012 with a quorum present.**

**II. DRAFT ADVISORY OPINION 2012-15**

**American Physical Therapy Association

**Chair Hunter recognized Mr. Joshua Blume of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to American Physical Therapy Association's (APTA) proposed plan to solicit its members who work at corporations wholly or partly owned by APTA members for contributions to APTA's separate segregated fund and to have the corporations collect and transmit those contributions to APTA's separate segregated fund through payroll deductions. APTA would pay the corporations for their services. Mr. Blume summarized the conclusions reached in both drafts.**

**Discussion followed.**

**MOVED to approve the response to the American Physical Therapy Association, Advisory Opinion 2012-15, as set forth in Draft B, Agenda Document No. 12-36-A, along with technical and conforming amendments.**

**III. DRAFT ADVISORY OPINION 2012-17**

**Red Blue T LLC, Armour Media, Inc., and m-Qube, Inc.

**Chair Hunter noted that Mr. Engle and Mr. Kappel, requestor's counsel, were available to answer Commissioners' questions.**

**Chair Hunter recognized Mr. Theodore Lutz of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to the requestors' proposal that m-Qube, Inc. would provide its services as an aggregator to process contributions made to political committees via text messaging. The requestors ask whether the proposal complies with the forwarding, recordkeeping and reporting provisions of the Act, and satisfies the segregation requirements for commercial vendors that process political contributions. Mr. Lutz summarized the conclusions reached in both drafts.**

**Chair Hunter noted that Mr. Torchinsky and Mr. Sheehy, requestor's counsel, were available to answer Commissioners' questions.**

**Chair Hunter recognized Ms. Jessica Selinkoff of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to Mr. Markwayne Mullin's request. He asks whether radio and television advertisements paid for by Mullin Plumbing, Inc. and Mullin Plumbing West Division, Inc. (the Mullin companies) would be electioneering communications when aired within the electioneering communication window. If so, Mr. Mullin also asks whether, when he files electioneering communication reports with the Commission, he must disclose the names of the Mullin companies' customers who paid \$1,000 or more for services rendered since January 1, 2011.**

**Mr. Torchinsky participated in the discussion which followed.**

**Chair Hunter noted that there would be a short recess to enable Mr. Torchinsky to consult with the requestor about a possible extension of the response deadline.**

**Chair Hunter noted that, yesterday, the Commission released many documents in response to the House Oversight Committee hearing held on November 3, 2011. She explained that the Commission issued a press release concerning these documents and included staff names and email addresses for the public to get more information or submit comments, and will hold a public hearing on September 12, 2012 to discuss enforcement issues. Chair Hunter said that the Enforcement documents, the Reports Analysis Division procedures, and the Audit Division materials are now available on the Commission's website.**

**Chair Hunter recognized Vice Chair Weintraub who noted that the public may not find these documents useful as they were primarily written for Commission staff and not with an eye toward making them accessible to the public, and the material includes many old documents. She emphasized current efforts to revise the Enforcement Manual, topics for the upcoming hearing, and anticipated helpful comments from the public on the Commission's enforcement process.**


