#### Safe jobs.

The U.S. Department of Labor takes the lead in promoting safe and healthy working conditions with policies and regulations designed to protect America's workers.

Heard of OSHA? That's us. It's the Occupational Safety and Health Administration. Along with the Mine Safety and Health Administration (MSHA), we are dedicated to preventing injuries and eliminating accidents in the workplace, protecting the health of America's workers, and saving lives. We also enforce whistleblower protections for employees and administer disability compensation programs to federal workers. It's not a good job if it's not a safe job.

#### Secure jobs.

Retirement is the largest single expense most people will have in their lifetime. Workers rely on pensions, a 401(K) account, retirement savings, and other means to prepare for a secure and happy future. And for most, their employer-provided health care is indispensable. Our Employee Benefits Security Administration (EBSA) is on the job, protecting more than 695,000 private retirement plans, 2.8 million health plans, and similar numbers of other worker benefit programs. The Department also administers COBRA and health care portability programs that help workers maintain their health care plans when jobs are lost. And when workers are laid off from their jobs, we are front and center, overseeing the nation's unemployment insurance program, ensuring that families can meet basic financial obligations, and providing important resources to obtain new skills and employment.
