Re: HAB Fiscal Year (FY) 2010 Budget

Dear Mr. Brockman and Ms. Olinger,

Over the past six years, the budget to support the work of the Hanford Advisory Board (Board) has been reduced to a point where the Board has been forced to suspend operations for portions of each year due to a lack of funds. The effect of the last five years of level funding represents an effective reduction of the Board's budget due to the compounding effects of inflationary pressures and dramatically increased travel costs. The Board's budget has been:

•	FY 2006 Budget:	\$ 471,000

•	FY 2008 Budget:	\$ 471,000

The Board has effectively managed and repeatedly curtailed its activities to the maximum extent practicable, including: reducing the number of committee and Board meetings, selecting meeting locations which minimize travel costs, completely eliminating Board facilitation and support for long periods of time, and for eliminating facilitation support for Site Specific Advisory Board activities. The Board is now approaching the point where budget shortfalls will prevent the Board from continuing to provide effective public input and advice on Hanford cleanup issues.

The Board anticipates work scope above our regular work load this year, including:

- Helping the Department of Energy (DOE) develop a robust public and tribal involvement process for release of the Draft Tank Closure and Waste Management Environmental Impact Statement in 2009
- Providing Board advice on the Draft Tank Closure and Waste Management Environmental Impact Statement in 2009
- Planning and participating in DOE Richland Operations Office and Office of River Protection project baseline workshops
- Facilitating public and tribal input and providing advice on the Tri-Party Agreement (TPA) negotiations
- Planning and participating in 100 and 300 Corridor Risk Assessment workshops
- Additional public involvement products and activities requested by the TPA agencies

Board funding levels are simply not adequate to sustain the high quality research, development and facilitation expertise required to support board activities. From FY 2002 to FY 2009, the Board's budget has been cut by 23%. We are below what we consider to be a funding level that will allow the Board to continue to function effectively.

To provide DOE and the regulating agencies with well-researched, insightful policy level advice and recommendations a strong facilitation team with deep technical knowledge and institutional memory is required. The Board has been subject to reduced facilitation expertise due to lack of appropriate funding. The level of facilitation which the Board requires must be at a high quality to ensure the agencies get the best products the Board can provide.

The Board also needs adequate budget to support necessary travel, regularly scheduled and ad hoc committee meetings and Board meetings that will enable us to accomplish our work load and meet the needs of the TPA agencies.

Given the Board's projected work load, increases in travel costs, facilitation needs, and our desire to avoid future periods of suspending all activities, as well as the Board's commitment to continue closely managing expenditures, a FY 2010 budget of \$560,000 is needed. The Board seeks to regain our ability to continue providing quality, values-based advice on Hanford cleanup that benefits DOE, the regulating agencies and the public.
