## **HMDA Reporter Panel Format**

The HMDA Reporter Panel is a fixed format flat file (HMDAReporterPanel.dat) of all lending institutions for an activity year. The HMDA Reporter Panel data and the file format document are available on the FFIEC HMDA website, <a href="http://www.ffiec.gov/hmda/hmdaproducts.htm#LAR\_TS">http://www.ffiec.gov/hmda/hmdaproducts.htm#LAR\_TS</a>.

## Effective with the reporting of 2010 data, the following changes have been implemented to the HMDA Reporter Panel:

- Added eight new fields (#s 17-24) Field #s 17-21 deal with Top Holder information; field #s 22 and 23 are the Respondent RSSD ID and the Parent RSSD ID, respectively; field #24 is the Respondent FIPS State Number, which corresponds to the Respondent State abbreviation;
- Derived all fields listed on the HMDA Reporter Panel from the HMDA Reporter Panel information;
- Changed three fields (#12, #15 and #16) to "Filler" because the Respondent Address, Respondent Zip Code and Tax ID are reported on the HMDA TS records only. If that information is desired, please refer to the HMDA TS records (see the Institution Record file format); and
- Changed the data source for the Respondent Name, City and State to information included on the HMDA Reporter Panel.

The difference between the Respondent RSSD ID and the Respondent ID (RID) is that they are unique identifiers, on two separate databases, for a specific institution. The RID number identifies an institution on the HMDA Reporter Panel. The Respondent RSSD ID identifies an institution on the National Information Center (NIC), a repository of financial and institution data (http://www.ffiec.gov/nicpubweb/nicweb/SearchForm.aspx). For all HMDA depository institutions a RID and Respondent RSSD ID number have been assigned. For HMDA, non-depository institutions, a RID number has been assigned; however, a Respondent RSSD ID may not have been assigned.
