**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION RESETTING THE TARGET DATE**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 11) resetting the target date in the above captioned investigation to December 30, 2011.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on May 21, 2010, based on a complaint filed by Georgia-Pacific Consumer Products LP of Atlanta, Georgia ("Georgia-Pacific"), alleging violations of Section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain electronic paper towel dispensing devices and components thereof by reason of infringement of certain claims of United States Patent Nos. 6,871,815; 7,017,856; 7,182,289; and 7,387,274. 75 *Fed. Reg.* 28651-2 (May 21, 2010). The complainant named as respondents Kruger Products LP of Mississauga, Canada, KTG USA LP of Memphis, Tennessee, Draco Hygienic Products Inc. of Ontario, California, and Vida International Inc. of Taipei, Taiwan (collectively the "Draco Parties"); Stefco Industries, Inc. of Haines City, Florida; Cellynne Corporation of Haines City, Florida; NetPak Electronic Plastic

and Cosmetic, Inc., d/b/a/ Open for Business of Chicago, Illinois (“NetPak Chicago”); NetPak Elektronik Plastik ve Kozmetik Sanayi, Ve Ticaret Ltd of Izmir, Turkey; Paradigm Marketing Consortium, Inc. of Syosset, New York; United Sourcing Network Corp. of Syosset, New York; and New Choice (H.K.) Ltd. of Shatin, Hong Kong.

On August 16, 2010, the Commission determined not to review an ID (Order No. 8) granting Georgia-Pacific’s motion to amend the Complaint and Notice of Investigation to add as new Respondents Jet Power International Limited, Winco Industries Co., DWL Industries Co., Ko-Am Corporation d/b/a/ Janitors’ World, Natury, S.A. De C. V., Update International Inc., and Alliance in Manufacturing LLC. (collectively “Additional Respondents”). On August 20, 2010, the Commission determined not to review an ID (Order No. 9) terminating respondent NetPak Chicago from the investigation pursuant to a consent order.

On August 10, 2010, Georgia-Pacific and the Draco Parties filed two joint motions disclosing that the movants are near settlement and that default proceedings will be initiated against the remaining original respondents. The motions also requested changes to the procedural schedule to accommodate the addition of the Additional Respondents to the Investigation and to prevent the Draco Parties from taking unnecessary action before they are terminated from the Investigation. On August 11, 2010, the ALJ suspended all deadlines pending the outcome of the joint motion to adjust the procedural schedule. No responses to the motions were filed.

On August 17, 2010, the ALJ issued the subject ID, resetting the target date for December 30, 2011, and directing Georgia-Pacific and the Draco Parties to jointly file, by September 19, 2010, a revised proposed procedural schedule. No petitions for review of this ID were filed.

The Commission has determined not to review the ID.

The authority for the Commission’s determination is contained in Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission’s Rules of Practice and Procedure (19 C.F.R. § 210.42).
