**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION SETTING THE TARGET DATE FOR COMPLETION OF THE
INVESTIGATION AT 18 MONTHS**

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 4) setting the 18-month target date as September 10, 2012.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on March 9, 2011, based on a complaint filed by LG Electronics, Inc. of Seoul, Korea. 76 *Fed. Reg.* 12994-5 (Mar. 9, 2011). The complaint alleges violations of Section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital televisions and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 6,785,906; RE 37,326 ; 5,533,071; and 5,923,711, and of certain electronic devices having a blu-ray disc player and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 7,701,835; 7,577,080; 7,619,961; and 7,756,398. The complaint further alleges the

existence of a domestic industry. The Commission's notice of investigation named as respondents Sony Corporation of Tokyo, Japan; Sony Corporation of America of New York, New York; Sony Electronics, Inc. of San Diego, California; Sony Computer Entertainment, Inc. of Tokyo, Japan; and Sony Computer Entertainment America LLC of Foster City, California.

On March 30, 2011, the ALJ issued the subject ID, setting the 18-month target date as September 10, 2012, pursuant to 19 C.F.R. § 210.51(a). No petitions for review of this ID were filed.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
