Specific U.S. Patent and Trademark Office Statutory and Regulatory Limitations

The following limitations apply specifically to all officers or employees of the U.S. Patent and Trademark Office. In case of doubt on any question of statutory or regulatory application, the officer or employee should consult the text of the statute or regulation and should rely on legal counsel. The General Counsel or his designee is available as counselor for officers and employees in such cases.

- Title 35 U.S.C., section 4, prohibits officers and employees of the U.S. Patent and Trademark Office, during the period of their appointments and for one year thereafter, from applying for a patent and from acquiring, directly or indirectly, except by inheritance or bequest, any patent or any right or interest in any patent, issued or to be issued by the U.S. Patent and Trademark Office. In patents applied for thereafter they hall not be entitled to any priority date earlier than one year after the termination of their appointment.
- Title 35 U.S.C., section 122 provides that except as provided in subsection (b) of section 122, applications for
 patents shall be kept in confidence by the Patent and Trademark Office and no information concerning the same
 given without authority of the applicant or owner unless necessary to carry out the provisions of an Act of Congress
 or in such special circumstances as may be determined by the Director.
- 3. Rules of Practice in Patent Cases, 37 CFR 11.10(b) provide that no individual who has served in the patent examining corps or elsewhere in the Office may practice before the Office after termination of his or her service, unless he or she signs a written undertaking agreeing (1) to not knowingly act as agent or attorney for, or otherwise represent, or assist in any manner the representation of, any other person before the Office in connection with any particular patent or patent application in which said employee participated personally and substantially as an employee of the Office; and (2) to not knowingly act within two years after terminating employment by the Office as agent or attorney for, or otherwise represent, or assist in any manner the representation of any other person before the Office in connection with any particular patent or patent application if such patent or patent application was pending under the employee's official responsibility as an officer or employee within a period of one year prior to the termination of such responsibility.

Privacy Act Statement

- To provide information to a Congressional Office from the record of an individual in response to an inquiry from the Congressional Office made at the request of the individual.
- 4. To disclose information to another Federal agency, to a court, or a party in litigation before a court or in an administrative proceeding being conducted by a Federal agency, when the Government is a party to the judicial or administrative proceeding.
- 5. To disclose information to the Department of Justice, or in a proceeding before a court, adjudicative body, or other administrative body before which the agency is authorized to appear, when the agency or any part of the agency, any employee of the agency in his or her official capacity, any employee of the agency in his or her official capacity where the Department of Justice or the agency has agreed to represent the employee, or the United States, when the agency determines that litigation is likely to affect the agency or any of its components, is a party to litigation or has an interest in such litigation provided, however, that in such case, it has been determined that the disclosure is compatible with the purpose for which the records were collected.

- 10. To disclose information to contractors, grantees, or volunteers performing or working on a contract, service, grant, cooperative agreement, or job for the Federal Government.
